

Minutes of Monthly Meeting of the Wicklow Urban District Council held on Tuesday the 7th May, 1935, pursuant to the following Notice sent to each Member of the Council on the 2nd May, 1935.

Item 1. Minutes confirmed.

Item 2. The following Reports of the Finance and General Purposes Committee were read and unanimously adopted.

At a Meeting on the 13th April, 1935, Councillors Everett, Olohan and Turner being present, payments amounting to £11. 11. 1 on the Housing Account were authorised, and also the usual Weekly Wages Book inspected.

At Meeting on the 20/4/35, Councillors O'Grady, Olohan and Lalor being present, payments amounting to £4. 17. 1 were authorised on the Housing Account and Weekly Wages Book examined.

At a Meeting on 27/4/35 Councillors Olohan, R. B. Haskins and M. Turner being present, payments amounting to £2. 16. 10 were authorised on the Housing Account and Weekly Wages Book examined.

At Meeting on 4/5/35 Councillors J. Everett, J. Olohan and M. Turner being present, payments amounting to £5. 1. 1 were authorised on the Housing Account and Weekly Wages Book examined.

Item 3. The only person tendering was the former Contractor Mr John Lalor, giving one tender of 1s/2d per gallon for the entire period to 31/3/36 for milk not Tuberculin-tested and another for 1s/4d per gallon for Tuberculin-tested Milk for same period. The Council unanimously accepted Mr Lalor's Tender at 1s/2d subject to sanction. The Department's letter (P.H.56447/35) of 12/4/35 directing advertisement for tenders was read.

Item 4. As no offers had been received it was decided to re-advertise in the Irish Builder and Engineer.

Item 5. It was Proposed by Councillor D. H. Haskins, and Seconded by Councillor E. Lalor and passed unanimously, that the Chairman sign the Agreements for letting of Council's fields for 11 months for and on behalf of the Council.

Letter G.66789/35, dated 2/5/35 from Department of Local Government and Public Health sanctioning the payment of £3 per annum to T. Campbell the Caretaker of the Halpin Memorial.

Letter H.65608/35 dated 25/4/35 from Department of Local Government and Public Health acknowledging receipt of Clerk's letter of 17th idem. re Allotment Scheme, pointing out that the Minister will be prepared to make at a later date an appropriate recoupment in respect of Council's loss on Rent, Rates and Fencing, and also will be prepared to consider remuneration to officials on the completion of the Scheme for the present season.

Letter H.61926/35 dated 26/4/35 from Department of Local Government and Public Health in connection with the Wicklow Urban No. 1 (Purchase) Order, 1934, stating:-

1. That it is not mandatory on the Council to acquire Sites Nos. 22 and 23, but the Minister was of opinion that the acquisition of the plots was desirable.
2. That the Minister has approved of the Council's acceptance of the offers made by the owners of the condemned houses for sale.
3. That the Council should consider the planning of 3 pairs of Cottages (C.L.23 type) on the cleared area.

(3) provide lighting for the road way and (4) free and full liberty for the Company to use the road for all traffic including bus and Lorry traffic.

On a division there voted for the Amendment Councillors Olohan, Waldron and Clarke (3) and against (9), whereupon the original Resolution was put and carried by the same majority.

Item 7. Further consideration of this matter was adjourned until 21/5/35.

Item 8. The Notice of Motion standing in the name of Councillor James Clarke was not moved, but after discussion it was Proposed by Councillor R. B. Haskins, Seconded by Councillor Thomas J. Doran and passed unanimously

"That the Town Surveyor and Medical Officer of Health be asked to review their recommendations; and that their final list as prepared by them be sent to the Councillors of the different Wards, the matter to be then discussed at the next Meeting of the Council."

It was Proposed by Councillor E. Lalor, Seconded by Councillor J. Waldron, and passed,

"That a deputation consisting of the Chairman, Town Clerk, Councillors Haskins, O'Grady and Lalor be appointed to interview the Minister with a view to ascertaining if the 60% Grant is available for relieving overcrowding."

A Letter dated 3/5/35 was read from the Purchasers from the Council of houses at Strand Street, protesting against the proposal to clear their houses.

Item 9. The Monthly Reports of the Veterinary Inspector on his Meat and Milk inspection were read and it was ordered that they be incorporated with Minutes.

The Monthly Reports of the Sanitary Sub-Officer and Waterworks Overseer were read.

The Town Clerk submitted list of rates due on condemned houses
and pointed out that they were payable as outgoings on sale.

Proposed by Councillor E. Lalor,
Seconded by Councillor C. W. Hudson and passed unanimously,

That in view of the circumstances and without prejudice
to Agreements for Sale, the Department be asked to sanction
the remission of all rates for 1934-35 on Tenants of Upper
Monkton Row as additional part of remuneration for their
houses,

It was decided that prior to demolition the owners as distinct
from tenants should have first claim on anything in old houses.

Re:- Title.

The Town Clerk pointed out that with one exception ~~none~~ none
of the owners had produced title deeds to the houses and that the
original lessee in the O'Hanlon Estate claimed there was due to
them sums as apportioned part of Head Rents and in these circum-
stances he was not yet able to proceed with payment of Purchase
Money.

It was decided to leave over until June Meeting the question
of payment of purchase money, the Town Clerk to see what could
be done about perfecting titles in the meantime.

It was reported by the Town Clerk that he had not yet heard from the Department of Local Government and Public Health re remission of rates on old houses, and that the parties with the exception of two owners, title was not yet shown and he was not yet in a position to pay the owners. It was decided to leave the matter over until a Meeting to be called at the earliest possible date when the matter would be ready for payment.

Item 4. It was unanimously decided to adjourn this item to the next (adjourned) Meeting.
