The Town Clerk produced copies of the Notices served on Messrs Haskins & Son under Sec. 23 of the Housing (Miscellaneous Provisions ) Act 1931. Messrs D. H. Haskins and R. B. Haskins were in attendance and were further represented by J. H. McCarroll Esq. Solicitor. The latter questioned the Town Surveyor and County Medical Officer of Health on their reports which were produced and copies of which had been furnished to Messrs Haskins &Son Both the Town Surveyor and Dr Beckett adhered to their views as expressed in their reports that the 8 houses could not, at a reasonable cost, be rendered fit for human habiation. Mr McCarroll stated that his clients were anxbous to retain the houses and were prepared to comply with all reasonable requirements of the Council to put them into a fit condition. Messrs D. H. Haskins and R. B. Haskins and Mr McCarroll then withdrew from the meeting and after discussion it was ordered that :-
