


WICKLOW URBAN DISTRICT COUNCIL. MINUTE BOOK







Minutes of Special Meeting of the Wicklow Urban District Council held on Wednesday the 1st of October 1941 pursuant to Requisition signed on the 27th of September 1941 and to Notice given to each member on the 27th of October 1941.as follows :-

PROPOSED by Councillor M. McMahon , SECONDED by Councillor J. Olohan and passed unanimously that the recommendation of the Finance & General Purposes Committee at their meeting on the 27/9/41 and following immediately hereafter be adopted and put into operation :-

That the following Public Lamps remain discontinued until further notice viz 3 on the Station (Dublin) Road, 1 at the head of Mentworth Place, 1 at Gelebern-&-Hepkins-(altered by Council to at Alcorn's), 1 in Main Street between TREMIRXXX corner of Garret Byrne's and Technical School (outside Kingston's), 1 between Technical School and Town Hall, 1 round the corner of Castle Gate, Castle Street , 1 at Convent Road corner of St Laurence's Road, 1 at At Patrick's Road, 1 at Coates' Lane 1 at Dispensary Lane, 1 at Friars' Hill, 1 at Corner of Fair Green (Bayview), 1 in centre of Kilamntin Road, 2 at Church Hill (1 above the Church and 1 at end of Brickfield Lane) and 1 at Clarke's corner of Leitrim Place (TOTAL 18) andxt AND that 2 new Lights be provided for the 10 new houses at or in the Castle Field AND THAT the remaining lights be put into operation from ONE HOUR after sunset to ELEVENX addaxx o'Clock each noght from the 1st of October and until further order. Net reduction of Lights to be 16 until further Order.

Harbour Commissioners to the Wicklow Urban District Council to take over the management of the Wicklow Harbour and requesting, as directed . that a deputation consisting of the Chairman of each body and himself be received to get guidance in connection with the matter .

Letter from the Department of Industry & Commerce dated the 10th Sept. 1941 in reply pointing out that it was open to the Council to move for the transfer to them either by a Private Bill or a Provisional Order enclosing the regulations governing the matter including an initial outlay of £35 and stating that no useful purpose could be served by a depuatation.

Letter of the 10th September 1941 from the County Secretary enclosing copy of a Resolution passed by the County Council on the 8th October 1941 wherein they referred the entire matter to their Law Agent for a report and asking that no further steps be taken pending his Council's decision on that report.

The Harbour Commissioners who had adjourned their own meeting to attend for this item again inquired if the Council were at liberty and ready to take over the Harbour business. The Town Elerk & Law Agent to the Council advised that in view of the letter from the Department of Industry & Commerce the Council could not take control of the Harbour without the Private Ball or the Provisional Order. He gave approximate figures of £30,000 that the Capitale Expendeture) Harbour had cost the ratepayers of Wicklow Town in Town Rate only apart from interest committments on that sum and also apart from what they had paid in Poor Rate as part of a contributing Barony.

Minutes of Meetings referred to were confirmed.

Item.2

After prolonged discussion it was agreed that this matter should be adjourned to a meeting to be held on Friday the 10thinst at 8.30 p.m. and that the Fuel merchants be asked to attend and discuss the question of the Stocks of Fuel in the Town.

Item. 3.

It was agreed to have the potatoes at Kilnamagh gathered, if possible, on Saturday next and that voluntary labour be enlisted for the work. It was agreed to advertise for suitable centre and services for cooking and distributing the meals. It was ordered that the Margantaxin Fuel Mercha: -nts in Wicklow and Arklow be asked to supply coal and quote for mt it.

It was also agreed to let the Parish Committee know of the arrangements being made at Kilnamanagh for the picking of the potatoes and to doxnant ask them to co-oerate in the matter. The Meals to begin on or before the 1st of November next.

Item 4.

The question of dealing further with Derelict Sites was left over pending a general report from the Town Surveyor in the matter.

It was agreed to offer the owners of the condemned sites in Csatke Street the sum of £8 per house subject to sanction of the Department of Local Government & P. Health and in the case of Mr Conway's house it was ordered that the Town Clerk reply to the letter from Mr Hopkins Solicitor dated the 23rd Sept. 1941 to the effect that the Council propose to acquire by agreement. the house/if the price is reasonable.

Permission was granted to Mr Hamilton to have water put into his four-appartment house in Castle St as requested in his letter of the 22nd of August last -- the work to be carried out to the satisfaction of the Engineer but that approval to connect the other houses with the main be deferred pending the Engineer's report as to whether the necessary improvements be done to the houses or not.

Read letter from the Secretary of the Harbout Commissioners dated the 2nd of October 1941 intimating that 7 of the Council's representaives had resigned from membership their resignation to take effect from the 7/10/41 The Town Clerk reminded the Council that it was their duty to have the vacancies re-filled.

The Town Clerk announced that as directed he had sent invitations to the Fuel Merchants (Messrs The Corn Co., Miss Darcy, H. Hamilton and The Manager Wicklow District Gas Co.)

At the meeting the Wicklow Corn Co. was represented by Mr Tracey and Mr Hamilton also attended. There was no attendance from either of the other firms and no apology or explanation from them.

After hearing what the Corn Co.'s representative had to say and also Mr Hamilton , the Councillors were satisfied that no reliance could be pla -ced on the Fuel Merchants to deal with the question of Fuel for the Winter and the following orders were made :-

(1) 500 Tons of Turf to be ordered from Castlebat if price at Wicklow dees not exceed £2:4:10

(2) Town Clerk to order 100 Tons of Buel Timber from Forestry Department Rathdrum and attend public Auction at Ballygannon

(3) Accept any offers of blocks at 35/- per ton or under.

Mrs Painting and Mrs Everett attended and on the XXtter former represent--ing that she desired on behalf of the ladies Committee in charge of the School Meals to convey their views as to the suitability of distribution centres for the Meals , she was permitted to address the Meeting . She had handed in earlier that day a letter addressed to the Fresiding Chair--man dated the 29th October 1941 asking for permission to attend the Council's Meeting when the matter for tender for premises was being considered. It was decided to hear Mrs Fainting before any of the other business was considered so that she would not be delayed. Mrs Painting stated that the Ladies Committee found that the premises heretofore in use (Mrs Doyle's , The Mall) was comfortable both for the children and for themselves and that the meals were always served war hot and in good condition by Mrs Doyle. She asked for permission to remain until the item was being discussed by the Council but was informed that the Council did not deem it necessary for her to wait and assured her that the views expressed by her would receive due consideration when the matter was being decided. She then withdrew from the meeting room accompanied by Mrs Everett but Mrs Painting revisited the adjoining room from time to time subsequently.

The Town Clerk suggested that it view of the matter being opened it would be better to proceed and deal with item No.2 and this was agreed to.

Item 2.

The advertisement for Tenders for centre and supplies as appearing in the Wicklow People of the 11thOctober 1941 and on Posters was read and also the correspondence with Dr Beckett C. M. O. H. leading up to the inspection by him on the 29th Oct. 1941 of the places offered as centres. Two such places were offered and inspected and the following is the report of the County Medical Officer on same :-

29th October 1941

A Chara, I append reports of premises offered for the provision of School Meals in Wicklow

(1) Mrs Dyyle, The Mall, Wicklow. The premises offered consist of one room 21 feet by 15 feet with a concrete floor partly covered with oil cloth . There is a double glass door in front which provides light. It is situated in the garden behind a shop on the Mall, through which entrance is obtained. The cooking is done in a range in the room.

(2) Mrs Ryan, The Mall, Wicklow. The premises offered consist of a galvanised iron structure mesuaring 37 feet by 18 feet with a board floor and three good sized windows in the back wall. There is a stove in the room but the flue for it has not yet been installed . There are four long tables and benches .Cooking is to be done in the kitchen of Mrs Ryan's Hotel and the food carried from there to the room a distance of about 20 yards . The children will obtain admittance from the back , from High Street.

Of the two, I think Mrs Ryan's premises preferable. The stove, however, shou;d be put in working order. G. P. G. Beckett

The tenders were then opened and read as follows :-

Mrs Doyle :- 25/- per week to cover cooking, attendance, use of the premises and certain articles , the Council to provide fuel

Mrs Ryan :- 25/- for cooking and serving use if large Hall fitted with seats and tables and heating stove to burn coke& timber xaf OR £1 :18 :- she to do the fuelling by Electric Boiler

The Town Clerk then explained the difficulty he had experienced in getting a Permit for Fuel and the diificulty in getting Fuel even with the Permit now obtained. As instructed he had invited the Merchants in Arklow and Wicklow to quote for the supply of Coal and one Tender was received which was now opened and was from Kearon & Tyrell of Arklow as follows :- Crown Patent Fuel at Arklow :- @ 90/- per ton

Ovoids if available :- @ 94/- " It was stated that they could be brought from Arklow @ 15/- per ton. The figures were then examined and it was found that Mrs Doyle's Tender,

Council supplying Fuel @ 25/- andereded Mrs Ryan's she supplying Fuel @ £1:18:- by only 1d and having regard to the representations of the Ladies ' Committee it was unanimously agreed to accept Mrs Doyle's Tender and premises.

The Official Contractors for Cocoa stated that they could hot supply.

The Town Clerk reported that he had invited the Speriors of the two Nat. Schools to submit lists of ^Children and had summoned <u>axiadiaax@aSchool</u> Meals Committee to examine them and the following attended that evening :-Mrs Painting, ^Mrs Everett, Miss Fitzsimmons, Mrs Turner, Miss Leonard, Mrs McCall, Miss Shaw and Messrs Olohan and O'Connor and Brother Gregory. The number of children listed from the Convent ^National School was <u>invit@x</u> 103 and from the Brothers ^National ^School was 79 (182 in all)The Committee had recommended the admission of all the children listed

ORder :- All the children listed to be admitted and the Meals to begin on Monday the 3rd of November 1941 at Mrs Doyle's at the hour of 12 noon (New Time).

The Town Clerk then explained the steps he had taken to get the potatoe crop at Kilnamanagh gathered and mentioned that he had received co-peration from a number of people, including Mr Eugene Byrne, Mr John Murphy Kilpool from Lorry Owners such as Messrs Hopkins, Wicklow Corn Co., Messrs Haskins John Kane and Messrs Fitppatrick and from ladies such as Mrs Cullen and Mrs Painting who had supplied tea one afternoon to the workers : that in the end he had agreed to pay 4 of the workers for one day selecting those who had given voluntary help. In particular Mr Browne Steward at Kilnamagh had giveb particular help and attention to the potatoe crop.

Proposed by Councillor J. Olohan, Seconded by Councillor Mames Manahananadapase Clarke and passed unanimously :) That the Council's thanks be conveyed to all workers and helpers and that Mr Browne be paid £5 for his work on the Scheme.
