

# ESTIMATES FOR FINANCIAL YEAR ENDING ON THE 31ST MARCH, 1954

Mr. Chairman and Gentlemen,

In the attached tables details are given of the Estimates of Expenditure and Receipts for the year ending on the 31st March, 1954. The Estimates will be considered at the statutory Estimates Meeting which this year will be held on Monday, 30th March, 1953.

The total expenditure is estimated at £30841 and total receipts at £13510. The net amount to be levied from rates, therefore, is £17331.

The expenditure under the four main accounting headings is given hereunder, with the corresponding figures adopted for 1952/53 shown in paranthesis:-

Credits of £479 are available and after the application of these the net amount required is reduced to £16852.

A rate of 1d. in the £ would produce £40. 18. 8. in the coming year (as compared with £40. 1. 2. in the present year), and the net requirements of £16852 would require a rate of 34/4d. in the £, an increase of 2/9d. over the rate for the present year which is 31/7d.

The increase in the estimated expenditure in the coming year is explained in detail later. Briefly, however, the additional outlay is due mainly to the following causes:- County Council Demand, which shows an increase of £1080; wages increases account for over £160 and in addition provision has been made for additional lighting. (£78); street decoration for An Tostal £120; Housing repairs £100 and contribution to the Water Safety Committee of the Irish Red Cross (£40).

When the Estimates were being considered last year the Council had before them an application for wages increase, but it was deferred pending an indication as to whether there would be a general revision of wages rates throughout the country. Lately as a result of decisions of the Labour Court and negotiations between the Union and employers such increases were granted, and consequently the Council in November last had to agree to a revision of wages which became effective from October, 1952. In the attached Estimates due provision has been made for the increased cost pesulting from this revision.

<u>ROADS:</u> The same provision as last year has again been made for the Council's contribution to Employment Schemes, viz. £75. In the

present year a grant of £300 was obtained and this was used in imimproving the road near the Black Castle, widening of corner at junction of St. Patrick's Road and St. Laurence's Road and improving paths at Castle Street.

The amount included for ordinary Road Maintenance is £579. The increase of £92 over the estimate for the present year is attributable to wages revision.

For Special Works £280 has been included and this corresponds to the amount allowed by the Council in the present year. The Town Surveyor has submitted an estimate for new Road Works which would cost £1,983. It was felt that this would be an undue amount to provide in any one year. It would require a very substantial rate increase and accordingly it was decided to include the same amount for Special Works (£280) as was allowed last year. The following are the works which the Surveyor recommends should be carried out:-

The Council having considered the foregoing list of works may determine the items in the estimate which should be given priority, and which might be carried out at a cost of £280. Some of these works moreover, might be undertaken with the aid of the Employment Schemes Grant.

Provision has been made for loan charges of £212 on the Capital Costs of Improvements at St. Patrick's Road. Last year the amount provided was £187, but it was contemplated that the loan charges for an entire year did not have to be met. The arrangements' for the loan have now been completed and the work has started.

During the year the Council gave very full consideration to a proposal for laying a new concrete Road-way through the Murrough as far as the entrance to the Dublin & Wicklow Chemical Works. The cost of this road is estimated at £2450 and the Chemical Company agreed to give a contribution of £700 towards the cost. A loan charge of £204 is included in the attached estimates. This would be the annual charge on a loan of £1750, repayable over 15 years. Arrangements for the borrowing have recently been concluded.

The County Council, however, is prepared to give a contribution of £600 towards the cost of this work, but unfortunerly legal difficulties have been met in connection with the matter. Consequently in preparing the Estimates it was fleft credit could not be taken for this contribution which would have reduced the capital cost and the loan charges.

#### SANITARY SERVICES

Water Supply: During the present year it was necessary again to resort to special pumping arrangements in order to maintain an adequate water supply. The impounding of a stream at Marlton and pumping water back to the Reservoir for filtration has enabled the the Councilto overcome the difficulties of water shortage. In 1952 much dry weather was experienced and since the beginning of the present year the rain-fall has been negligible. In consequence the Town Surveyor had to arrange to start pumping as from the middle of last month. He anticipates that in the coming year the Pumping will cost up to £240 and provision has been made for this in the attached Estimates. This pumping arrangement will have to be continued until the water supply is augumented by recourse to a Regional Scheme. Further progress with the details for the Regional Scheme was not made in the present financial year as the Electricty Supply Board decided to investigate the possibilities of using Lough Dan for Hydro-Electric Development. It is now understood, however, that the Board will shortly be in a position to determine if they will proceed with the proposed Hydro Electric Development. The latter proposal would materially affect the design of the Regional Water Supply Scheme.

Domestic and vStreet: Scavenging: There is an increase of £34 due to wages revision. No provision has been made for a Domestic Scavenging Service in these Estimates The matter was very fully considered by the Council last year and/it was found that the provision of a Domestic Scavenging Service would cost 1/6d. to 2/- in £. the matter was indefinitely deferred.

Burial Grounds: The Demandfrom Wicklow & Rathdrum Joint Burial Board for the maintenance of the Cemetery at Merrymeeting shows an increase of £25 on that for 1952/53.

Public Lighting: Last year the estimate for public lighting was increased by £50 and as a result new lights were provided at St. Patrick's Road, Marlton Road, Rocky Road, Wentworth Place, Cooper's Lane and Dunbur Road. The same amount (£460) is again included. Recently a application was received for new light at New Park Road but it was found that the charge for installation and lighting would be £78. The matter was deferred pending consideration of the Estimates. This sum of £78 has now been included.

Water Safety: The Irish Red Cross Society some time ago asked that the Council might agree to give a contribution towards the training in Water Safety. The Society already has provided instructors at the Sea-side Resorts in Wicklow County. The Council agreed to consider the matter further in conjunction with the Estimates. A sum of £40 has been included as a contribution to the Society.

### HOUSING:

For repairs to Council houses the Surveyor has submitted an Estimate of £750. The amount allowed by the Council for the present year was £650.

The Council's Housing Scheme at Ballynerrin was completed in April last. The number of houses now owned by the Council is 266. The loan Charges for housing show no appreciable change from the provision made for the present year.

The Council in the past few years has made 13 loans to persons building their own houses. The loan charges are fully met by the repayments from borrowers and the scheme involves no charge on the rates.

#### GENERAL URBAN PURPOSES:

Town Hall Expenses: This item shows a reduction of £40 as special provision was made for repairs in the present year. The repair work will be completed by the end of the present financial year.

<u>Tourist Development:</u> Last year it was agreed to allow £47 as a contribution to the local Tourist Development Association. It was decided that there would be a better chance of securing special publicity for Wicklow and the adjoining district if the arrangements were left to the local Organisation.

Corporate Estate Maintenance: There is an increase of £21 due to wages increase.

Foreshore Maintenance: £174 is included to meet the cost of urgent repairs; the sum allowed in the present year was £164. A Scheme for major protection work at the foreshore has already been submitted to the Local Government Department and it is hoped that a Special Grant will be obtained in the coming year.

<u>Tree Planting:</u> For this purpose £38 has again been included. During the current year trees have been planted at the entrances to the town, along the Rathnew Road and Marlton Road. Trees were also planted at the Murrough. In additional fruit trees were supplied to Council tenants. The contribution made by the Council towards this tree planting Scheme only meets part of the cost of work undertaken by the local Organisation. The balance is raised by voluntary subscriptions.

Band Performances: A sum of 635 has again been included as a contribution towards the cost of the local band. During the tourist season last year the Band gave performances at the Sea Front.

An Tostal Decorations: It was indicated some time ago by the Local Government Department that local authorities might incur expenditure not exceeding a rate of 3d. in £ on the decoration of their districts, in connection with An Tostal. The Council thus far, has not determineda Scheme for decorating the town byt it was decided to review the matter when the Annual Estimates were presented. A sum of £120 has consequently, been included in the attached Estimates. If any work of this nature is to be undertaken it is suggested that instead of outlay on bunting and decorative lighting etc., some type of improvement which would be of a permanent nature would be more desirable, e.g. recently the Council considered a proposal that a special structure might be provided for exhibiting the model of the steam ship the "Great Eastern" and other items of nautical interest.

County Council Demand: The Demand for County Services shows a very marked increase; The amount of the increase is £1080. 6. 5., which is equivalent to a rate of 2/2d. in £. The following table shows how the Demand for 1953/54 compares with that for the present year:-

The main increases are for Public Assistance and General Purposes. The increases under the heading of Public Assistance is due in great part to the rise in costs of treating patients in County Institutions, in external Hospitals and to additional outlay on medicine and drugs. Of General Purposes the increase is attributable to costs of Scholarships, Vocational Education and Fire Brigades. Last year there were credits available which served to offset increases in the costs of County Services but similar credits are not available in the present vear.

### GENERAL:

The Estimates which are now presented would require a rate of 34/4d. in £, which is an increase of 2/9d. over the rate in the present year. It is unfortunate that the County Council Demand has shown such a marked rise as this is anitem which the Urban Council cannot alter in determining the rate for the coming year. The Estimates, however, include, as already mentioned, provision for certain new works which the Council may decide to amend or defer.

The Town Clerk again, as in former years, has given very valuable assistance in the preparation of these Estimates. All the relevant records required for the purpose have been kept in a very thorough manner and the Council's accounts have been capably dealt with by him. It should also be mentioned that all the other officers and employees of the Council have discharged their respective duties in a diligent and satisfactory manner.

To the Chairman and members of the Council I desire to express sincere appreciation of the assistance and guidance so freely given throughout the year.

For the third time, we, the Tenants of Colley Row, Wicklow, apply to have a Public Light supplied in the vicinity of our houses. Most of the tenants in this area are Old Age Pensioners. The Road approaching the houses is bad, rocky, and dangerous, even in daylight, but after dark, these old people simply cannot leave their homes at all as they could not be expected to use the road in safety in the dark. On the other occasions when we applied for this light, it was deferred, possibly because so many other lights were needed in the town, but this year, we sincerly hope that the Council will find it possible to consider us, as we are genuinely at great inconvenience, and at night, in serious danger of accidents through want of this light.

Another very small matter we would mention is connected with the road. When some time ago, it was repaired, a strip of it was left undone, which being now on a lower level than the main portion has formed a "shore" or "gulley" which conveys all the water from the higher levels, down around our houses. As this would be very easily remedied, perhaps something would be done about it also, as it is very inconvenient in wet weather.

We trust that the Council will find it possible to give our application favourable consideration, particularly regarding the light, and remain.



GRANT FOR FORESHORE WORKS ; Read following letter (Ref. L.206/1) from the Department of Local Government:-

A Chara,

With reference to previous correspondence in regard to the carrying out by the Wicklow Urban District Council of emergency protection works on the foreshore at Wicklow, the cost of which is estimated at £3,800, I am directed by the Minnister for Local Government to state that he has obtained the approal of the Minister for Finance to the allocation of a grant of proportion of the cost of the scheme, and the grant will be made available on the following conditions:-

(1) The maximum grant payable will be £1,900 or 50% of the cost and proportionate payments therefrom will be made in respect of expenditure on the works as certified from time to time.

Employment of labout on the scheme will be subject strigtly to the conditions set out in the Memorandum SGA/213/EU of the 15th November, 1946, subject to such regulations as may be issued from time to time.

Particular attention is directed to the instructions in the memo randum regarding the furnishing of returns, the requisition of instalments of grants, departure from approved works and the keeping of a record of detailed particulars as indicated, of the expenditure on each deparate work. It is also a strict condition that the local authority will furnish punctually the particulars required by the forms issued from time to time by this Department in regard to the employment and expenditure on the scheme.

(3) The making of payments from the grand will be subject in other respects to strict compliance with all requirements of the Department as regards details of the scheme, supervision and execution of the work. etc.

(4) Arrangements should be made for the commencement of the work as soon as possible.

I am to request you to confirm that the Council are prepared to comply with the conditions set out above.

In reply to your query in letter of 29th ult. with which you enclose copy of communication from Department dated 23rd ult. may I refer to my report, detailed estimate and plans submitted bo the Council in August, 1952, and approved and ordered to be forwarded to the Department.

An Estimate of £137,669. 16. O. was made at that time for protection works to be carried out along the Foreshore to a distance of about 650 lin. yds. immediately, north of the end of the present promenade.

In addition, I recommended that for a distance of 400 to 500 lin. fect a series of about 80 concrete blocks, chained block to block, should be constructed without delay so as to protect the beach as it existed pending the major works being completed. Estimated cost of that emergency proposal was £3800 and it is presumed that the proposals set out in the Department's letter are based. This type of protection has already been successfully carried out on this beach. The flexibility of its structure allows the block units to sink into the shingle, some evenly, others unevenly, other irregularly until a form "set" is arrived at in the hard sub-stratum of the under beach.

The waves, during storm, break over and between the blocks, expending potential energy and are broken down in velocity and strength. Eventually, when the chained block line takes its permanent position well down in front and along the beach, the full effect is observed.

It is recommended that this part of the proposal be carried out as soon as possible whilst awaiting the decision on the major proposals for the protection sea wall etc.; its effectiveness can be expected to extend over many years with normal conditions and annual care.

It must be clearly understood, however, that this block construction is not intended to prevent waves breaking over and behind the

The provision in the existing general qualifications for these offices whereyb candidates with service in the Defence Forces may make the deductions from their ages provided for in Regulations made by the Minister for Local Government should be constructed as referring to the attached Regulations as well as the Regulations made on the 14th May, 1947. DEFENCE COMMITTEE FOR ANDREO GEOFFROY: Read following letter from Defence Commitee for Andreo Geffroy dated 10/4/1953.

10th April, 1953.

The purpose of this letter is to express the sincere thanks of Andreo Geffroy and his friends to all the Irish Councils which have passed resolutions of sympathy with him and to all those who have helped in their endeavour for his release, and also to convey some information concerning recent developments in the case.

It is now nearly eighteen months since Geffroy was sentenced to death for the alleged betrayal of two British Agents, Redding and Abbot, who landed at Locquirc in February, 1942, from a boat which was to take back to England two members of the French Resistance, Carre, and de Vomecourt (the former of whom was secretly working for the Germans). Geffroy was condemned to death on the ground of Redding's suspicion that he had betrayed him and Abbot to the Germans; but his innocence of any complicity in their arrest was proved over six months ago by the evidence of the Abwehr Officer, Erich Borchers, and of Eckert, the German Officer who actually carried out their arrest. Since then Mathilde Carréhas been questioned, and has sworn an oath before the Military Tribunal that the Germans had arranged the landing of the agents through the transmitter controlled by Borchers and were waiting to arrest them; de Vomicourt confirmed this when confronted with her. Moreover, Redding himself has now been interviewed by Mr. Henry Wales of the "Chicago Tribune" Office, 15 Rue de Marignan, Paris, (who is taking an active interest in the case) and has admitted (1) that Mathilde Carre told him and Abbot when they landed that the Germans knew they were coming, and (2) that Geffroy at first refused to take them in, saying that the Germans would be sure to come and find them Had Redding made this clear in his evidence at the trial, the Tribunal would have had no excuse for sentencing Geffroy.

In spite of all this, however, Geffroy is still confined in the condemned cell at the Prison de la Santé(CAM 2/21, 42 Rue de la Sante, Paris 14). Alone in this small dark cell he had to spend 23<sup>1</sup>/<sub>2</sub> hours out of the 24 (he gets only half an hour's excercise daily) his hands and feet are heavily fettered. It is reported that President Auriol is unwilling to sign the cancellation of his sentence while the case is under examination, and that, unlessit is given priority, this examination may drag on for three or four years. But if he is kept much longer under the present appalling conditions, Geffroy's health, already weakened by lack of adequate food and exercise would be irretrievably ruined.

I think if a concrete wall were constructed to an average height of about 6' so as to prevent access by children, it would be a great help. The distance involved would be about 25 yds. and would cost £65.

The remainder of the wall which is partly in stone and clay could be repaired further down towards the crossroads and feneed up in such a way so as to prevent children walking along it. The additional cost would be £24. 10. 0.

PATH AT HIGH STREET: Read report dated 2/6/1953 from Town Surveyor:-2nd June, 1953.

A Chara,

As you requested I examined this path - to concrete this path, which I understand is alongside the high wall at the rere of the premises recently acquired by the Department of Posts & Telegraphs.

SMALL BEACH AT SOUTH QUAY: During a discussion it was mentioned that quite a large number of children used this beach for bathing and it was felt that something should be done to clean it up. In this connection the question of extunding the sewer further out was considered and it was decided to ask the Town Surveyor to submit an Estimate for same.

DUMPING AT THE MURROUGHL It was observed that quite a large amount of dumping was taking place at the Murrough and that the principal offenders was Messrs Shamrock Fertilizers Ltd.

The Town Clerk reported that it had come to his notice that broken bottles etc. left by campers using the Murrough, was causing injury to youngsters using these ground for football matches etc.

The Council decided that it did not wish to discourage camping in this area but that the S.S.O. should be instructed to warn campers not to leave any refuse on the grounds.

WALLS AT CASTLEFIELD: The Town Surveyor reported that work was progressing satisfactorily on second wall at Castlefield. The County Manager explained that portion of the cost of this wall would be met from E.S.V. Grant and a balance of approximately £50 from Revenue.

CONCRETE ROAD AT MURROUGH: The Town Surveyor reported that the new concrete road at the Murrough was now finished with the exception of providing clay along the sides of same. The work would be completed for the estimated figure of £2,450.

ST. PATRICK'S ROAD: The Town Surveyor reported that this work was almost completed and would be within the estimate of £1,100. The possibility of removing the corner at Abbey Garage was mentioned by Councillor Kane. The Town Surveyor stated he had inquired into this but, as advised by Mr. Hopkins, Solicitor, the premises concerned were in Trust and the subject matter of a Chancery Action, the consent of the High Court would have to be obtained. This job was considered very satisfactory.
