(1) The County Council Demand, as a rule, is not transmitted to the Urban District Council before the 1st April.

(2) A special meeting of the Urban District Council has then to be called on three days notice to adopt the estimate for the Poor Rate.

(3) The estimate having been adopted, fourteen clear days notice of intention to make Poor Rates has to be given.

(These proceedings at least consume about twenty-one days)

(4) The Poor Rate having been made, the collector could not possibly, under three weeks more, lodge a sum equal to one fourth part thereof, to enable the Urban District Council to comply with the terms of the County Council Demand note.

Thus it will be seen that at least for five weeks after the first day prescribed for payment of the first quarter's instalment, and for at least two weeks after the prescribed day in the third quarter, an Urban District Council is precluded, both by law and circumstances, from providing funds to discharge their obligations, and are meantime open to Mandamus proceedings, with their attendant costs.

We therefore, respectfully request the Local Government Board to make such amendments in the terms of Form 26 of the County Council's Order, 1899, as will remove this anomalous condition of affairs, in making this request, we are not at all ignorant of the obligation on the County Council to meet in advance the demands upon them by the Boards of Guardians and Rural District Councils."

Sir

The Local Government Board for Ireland have had before them your letter of the 18th ultimo, and enclosures, relating to the further sum of £944 applied for by the Wicklow Urban District Council for the purpose of carrying out additional sewerage works; and with reference to the Inquiry held in regard to these works by the Board's Inspector, Mr Price, in the month of April last, I am to state that the Board now sanction the borrowing of this sum in pursuance of Section 237 of the Public Health (Ireland) Act 1898,— the loan is to be applied in the construction of new sewers in Ball Alley, Wentworth Place, and Colley Street; repayment to be spread over a period of 30 years, and the loan to be issued in three instalments of £500, £300 and £144, respectively:— As some misapprehension appears to have arisen as to the effect of the Board's sanction to a loan they consider it advisable to draw attention to the terms of Section 246 of the Act above referred to, and to point out that, while it is open to the Council on receiving the sanction of the Local Government Board to a loan, to contract for it in the open market, or to raise it by the issue of stock, the final decision as to whether a loan will or will not be made from Public funds rests with the Lords Commissioners of His Majesty's Treasury:— The Board are aware that their Lordships have felt compelled to refuse their sanction to loans where the rates were exceptionally high, or where there has been impunctuality in the payment of the instalments of loans already made:— In the latter case their Lordships, before making any further loan require an undertaking to pay the instalments on existing or future loans punctually, on the fall days on which they accrue due.

Application should be made to the Commissioners of Public Works for the loan, if the Council desire that it should be recommended under Section 246 but no expenditure should be incurred in anticipation of receiving the loan, until the District Council learn that its issue has been authorised by the Lords Commissioners of His Majesty's Treasury. — The Plans and Estimates of the proposed new sewers are returned herewith, and the Board request that they may be furnished with certified copies thereof.

for deposit in this Office. - I am to add as regards the further application of the Council for sanction to a Loan for the erection of Working Class Lodging Houses, that the above named sum leaves a very small margin of borrowing power available by the Council under the Public Health Act and Sanitary Acts, and the Board have, therefore, to call special attention to the last paragraph of their letter to the Council of the 24th July last on this subject.

Gentlemen

In January last Miss Graham of Summer Hill applied to the Council to have a sewer constructed into which her premises could be drained. Nothing has been done, and my attention has again been drawn to the matter. I examined the place recently, and I find the public sewer is about 60 yards from the premises in question, and as any drain or sewer to connect with it would be rather costly, having to be laid partly through the road it would hardly be fair to saddle the owner with the whole cost of the work, especially as other houses could be connected with the new sewer if constructed. The Lady's house and yard are in a bad state for want of drainage, and she certainly has good reason to complain. — I would recommend that a brick pipe sewer be laid across the road to join the present sewer at the rear of Captain Wall's house —

Gentlemen

I respectfully beg to report that during the past month the Public Lighting of the Town was well maintained. I found three lamps not lighted, but it is my opinion they were turned out. — I made usual sanitary inspections visiting over 180 premises and served 13 notices as required by statute for different sanitary purposes. — I had drains and water channels repaired and cleaned on six occasions. By directions of your Council I had samples of water forwarded to Sir Charles Cameron for analysis — The scavenger was attentive to his business, but one man is not sufficient to clean the streets of the Town as during the past month the streets of the Town were in a filthy condition — I have drawn attention to this subject on various occasions — I would suggest to your Council that the following Bye Lanes and passages be repaired with quarry flag or some other metalling, namely Dispensary Lane, Stable Lane, Ball Alley, Hospital and Pound Lanes — The Medical Officer of Health's attention has been directed to some sanitary subjects =

Therefore on the facts the Urban Council are neither entitled to demand or enforce payment in these cases. " I find that the portion so leased by the Board of Trade " is ground made by the action of the sea gradually retiring and as a matter of law the right of the Crown as formerly vested in the Commissioners of Woods and Forests and now represented by the Board of Trade

Lord Yarborough) which would appear to me that the Urban District Council of Wicklow in accepting the lease from the Board of Trade have forfeited their fee simple in the two acres and thirty perches, because according to the present law where a man gives a lease of property in which he has no legal interest for a term of years both Lessor, and Lessee will be estopped during the term or forbidden to deny the validity of the lease.
