Auditor's Report

Gentlemen,

I have had the honour to report that I have audited the accounts of Wicklow Urban District Council for the financial year ended 31st March 1909, and I beg to transmit, herewith, two copies of the Abstracts duly certified.

The Urban Rate levied for the period amounted to 3/9 in the £ and the Poor Rate 2/4, in both cases the collection was satisfactory.

I have surcharged the Rent Collector with the sum of £ 4. 14. 2, being arrears of rent of Artisans' Dwellings which he neglected to collect and which are now irrecoverable also the sum of £ 4. 2. 10, Poor Rate allowed.

I have also been obliged to surcharge several items amounting to £ 18. 0. 8 included in the Solicitor's bill of costs.

The circumstances connected with this case should impress the Council with the necessity of having their Solicitor's bills furnished at least once a year, the one under review having extended over three years. Had the costs been furnished at frequent intervals the Council would have been aware that the Solicitor had not obtained the amounts referred to, from the Contractor who was liable and they could then have taken steps to obtain payment of the amount while it was possible to do so.

The accounts were prepared and submitted for audit by the Town Clerk as heretofore, in a highly commendable manner.

Sir,

I am directed by the Local Government Board for Ireland to enclose, herewith, a copy of a special report of their Auditor, Mr D. A. Baker, on the accounts of the collector of Rents of the Corporate Estate and Artisans' Dwellings of the Wicklow Urban District Council, and I am to request that it may be submitted for the Urban Council's special consideration, due notice being given to each member.

The Board desire me to point out that the facts disclosed in the report are not satisfactory, nor do they reflect credit on the collector.

I am to draw the special attention of the Council to the necessity for the Official Rental remaining at all times in the custody of the Clerk, the Collector to have access to it during office hours. The Council's attention is also called to the provisions of Article 64 of the Public Bodies Order, 1904, and with reference thereto, I am to state that serious notice should be taken by the Council of any failure on the part of the collector to submit his accounts regularly at least once each month to the Clerk in order that they may be checked. I am to point out that under Article 5 of the same Order it is the duty of the Clerk regularly to report any failure in this respect on the part of the collector.

With reference to the 4th paragraph of the accompanying Report, the Board desire me to state that the collector should be called on to explain, in writing, his failure to obey the Order of the Council directing him to take legal proceedings against tenants owing one year's rent.

Auditor's Special Report

15th Sept 1909

Gentlemen,

In pursuance to your instructions, I beg to furnish a special report on the

accounts of the collector of Corporate Estate and Artizans Dwellings Rents of Wicklow Urban Council.

It would appear that my last report on the audit of Wicklow Urban District accounts, which was submitted to the Council, was referred to the Finance Committee but as there was no attendance at the meeting, no action was taken with regard to the several matters referred to therein, nor has the collector complied with the instructions given, the rental being still retained in his possession, it has, therefore, not been checked by the Town Clerk, nor has it, he informed me, been submitted to the Finance Committee during the year.

It is most essential that this Rental should be kept in the Office safe as the consequence of loss through fire or otherwise would be very serious.

As regards the Corporate Estate the arrears have increased by about £ 30 during the year. Though the Council passed a resolution some years ago that in the case of all rents one year in arrears proceedings should be taken, I find there are upwards of forty cases in which one year and upwards are due and in none of these instances have the steps indicated in the resolution been taken, in explanation the collector states he considers the arrears perfectly safe. I have, however, pointed out to him his personal liability should any loss arise.

There are several items which it would be necessary for him to lay before the Council for the purpose of striking off, these I have noted in the rental.

Vouchers for Rates and taxes allowed have not in all cases been submitted, these are items which should be verified by the Town Clerk who is conversant with the various letting agreements and leases.

The receipts from grazing lands show an improvement on the previous year, this account is one that I have no means of checking, as the charges are made per head of cattle and as these are constantly going on and off it would be necessary that the Town Clerk and Finance Committee should regularly check this account.

With regard to the Artizans Dwellings there are a number of cases in which the arrears are much too high.

The collector admits four cases of bad debts in which the tenants have left owing arrears amounting to £ 4. 14. 2, these I have surcharged him with, as he neglected to promptly collect the amounts. There are two other cases (No. 6 and 7 Strand Street) which were £ 1. 3. 10 and £ 1. 11. 2 respectively, in arrears on 31st March last, these I have not surcharged as the tenants are still in occupation and the collector thinks he may be able to collect the arrears.

I have also surcharged the collector with Door Rate allowed on these dwellings and have stated my reasons therefor on the face of the Ledger.

The Town Sergeant has, I understand, ceased to collect these rents

for the collector.

The prescribed form of Rental was not kept during the year but I believe this will be adopted in the current period.

1. Your Committee inspected Summer Hill and had before them Mr Newbold's application. We recommend that the Slot between Mr Newbold's and Anne Ryan's holding be investigated and reported thereon.

2. Your Committee's attention has been drawn to the advisability of Mr Newbold Straightening the fence opposite his houses on Summer Hill, Mr Sansing to mark the line of road.

3. We recommend that notice be served to provide drainage to John Conway's premises Castle Street.

4. We inspected with Mr Thomas Gregory the passage way between his holding and Mr Gillellis and are of opinion that it is a matter between the Tenants themselves.

5. We have carefully inspected Miss Gregg's and Dr Gregg's houses in Strand Street and recommend:- (1) That Miss Gregg be granted a renewal of the lease of four houses on the South side of Strand Street at an increase of 20 per cent on present rent, lease and rent to date from 25th March 1909; new lease to operate as a surrender of the old lease and be taken out on or before 1st January 1910. (New Rent £1. 5. 0 p^a)

(2) We also recommend that Miss Gregg be granted a renewal of the lease of the house on the corner of the Lane with a frontage to Bond Street on similar terms and conditions, Miss Gregg to provide drainage and sanitary accommodation to the satisfaction of our Town Surveyor. (New Rent 3/6 per annum) Formerly included in H^o Hayes Lease

(3) We recommend that the separate house on North east side of Strand Street be included in the lease of the premises adjoining and which lease has already been sanctioned to Dr Gregg the rent to be apportioned on the value of the whole plot and to include 20 per cent increase, the usual conditions to apply. (Rent £ 3. 17. 6 which includes 3 Mrs Doyle & Charles Ralph's holdings now in one lease (6 houses))

We have carefully considered the advisability of granting a renewal of the lease of two houses, one situate fronting Bond Street, and the other in the Lane leading from Bond to Strand Street, and recommend that same be granted at an increase of 20 per cent, Dr Gregg to provide drainage and connect the same with sewer Strand Street, to the satisfaction of our Town Surveyor. (New Rent 5/- per annum formerly included in H^o Hayes Lease)

The drainage system of the town was disinfected and flushed with water as usual they appear to be in good working order.

The public lighting of the town during the month was well maintained. Some time ago I called attention to the necessity of having the doors of the old Boat House Murrrough repaired and painted. I now do so again hoping you will give it consideration.

I have had the Bathing Boats removed to storage for the winter. The Medical Officers of Health's attention has been directed to some sanitary subjects.

I enclose the latest diagram showing the Water Supply, waste etc. On the 30th Sept last Mr O'Connor and I succeeded, by a little vigorous action, in reducing the waste to 26,000 gallons per day, the measures we then took were considered rather drastic by some members of the Council and the waste is now 40,800 gallons per day. The total supply now passing through the filters is 61,300 gallons per day making the speed of straining - I cannot call it filtering 11.4 inches per hour, while the best authorities on water-works only allow a maximum speed of 5 inches per hour, I shall therefore, unless the Council direct otherwise resume the steps taken last September and carry out the order of 8th June last.
