I may mention that since end of financial year Colonel Welch has paid one half year's rent, thus reducing his arrears from £ 63 . 10 . 0 to £ 31 . 15 . 0.
Re Rents of Artisan's Dwellings:- You have some idea of the difficulty of

collecting rents from poor people, such as occupy the Murrugh cottages, but as the Auditor's ruling and direction leave me no option I shall in future take prompt measures with defaulters including those yearly tenants who owe one year's rent or more, and shall look upon your acquiescence herewith as approval of this course.

I must take exception to the Auditor's reference to an order of your Council directing me to take legal proceedings against tenants owing one year's rent. In reply to my letter to the Town Clerk for this Order, he furnished me in his letter of 18th ult, with the following resolution:—"That we authorise and direct Mr Desaise our Agent to take the necessary steps to collect in all rents over a year outstanding"

This resolution was passed on 5th August 1895, twelve years before I came into office, and it is a personal order to Mr Desaise. But as I have already intimated I shall now act in accordance therewith, unless you direct otherwise."

Town Surveyor's Report
2nd December 1909.

Gentlemen,

Considering the primitive nature of the appliances available the Roads and Streets are in fair condition. I must however, again ask that a proper Mud Cart be supplied, as at present the sweepings cannot be removed until they consolidate.

Mr J. S. Newbold is about to remove the old thorn fence in Colley Row, and to substitute a new wire fence. The present fence is in a zigzag line. I would suggest the new one be on a straight line, as shown on the tracing herewith.

The waste of Water is still very excessive, and I regret not having the support of the Council to enforce the regulations in their entirety.

The state of that portion of the Foreshore Works opposite Mr Walker's house on the Murrugh, is rather serious as will be seen from the sections I have prepared, and prompt steps must be taken, or it will soon collapse.

A very exhaustive and important report from Mr Shannon, C.E. was read at the last meeting of the Harbour Board, on the state of these works, but that body took no steps in the matter. I thoroughly agree with every word in that report; and I cannot too strongly recommend that the defects he mentions be at once remedied by whoever is the responsible authority. I hope the Urban Council will take prompt action in the case.

The repairs to Mr Dorcas Mitchell's house have been completed.

I received an estimate for the repairs to the Old Lifboat House, but I think it will be better to make out a specification for the work, and invite tenders in the usual way.

I have lodged the amended Main Drainage Plans with the Town Clerk, for your approval. They should be signed by the Chairman, and sent on to The Local Government Board.

There is no ventilator in connection with the W.C. or drain from the Teacher's Premises at No 2 National School. The Select Vestry should be asked to provide proper vent-pipes to same.

Gentlemen;

I respectfully beg to report that during the past month I have given special attention to the Dairies, cowsheds and Milkshops in the District, and regret to state that some of the Proprietors are relapsing back into their old habits of allowing the cows to get into a dirty condition, however I have warned the parties referred to that I shall take immediate steps to compel them to comply with the regulations. I have called the Milk Vendors attention to the mode of distributing milk in uncovered cans, and also to the untidy condition of many of the Children handling the Milk, if there is not an improvement in this respect I shall supply the names of the Milk Vendors to your Council as a warning to the public.

I served 3 notices on Cowkeepers in October for sanitary requirements two are making reasonable efforts to comply with the notices, and one has done nothing whatever, the latter case will require strong measures to be taken.
