Sanitary Officer's Report
5th October 1914

I respectfully beg to report that during the past month I made my usual Sanitary inspections visiting 306 premises and served 19 Notices under the Public Health Acts for various sanitary purposes.

The usual disinfecting of the main drainage and washing down of the water steps has carried out satisfactorily. The scavengers were attentive to their work.

During the month I had two patients removed in ambulance car to Fever Hospital and these premises disinfected -

The illuminating power of the public lighting has not been up to the standard and the attention of the Gas Manager should be called to the matter -

owing to a heavy wind on 1st September last two of the trees on the Mall were blown down and broken -

The paving in Leitham Place requires repairs and also the paving in Bachelor Walk -

The Bathing Boxes have been removed to storage and I await your directions with regard to the public seats -

During the month I had four cases before the Magistrate at Petty Sessions for defective drainage, in each case an order was made to have the work carried out within a fortnight, in three cases the order has been complied with, and in the case of premises New Street the work is in Contractor's hands.

Owing to three of the Town labourers being engaged in the
 greater part of September and four during the past
 fortnight at the Waterworks, the roads and streets
 are in a neglected condition, especially the outlying
 roads on which the waterables, drains, outlets etc are so
 overgrown with grass and weeds as to cause deep water-cuts
 in the carriage way. I shall require all the men with two
 carts to spread the metal during this month and put the
 road into some sort of reasonable repair and condition.

In the ~~near~~ time above mentioned about 1200 cubic yards of sludge and soft clay, have been removed from upper end of Reservoir to near top water level, some of this has been carted away by the adjoining Farmers. The remainder should be removed at once, and if necessary carts must be employed to do so before the water rises. The level of the water is now rising and I recommend that a continuous supply be again turned into the delivery mains through the Town.

40 tons of $1\frac{1}{2}$ " Ball race metal are required for Chemical Road and 50 tons of fine screenings for Town footpaths. The drainage of Rochford premises is in the hands of a Contractor.

The ground at the foot of the clay bank was opened and the water found percolating came from underground springs.

We have made arrangements for a second horse and cart

Your Sanitary Sub Officer has reported with regard to the Councils houses in Bond & Strand St from which it appears several of the concrete floors in the Kitchens have been deliberately broken up, some action should be taken in this matter. Your Committee met this morning and have directed that the men at Waterworks be continued on for this week to staunch the leaks going into filter chamber and to construct a concrete buttress up to the level of filter bed. The spreading of macadam to be continued and the two carts to be kept on for the present.

We have arranged with your Town Surveyor to call on Mr. John Flynn with regard to drainage of water off the public road opposite Miss Rhode's house and to have same remedied.

Your Sanitary Sub Officer has reported several householders for accumulation of manure and refuse on their premises, we have directed that notices be served to have same removed at once. We have also had before us a number of small dwellings without proper drainage and want of ashpits, we directed that in all cases notices to be served to provide same.

We recommend that Patrick Crowlock be told off to carry out Town Surveyors directions and to see that same is complied with by the workmen, he to be paid 1/- per week extra. On the occasion of heavy rain storms no matter at what time they occur he is with the assistance of another man to have all street-gulleys cleared to take away surface water, both men to be paid for time occupied if outside working hours.

We have directed that the lengths of fire hose be examined and thoroughly overhauled and also fire apparatus.
