5th August 1918

I beg to report that during the past month I made my usual sanitary inspections visiting over 306 premises and served 14 notices under the Public Health Act for various sanitary purposes all of which have been complied with.

The usual flushing and disinfecting of main drainages have been carried out satisfactory.

The Scavenger has not been as attentive to his work as he should have been several of the back streets have not been scavenged and others seldom visited.

During the month an obstruction occurred in a Street Gully at Morton's Lane I had same cleared and put in working order.

Some of the flooring boards, uprights & cross pieces in the

Woodenbridge have become rotten and will require to be replaced
 One of the Iron Slates at the back of the Urinal on the South Quay is broken, this was caused by some timber striking it, while being hauled aboard a steamboat.

The practice of slinging timber across the Harbour Road to the Quay side should be stopped or else the Council will be at considerable expense keeping it in repair.

The Seat which was erected on Rathnew Road was broken from its place and thrown across the Public Road; same has been removed to storage.
