We have had before us Coal Controller's letter re price of coal, and have directed our Town Clerk to ascertain from the various Coal Merchants the F. O. B. price of Coal at Troon, Garston and other Ports, and to submit same together with the particulars asked for th the Controller with a view of having the price of coal fixed.

We have had before us Sanitary Sub Officer's Reports, and having considered these reports the Committee ^{regret} to inform the Council that they disclose a rather alarming condition of things so far as the insanitary condition of the houses contained in said reports. It would appear from our investigation that these insanitary houses might be divided into three groups or classes, one of these possess no sanitary arrangements nor gardens. The second while being provided with gardens appear to have no sanitary arrangements whatever., while the third might be sub-divided into those which have sewers and no closets, and those which have closets and no sewers, we think that the Owners of such of those houses as have no sewers should immediately be obliged to connect them with the Township sewers which we are informed are quite adjacent in almost every case.

In all the other cases we would suggest that the Council exercise all their authority under the law to compell the Owners to remedy the condition of things which are highly unsatisfactory, and which is a continuous menance to the health not only of the inhabitants of these houses but to the entire community.

We further recommend that in the event of these Owners not providing the necessary sanitary accommodation we ask the Council to take the necessary steps to cancell the leases in those various cases.

We have had before us Local Government Board's letter re housing scheme, and recommend the Council to consider the question of providing say about twenty additional Artizans Dwellings somewhat similar to those erected on the Convent Road. As an indication of the urgency of dealing with said houses we would refer the Council to the reports of the Sanitary Sub Officer.

We recommend that the Yard on South Quay be let to Mr. Roland at the rent of £15 : 0 : 0 per annum.

Sub Sanitary Officers Report

4th February 1919

I beg to report that during the month I inspected upwards of 300 premises and served 23 notices under the Public Health Act for various sanitary purposes which were complied with.

On my inspection of the main drainage I find in Strand Street and a part of Main Street the pipes are three parts chocked and a bad smell from the manholes. I would have had them cleared up by now only there was no plugs in the manholes for the purposes of clearing. I have a man working in the manholes at present setting the iron plugs, so as to have them cleared next week. The cover is gone from the main pipe in the Marlton River, and will require a new cover that cannot be carried away.

On inspecting the Black Castle I find the Scavengers and others have made a depot for throwing all unsanitary matters there, and I have received complaints from the tenants there about same.

The Public Lighting of the Town has been satisfactory. The Scavengers work on the Streets has improved in cases, but some of the Streets are very hard to be kept cleaned as the people throw every refuse at night on the Streets and the Scavengers

has no help to reach on these back Streets and the public are complaining about them.

MacPhail, Town Clerk, and John DeCourcy, Waterworks Overseer be each granted a war bonus of 23/- per week, being the amount set forth in the schedule accompanying Local Government Board's letter as applicable to those two Officers.

We recommend that Bartholomew O'Toole be granted a war bonus of 23/- per week, for the same reason as stated above, subject to the sanction of the Local Government Board, inasmuch as the question was raised as to whether or not he was entitled to the war bonus having regard to the circumstances that he is at present an Officer on probation., his appointment not having yet been finally sanctioned by the Local Government Board.
