Sub Sanitary Officer's Report

6th July, 1925  
-----

Inspected 26 premises and served one notice for defective drainage  
which has been complied with. The usual flushing of the main drain-  
age and the disinfecting of the Gully Traps and the Urinals on the North  
and South Quays has been carried out weekly during the month. I wish  
the Council's permission to re-fill Gully traps with water from water  
main owing to dry weather.

By the Council's instructions I inspected premises at Hill Side  
occupied by Miss L Hayden, and find there is no cause of complaint of  
want sanitation. She wants a wall removed in Yard and the main Wall  
at rere of premises raised which is a question for the Owner of the  
premises.

During the month the Council's men were engaged on the Marlton  
Road, Station Road, Fern Hill, Church Hill, Summer Hill, Green Hill and  
Rathnew Road raking off stones and trimming Hedges along same. I had  
the stones removed to depot. *Eh*

The Crusher in Mill Yard was over-hauled by Mr Roscoe and two of  
the Council Men were engaged with him for a week. I had six loads  
of tar chippings spread in pot holes on Rathnew Road. Owing to the  
dry weather I had the water car on the main street for half days during  
the past three weeks and had all loose stones removed off Main St.

I had ten Men in Mill Yard 2 weeks breaking Stones. One of the  
Public Seats on the Pier has been broken during the month.

in it the year previous *Eh*

## ELECTRICAL ENGINEER'S REPORT

7th July, 1925

During the month ended 30th June the services has been maintained as usual. I have run 3 new services and wired up Nos 2 & 3 of the New Cottages as directed. With reference to application for removal of Pole on Summer Hill I have inspected same, and consider if this is carried out it will mean a considerable amount of unnecessary expense as well as causing inconvenience to Users of Electric Light on that section. Four new Consumers have come on during the month.

I submit a summary of Income and Expenditure for the Quarter ended 31st March and June 30th 1925. In each case I have given the total expenditure for the Quarter, but have shown working expenses under a separate heading as distinct from costs of running new services, installing Meters and Extensions to overhead lines.

ORDER:- The Minister for Industry & Commerce sanction to be obtained for removal of Electric Pole. The whole Town to be lighted on Saturday, Sunday and Monday Regatta week.

ENGINEER'S REPORT

7th July, 1925

E.K.

I have been making preparations to start work under Road Scheme. I took up duty for your Council on 1st July 1925.

We have been refused permission to enter the Dunbur Quarry by My Philip Keogh. I would recommend that an Order be obtained to enter here, in accordance with the 1925 Local Government Act.

I have directed that 3 inch stones only be brought for the present to the Crusher in the Yard, and, I intend to start on tomorrow morning.

I propose to acquire the Crusher Stones which are at present in the Yard and to pay for them at the Rate of Five Shillings per cubic Yard from your Council.

In agreement with the suggestion of the Inspector from the Roads Department, it is proposed to pay 1/- per cubic Yard of stone crushed to the Electricity Department of your Council.

I have directed Mr John Roscoe to take charge of the Engine in the Yard and to supervise the men working the Crusher and keep the account of all material entering and leaving the Yard. I would suggest that he be paid at the rate of £3 weekly.

An up-to-date tar boiler and sprayer is an necessity in a Town like Wicklow and I would recommend that you Purchase the very neat handy and economical spray boiler placed on the Market by Municipal Appliances Ltd. The illustrations and price are attached herewith.

ORDER:- That Messrs J. J. Kennedy; M. Turner; E. Lalor; D. H. Haskins John Conroy and Engineer wait on Mr Philip Keogh, and try and come to an agreement with him in connection with the Quarry.

That the Minister's sanction be obtained to the payment of £3 per week to Mr John Roscoe for looking after Plant.

That the Minister for Local Government sanction be asked re the

purchase of Tar Boiler & Sprayer.

Read letter from Messrs Pat Merrigan; T. Murphy; P Reilly; T. Kelly; John May; John Cullen; W. Gregory, W. Murphy, stating that their still remained a balance of £40 or more of the Grant of £800 in the hands of the Urban Council that was granted by the Government for the relief of the unemployed ex-National Army Men for Road Work and requesting the Council to have same expended forthwith.

The Town Clerk stated that the £800 was granted for the relief of unemployment and that it was not solely for ex-National Army Men however the ex-national Army Men received £760 of it and that he had expended the balance during the past two weeks on the breaking of stones which are required for the Steam Rolling Scheme by order of the Council.

A Chara,

I am directed by the Minister for Local Government and Public Health to transmit to be laid before the Wicklow Urban District Council, the accompanying copy of a report of the Minister's Inspector, Mr Ryan, on his recent inquiry concerning the Officials employed by the Urban Council.

The Minister is willing to consent to the recommendations of the Inspector fixing salaries without bonuses from the 1st instant as follows:-

Mr McPhail, Town Clerk, - £340 - rising by £10 to £400 per annum.

Mr DeCourcy, - £180 together with his present emoluments.

Mr O'Toole, - £135 with the provision of uniform as necessarily required

As regards the rate and rent collection, the Minister is quite satisfied that the commission at present payable should suffice, and agrees with the Inspector that the positions should be amalgamated when a suitable opportunity arises. The Department are by no means satisfied that either of the present occupants of these positions hold pensionable offices. The mere fact that an official of a Local Authority does no other work than for that Authority would not necessarily imply that he devoted his whole time to their service. While it is not intended to authorise any increase in the present rates of commission it is considered that the status of these two officials should be placed beyond doubt. I am, accordingly, to ask for certified copies of the advertisements in response to which the appointments were made. The resolutions of the Council appointing them and the letters of sanction, if any, given at the time.

As regards Mr Ryan's suggestion that a Town Surveyor should be engaged I am to state that the Minister concurs, but he is of opinion that the part time services of a suitable professional gentleman practising in the neighbourhood should suffice.

The Council should submit resolutions regarding the Officers concerned to this Department for the Minister's formal sanction.
