Sanitary Sub Officer's Report.

6th April, 1926.

Inspected 15 premises and served two notices for sanitary purposes which were complied with.

The usual flushing of the main drainage and the ^{disinfecting} ~~disinfecting~~ of Urinals on the North and South Quays has been carried out weekly during the month.

On inspecting a premises on Kilmantin Hill, (re dampness) the walls on the ground floor are in a bad state and the owner of the premises is of opinion that there is a leak in an old well that was covered in some years ago by the Council.

With the Council's instructions I had the old store at the Black Castle taken down, there is about twenty tons of concrete blocks out of ~~the~~ same, I wish the Council's instructions to have these blocks carted to the Foreshore.

During the month I had the Council's men also engaged cleaning up water-tables on all the Council's roads, and had 150 yards of reinforced concrete railing erected on Bachelor's Walk.

I wish the Council's permission to have the public seats painted and put on the Piers and Marrough by the end of this month.

eh The Fire-hose was engaged at a fire in the Market Square on March, 6th, and had same extinguished before much damage was done.

WATERWORKS OVERSEER'S REPORT

I repaired fountains at High Street and Monkton Row.

Three of the supply streams supplying the Reservoir have stopped flowing it is not usual for them to stop so early in the year.

There is 19ft. of water in the Reservoir.

During the month ended 31st March, 1926, the lighting of the Streets and Harbour has been carried out and the services to private consumers maintained as usual.

As the public lamps have been lighting since September 19th, I would like to have instructions from the Council as to when the street lighting is to be discontinued.

I have carried out an overhaul on one of our engines which has been working during the winter months and same is now in a satisfactory *eh* condition.

During the month I have collected and lodged to Council's credit £422 : 11 : 11, this closes collection for outgoing year, and leaves

outstanding arrear very small.

The meter readings for March Quarter have been completed and Accounts will be furnished to consumers during coming week.

One new service has been run and one new consumer connected. during the month.

Sub Sanitary Officer's Report.

4th May, 1926.

Inspected 25 premises and served one notice for sanitary purposes which is under completion.

By the Medical Officer of Health's instruction I disinfected a premises on Kilmantin Hill, and had bedding destroyed, I submit herewith list of same together with approximate value of the articles destroyed.

The usual flushing of the Main-drainage and disinfecting of Urinals on the North and South Quays has been carried out weekly during the month.

Owing to complaints the following work has been carried out:-

1. New open gully with iron grate, built at corner of Church Street.
2. Man-hole of sewerage lowered at crossing on Summer Hill.
3. 20 yds. of pipes laid on Dumbur Road to carry off surface water which flooded the premises of Mr Wolfe.
4. Relaid 150 yards of curbing on foot-path at Bachelor's Walk.
5. Made 100 cement posts and 30 rails for paling on Bachelor's Walk.

The Council's men are working on Kilmantin Hill, laying pipes from the well to sewer and will be finished by Thursday.

Owing to the water-table having sunk in front of Mr F. Murphy's premises it will require eight yards of water-table to carry off water that is ledging at same.

The pump of the water car requires a new sucker before the car can be used again.

ORDER:- That water-table at Mr F. Murphy's premises, Church Street, be repaired. Sucker to be provided for pump of water car.

Mr Martin Byrne be paid the sum of £1 : 10/-, for bedding destroyed.

WATERWORKS OVERSEER'S REPORT.

4th May, 1926.

During the month I repaired fountains on Kilmantin Hill, at Castle Street and St. Patrick's Road.

Made several night tests and as a result served seven notices for waste of water through leakage.

All meter owners were served with notices to refrain from washing cars.

There is 17ft. water in the Reservoir, and only two streams flowing very slowly, it is very early in the season for streams to be so low.

During my time in charge of the Waterworks, the streams were not so small at this time of year, except on one occasion.

ELECTRICAL ENGINEER'S REPORT.

4th May, 1926.

During the month ended 30th April, private and public services were maintained as usual.

The public lighting has been

discontinued since the 18th instant.

I have carried out some necessary repairs to plant and to some of our overhead lines.

During the month I have collected and lodged to credit of the Council £101 : 14/-.

Read the following letter from Mr Edward Kennedy, Peer Rate Collector

I beg to inform you that I have from time to time issued summonses against defaulters for the payment of ~~rates~~ Peer Rates, and have also obtained Decrees, but the Decrees have never been executed as there is no special Bailiff to be obtained here. I have at present about 30 defaulters who should be summoned for the non-payment of Rates, but before I take out summonses I shall be glad if you will let me know will you allow me the costs of same.

I have been considerably out of pocket in consequence of the Decrees not being executed, and I think it would not be fair to expect me to be at further expense in connection with prosecutions.

You are aware that when I was appointed that the cost of the summonses was only 1/6 and moreover the Decrees were executed by the R.I.C., and thereby I was able to recover my out of pocket expenses, at present the cost of each summons is 4/-, and if I was to be at this loss for every summons taken out by me it would mean that my Poundsage would be practically eaten up by my out of pocket expenses.

On hearing from you that you will refund me the cost of the summonses and advise me as to how I should have these Decrees executed I will immediately take steps against the parties concerned.
