Sub Sanitary Officers Report

1st June, 1926

Inspected 30 premises and served 3 notices for sanitary purposes, two of which have been complied with and the other notice is under the consideration of the Owner of the Yard. The usual flushing and disinfecting of the main drainage and Gully Traps were carried out weekly during the month.

By the Council's directions I had 12 Yards of 4 inch earthen ware pipes laid from Well on Kilmartin Hill to main drainage, and had about 10 yds of Cement water table laid in Church Street. Opened up and cleaned drainage from Mr. Darcy's Yard on South Quay. The Council's Men were engaged at the quarterly cleaning of roads on Station Road, Fern Hill, Church Hill, St Patrick's Road and are engaged at Bachelor's Walk erecting railing along same.

Had the Public Seats painted and put out on the Piers and Sea Murreugh for the Season.

I wish a Committee to inspect water table at Convent Road as same requires a Gully Trap laid in same and piped across the road.

Waterworks Overseer's Report

6th July, 1926

Since last Meeting there is a great deal less water coming into the Reservoir than there has been for a number of years.

It will be absolutely necessary to use the strictest economy. One of the two streams that supply the Reservoir is just the smallest dribble. The main supply stream is also very small.

The Springs started to fall early in March, and have got worse and worse ever since. The Reservoir is down to 8ft 8inches below overflow.

During the month I repaired fountains at Kilmantin Hill and Lower Strand Street, this fountain is been continually broken, and stuffed with pieces of wood. I cleaned service at Wentworth Place.

There is a red sediment showing in the water in Castle Street, this is rust from mains. I reported on the condition of the mains on two occasions before.

I would like permission to turn off water from different parts of the Town leaving on one main only for testing purposes, this would be at night.
