Inspected 20 premises and served three notices for sanitary purposes which were complied with. The flushing of the main drainage and the disinfecting of the Urinals on the North and South Quays has been carried out weekly during the month.

By the Council's directions I had a large number of men employed for Christmas and had them working at Mill Yard, North & South Quays, Corporation Lands and throughout the township and got the work completed as far as I could in the four days.

During the month the Council's men were engaged at repairing the railing on the Sea Murrough and cleaning up water tables etc at Brickfield Lane, Convent Road, Coopers Lane, and upper and Lower Monkton Row and had 17 yds stones spread on road on sea Murrough and stone shore at Morton's Lane repaired.

There is eight feet of water in the Reservoir. About thirty tons of Sand is required for adding to existing fine sand in filtering beds.

We have instructed the Electrical Engineer to report as to the advisability of altering the position of the North Quay Lights.

Sub Sanitary Officer's Report.
1st February, 1927.

Inspected 45 premises and served two notices for sanitary purposes which were complied with.

The usual flushing of the main drainage and disinfecting of Urinals on the North and South Quays has been carried out weekly during the month.

I wish the Council's permission to take a sample of the water in the yard of Mrs Byrne's premises, Fitzwilliam Square, where a pump has been erected over a well and the public are getting a supply of water from same, which is now stopped pending analysis.

During the month I had 70 tons of stones broken to $1\frac{1}{2}$ inch ^{gauge} ~~size~~ with the crusher in the Mill Yard, and had them spread at Bridge St., Summer Hill, Castle Street, and High Street, and had all mud swept of Main Street and removed to depot, and had water ways cleared up on all roads after the rain storm.

Owing to the bad state of the road with mud along the South Quay and footpath from Fern Hill to Bollarney, ^{with} loughs of water lying along same, I have received several complaints and wish the Council's instruction to have same attended to.

During the month I had the fire hose engaged at a fire which broke out at Messrs Millers' yard on the North Quay, about 9 p.m. on the 4th January.

We have only six lengths of sewer rods in stock and I require a new set of rods.

ORDER:- That sample of water be taken from ^{pump on} Mrs Byrne's premises, Fitzwilliam Square, and sent for analysis. That Mr Gallagher's attention be drawn to the state of the footpath on the Rathnew Road.

Waterworks Overseer's Report.

1st February, 1927.

During the month I repaired Fountains at High St. and New Street, the new Fountain at New Street was pulled from its socket in granite block, considerable force was necessary to do this, the Fountain that occupied this position was also broken to pieces, it would be impossible for children to do this damage. There was also internal parts of Fountain in Lower Strand Street smashed, this was done by forcing back the handle and shoving a rod up the outlet, some new parts are required for a lot of the Fountains.

Owing to the depth of the water over the sand in the Filtering Beds not being sufficient on the 17th inst., I had special Meeting called to put the matter before the Council, ~~only~~ only one Member, the Chairman was present. It was decided to let the water through to the Town direct from the Reservoir in order to give a full 24 hours supply and notify the people of same. Since that we had rain and as a result the Reservoir came up 18 inches, water is again passing through the Filters.

There is now 6ft. 5ins. of water in the Reservoir and a fairly good supply is coming in but nothing like the amount that comes in at this time of year.

Attached is an account of rainfall for end of year 1926 and beginning of 1927.

ELECTRICAL ENGINEER'S REPORT.

1st February, 1927.

During the month ended 31st January, plant has been running daily and services maintained as usual. The weather during the latter portion of the month has been very ~~severe~~ ^{Severe} and was responsible for a large number of minor faults and breakages, but no serious breakdown occurred.

I have inspected the positions indicated for proposed extra public lamps in Colley St. Monkton Row, Upper & Lower, Summer Hill and Upper Strand Street, and have submitted for your consideration estimates for carrying out this work on wooden poles and alternatively on steel poles

In the event of the work being carried out I would recommend steel poles be used. In company with Messrs Turner and Dalby

I visited the proposed new positions for lights on North Quay and I am of opinion that the removal of existing lights to the points indicated would be a distinct advantage supplying badly needed lights in Bond Street and on River Front, I submit estimate for this work also.

During the month I collected and lodged £204 : 0 : 11.

TOWNSHIP RATE COLLECTOR'S REPORT.

By your direction I attended the District Court in order to inquire what power I had under the Courts, 1926 Act, to ~~recover~~ Township Rates.

The Justice informed me this Act does not apply to Township Rate the collection of which is governed by the Town Improvements Act, 1854.

I therefore find that Warrants for recovery will be directed to me for ~~execution~~ ^{execution}, (the Guards refusing to accept) and not the Police as was the practice until about two years ago. I wish to say this decision will make the collection in many cases very difficult if not impossible.

I would request you to put the matter before the Local Government Board, as I consider the rule applying to the collection of Poor Rate should also apply to Township Rate.

Local Government Auditor's Report.

I beg to report that I have audited the Accounts of the Wicklow Urban District Council for year ended 31st March, 1926, Certified copies of the Abstracts are forwarded herewith.

An examination of the Council's Estate Rental shows that about twenty Tenants are in arrears to the extent of about three years on an average. I have informed the Collector that I propose to hold him personally responsible at the next audit should the arrears in these cases be then uncollected. I have given him a similar warning in respect of certain Tenants of the Council's Bond St. houses.

An arrangement made by the Council with a number of tenants of theirs in Strand St., has so far proved unsatisfactory by reason of the dilatoriness of the latter in making the payments stipulated ^{but} the Council have now fixed 1st March, next as the latest date for the fulfilment of their contracts by the tenants.

In connection with the Electricity Undertaking it is desirable that, as early as possible, arrangements should be made for the performance by separate persons of the work of meter-reading, account-keeping, and collection of rentals; and as a first step the keeping of Accounts should, I think, be transferred at once to the Clerk's office.

The normal contribution was not made during the year to the sinking Fund, but instead, and in partial fulfilment, a sum of £101 was transferred

thereto to redeem a parcel of the Council's stock which came on the Market. the normal contribution should be made each year henceforward

It appears that in the year 1914 the Council's Solicitor furnished the Council with his Bill of Costs which at Council's instance was then submitted for taxation, but at the Solicitor's request taxation was adjourned. The Solicitor has, I understand, acted for the Council from time to time since then, but excepting fees for his services in connection with the promotion of the Electricity Undertaking which he claimed and received he has not, in spite of repeated applications, presented his bill for services rendered by him in the interval so that at any moment the Council may be forced to answer an accumulated claim by their Solicitor covering the period of twelve years since presentation of his last bill, and that bill itself which embraced the year 1914 and some previous years. The Council would be guilty of gross negligence if they permitted this condition of things to continue, and when it is stated that it would require a rate of 1d (one penny) in the £ on the valuation of the Urban Area to produce approximately £30 (Thirty Pounds) the gravity of the omission is apparent.

I directed attention to this matter in my report of last year.

All Insurance renewal premiums have been paid to date.

The Accounts were well kept and presented for audit in a satisfactory manner.

The following Report from Mr P.H. McCarthy, B.E., re Waterworks was read:-

I have today made a further inspection of the Wicklow Reservoir and have gauged the flow in streams supplying same and also the leakage.

The flow of the streams supplying the Reservoir amounts at the present time to ~~48~~ 148,000 gallons per day. The leakage through the embankment is 15,000 gallons per day, so the net supply is ~~understand~~ 133,00 gallons per day. The population supplied is I understand 3,200 and taking 30 gallons per head per day as the requirements of the Town the total consumption would be 96,000 gallons per day, this would leave a surplus of only 37,000 gallons daily to go towards the filling of the Reservoir which at this time of the year is very little.

I may say that a consumption of 30 gallons per head per day is rather on the low side and is only secured in towns where there are up to date fittings, good water, light mains and careful inspection to prevent leakage, and if at all possible it is very desirable that an additional stream at a high level should be intercepted and conveyed to the Reservoir.

At the present time there is only $6\frac{1}{2}$ feet of water in the Reservoir and even with this depth the leakage is 15,000 gallons daily and of course it will be much greater when the Reservoir fills to top level.

The dam or embankment except the two ends is constructed of concrete the back of the wall being subdivided into chambers which were used as fillers and clean water tanks. These are not now utilised as such. The chambers were all empty and I was able to make an inspection of them. Even with this present low level of water at the Reservoir the water is coming through the concrete in many places, in fact I believe the whole of the leakage is due to this cause.

The concrete is very rough and coarse in places and obviously the gravel, sand and cement were not properly proportioned. I don't think the filling of the chambers with concrete or puddle clay would make the embankment water tight. Between the chambers there are concrete walls and even the filling of the chambers would not prevent the water from escaping through the porous concrete of the cross walls and out at the back. I believe a much better result can be obtained by injecting cement grout under a very high pressure into the concrete so as to try fill up the pores through which the water is at present escaping.

This will not cost anything near what the filling of the chambers would cost. I am also of opinion that even if there was a

probability of stopping the leak by filling the chambers there is a great risk of throwing additional weight on the foundations and developing cracks which do not at present exist.

Plastering or patching especially in the interior of the chambers would be useless. The interior of the mass of concrete must be got at.

This is work that cannot be very well done by contract and I think if you could secure the services as foreman or overseer of a man experienced in this class of work it would be most satisfactory.

Mr McCarthy was present at the Meeting and explained to the Council the condition of the Waterworks, and after careful consideration the following resolution was adopted, It was also decided for Mr McCarthy to again inspect the Waterworks accompanied by the Members of the Council on Friday next 11th instant.
