SITE NOTICE

WICKLOW COUNTY COUNCIL

In accordance with provisions of PART XI of the Planning Acts 2000 (as amended) and Part 8 of the Planning and Development Regulations (as amended), notice is hereby given that Wicklow County Council proposes:

Enhancement Works at **Raheen Public Park** (Old Par 3), Newcourt, Bray, Co. Wicklow. The proposed works involve:

- Developing 1460m of new trail of gradients no steeper than 1 in 15. The trail is to comprise of a 2m wide compacted graded stone base beneath a selected tight hoggin finish with 600mm grass verge on both sides.
- Construction of an access ramp to the new ramp at 1:15 gradient with landings every 5m
- Improving 220m of existing trail.
- Development of Woodland Planting in line with a NeighbourWood Scheme under development.
- Establishment of Wildflower Meadows in line with a Conservation Management Plan under development.
- Install concrete bases for hartecast phoenix benches to provided, spaced at a minimum distance along trail of 40m.
- Install information boards about the ecology, archaeology, heritage and geology of the area.

In accordance with Article 81 of the Planning and Development Regulations 2001-2018, Wicklow County Council had concluded from a preliminary examination pursuant to the provisions of article 120(1)(b)(i) of the Planning and Development Regulations 2001-2018 that there is no real likelihood of significant effects on the environment arising from the proposed development and that an Environmental Impact Assessment is not required.

Where any person considers that the proposed development would be likely to have significant effects on the environment, he or she may, at any time before the expiration of 4 weeks beginning on the date of publication of this notice, apply in accordance with the provisions of Article 120 of the Planning and Development Regulations 2001-2018, to An Bord Pleanála for a screening determination as to whether the development would be likely to have such effects.

In accordance with the provisions of article 250 of the Planning and Development Regulations 2001 to 2019, Wicklow County Council has carried out a screening of the proposed development to assess, in view of best scientific knowledge, if the development, individually or in combination with other plans or projects, would be likely to have a significant effect on a European site. Accordingly, Wicklow County Council has determined that the proposed development would not be likely to have a significant effect on a European site.

Plans and particulars of the proposed development may be inspected or purchased at a fee, not exceeding the reasonable cost of making a copy, at Wicklow County Council, Planning Section, Council Buildings, Wicklow Town, Co. Wicklow during public opening hours and at Bray Municipal District Offices, Civic Offices, Main Street, Bray, Co. Wicklow, during opening hours from 9:00 a.m. to 13:00 p.m. and 2:00pm to 4:00pm Monday to Friday excluding Bank Holidays and at Bray libraries during opening hours for a period between Wednesday 15th March 2023 to Thursday 13th April 2023.

Submissions or observations with respect to the proposed development dealing with the proper planning and sustainable developments of the area in which the developments would be situated may be made in writing to the District Administrator, Municipal District of Bray, Civic Offices, Bray, Co. Wicklow on or before **noon Thursday 27th April 2023.** Submissions and Observations should be clearly marked 'Raheen Public Park Enhancement – Part 8'.
