ITEM NO. 3

To consider the disposal of 5.7 hectares (14.085 acres) or thereabouts of land in the townland of Rathdown Lower, Greystones, Co. Wicklow to Greystones Harbour Property Designated Activity Company, c/o Wicklow County Council, County Buildings, Wicklow (Deferred from meeting of 7th September, 2015)

Mr. S. Quirke, DOS advised that since this matter had been deferred from meeting of the 7th of September, 2015, he had submitted the following reports to the members of the Municipal District and Wicklow County Council.

- 1. Report dated 17th September, 2015 from S. Quirke, DOS, Transportation and Roads Infrastructure
- 2. Advice of Philip Lee Re. Greystones Harbour PPP dated 29th September, 2015.

He advised of the legal advice received in that the Council does not have the discretion as to whether or not to proceed with the disposal resolution and that failure to do so would result in a compensation event which would be a serious matter for Wicklow County Council. He also advised the Greystones Municipal District had passed a resolution at meeting held on the 28th of September, 2015 to request Wicklow County Council to proceed with the disposal of the land. It was proposed by Cllr. G. McLoughlin and seconded by Cllr. G. Walsh to proceed with the disposal resolution as circulated to the elected members dated 25th August, 2015.

Cllr. T. Fortune proposed the following, seconded by Cllr. J. Whitmore

- 1. That the parkland area in the harbor development be re-instated back to its original size and the proposal to pass land from park to housing not proceed.
- 2. In light of changes, or proposed changes, to the contract, how can we proceed with item 3 on today's agenda 5th October, 2015. I propose that we should not do this.

Cllr. J. Whitmore, outlined her concerns in relation to the disposal and put forward the following motion which was seconded by Cllr. T. Fortune.

'That there be a review of the processes involved around the disposal of land that that recommendations be put forward to the Council for approval.'

Cllr. I Winters proposed 'that the protocol committee look at the procedures in relation to disposal resolutions and that if elected members require questions to be answered that the questions be submitted in writing so that all elected members can view the questions and the responses before voting on the disposal resolution'. This was seconded by Cllr. C. Fox.

Following a discussion on the matter within which elected members outlined their concerns in relation to the disposal resolution, Mr. S. Quirke responded by outlining the history of the matter contained in report dated 17th September, 2015 previously circulated.

In relation to a section 183 notice not being brought forward when the contract was signed he explained that this was because the land did not exist at the time as it was in the sea and that the land the subject of the disposal resolution had been reclaimed from the sea. He advised that the membership of the Special Purpose Vehicle company had been approved by the elected members in January 2005 however the company was not formed at that time as the development had stalled and therefore was not necessary at the time.

In relation to the proposal that the parkland area be retained, he explained that this was not an option as the development as approved by An Bord Pleanala included that land and the Council is legally required to transfer the land on which the residential properties are to be constructed. He referred to the legal advice received from Philip Lee Solicitors advising that the Council is required to dispose of the lands on which the houses are to be constructed which was also confirmed by the Council's Law Agent.

Following clarification given on the legal and financial implications for the elected members the proposals put forward were put to a vote.

To receive presentation on Ireland's Ancient East from Ms. Orla Woods, Failte Ireland

Ms. Orla Woods, Failte Ireland, made a presentation to the members covering the following areas:

- Introduction

- Great Escapers
- Defining Ireland's Ancient East
- Believe in the brand
- · Interest from tour operators
- Brand development strategy
- Strategic Development Plan with OPW

Elected members made the following contributions:-

- Ireland's Ancient East described as a wonderful idea and concept, however query as to how much of County Wicklow is included and is there a starting and end predetermined route?
- Call for Failte Ireland to uncover the hidden gems of County Wicklow and concern expressed that County Wicklow has underachieved in the area of tourism.
- The benefits of the Wild Atlantic Way welcomed and the same can apply to Ireland's Ancient East if it is marketed and sold properly.
- · What attractions is Failte Ireland working with in the provision of new signage for Ireland's Ancient East
- · What can County Wicklow do to alleviate pressures because of its close proximity to Dublin
- Wicklow has very poor average stays of probably less than 1.5 nights per person and efforts need to be made to increase this average.
- A segment of the market that is missing out for County Wicklow is the outdoor recreation sector and the young and vibrant youth sector that uses County Wicklow for outdoor recreation. This needs to be capitalised on.

In response to the queries raised Ms. Woods outlined that tour operators had identified a capacity issue in the Dublin area and that a number of operators were considering doing the reverse of what has been happening in the past in that they will be considering the concept of staying in County Wicklow and day tripping to Dublin. In relation to signage Ms. Woods advised to put it into context, the Wild Atlantic Way was in its fourth year, whereas Ireland's Ancient East was in year zero. She advised that the success of the Wild Atlantic way is that people and industry/businesses got involved and made it their own. Failte Ireland can only provide the supports and the marketing to assist communities help themselves and the Wild Atlantic Way has shown how an initiative can be successful and it is believed that it can be replicated on this side of the country also. In conclusion the Cathaoirleach and elected members expressed their appreciated to Ms. Woods for presenting to the Council

To consider the Chief Executive Report on the Draft Development Contribution Scheme and consider the adoption of Draft Development Contribution Scheme

Chief Executive's report on submissions received on the draft S48 Development Contribution Scheme, 2015 was circulated with the agenda.

Des O Brien, DOS advised that no submissions had been received following advertisement of the Draft Scheme and that the recommendation of the Chief Executive is to proceed with the amendments proposed therein as follows

- 1. Allow for the extension of the 20% reduction/refund in Development Contributions until January 2018 as set out in S4.11 of the scheme.
- 2. 100% reduction in Development Contributions for film studio infrastructure set out in table 4.3
- 3. Consolidate the four existing schemes
- 4. Remove any water or wastewater structures, as it is no longer relevant to Wicklow County Council

Cllr. P. Casey proposed the following which was seconded by the Cathaoirleach, Cllr. J. Ryan and agreed

'That Wicklow County Council makes a submission to the Minister for Finance to support submissions made by the film industry to:

- 1. Increase the 'per project' cap from €50m to €100m on 'all qualifying expenditure', to enable Ireland to compete on a level playing pitch with the U.K. for 'tent-pole' big budget movies.
- 2. Extend the 2020 'sunset date' to 2026, providing a 10 year period of certainty, for investors in capital intensive new film studio infrastructure'.

Following a brief discussion on the matter it was proposed by Cllr. P. Casey, seconded by Cllr. J. Brady and following a roll call it was agreed by a margin of 25 votes for, 1 against and 6 not present to adopt the draft S48 Development Contribution Scheme, 2015 viz:-
