Mr. Kevin Scanlon, Municipal District Engineer, gave a power point presentation to the elected Members in relation to the Project. Ms. L. Gallagher, Meetings Administrator advised the elected members in relation to paragraph 37 E (6) in that 'the members of the planning authority may by resolution decide to attach recommendations specified in the resolution to the report of the authority, where the members so decide those recommendations (together with the meetings administrator's record) shall be attached to the report and submitted to the Board'

Elected Members expressed the following views which were responded to by Mr. Kevin Scanlon.

- Scheme welcomed and costs noted
- Submission of the Scheme to An Bord Pleanala fully welcomed and supported by the Elected Members.
- Query as to how the tunnelling works will effect residents?
- Monitoring of Emissions request that information be provided realtime or on line so that Agencies can have access to it.
- Request for information in relation to the Flood Defence Scheme and how it interacts with the Waste Water Treatment Plant Project
- At what stage will future Planning Permissions be signed having regard to the new scheme?
- Concern expressed in relation to the impact traffic diversions will have on motorists and view expressed that communication is key. This is a major concern for business people and residents of Arklow.
- Request for a meeting to be arranged in Arklow in relation to the serious traffic implications.

Mr. Sean Quirke, Director of Services responded to the issue of disruption to traffic and advised that there will be a communication plan in place as well as a traffic management plan, which he

described as hugely important. In relation to the flood scheme he advised that this will be a separate process.

At the conclusion of the discussion the Meetings Administrator called for a proposer and seconder to any formal resolution under Paragraph 37E (6) of the Planning and Development Act, 2000 as amended in respect of which there were none.

ITEM NO 11

Ms. L. Gallagher advised that the following consideration of the draft policy at Council meeting held on Monday the 2nd of July, 2018, the five municipal Districts had considered same and recommended for adoption as set out in the report of the 31st of October, 2018.

Baltinglass MD:

Agreed to recommend adopting the policy with the removal of the last part of the sentence in paragraph 7.4 page 4. (set out in red)

Wicklow MD:

Agreed to recommend the adoption of the policy as recommended by the Baltinglass MD <u>Arklow MD</u>:

Agreed to recommend the adoption of the policy without amendment

Greystones MD:

Agreed to recommend the adoption of the policy without amendment

Bray MD:

Agreed by a margin of 5 votes to 3 to recommend the adoption of the policy without amendment.

- Cllr. J. Behan proposed that major housing development in general consisting of 20 or more housing units, page 4 paragraph 7.6 be increased to 100. This was subsequently reduced to 50 units and seconded by Cllr. M. Kavanagh.
- Cllr. S. Matthews proposed that the policy as agreed at Bray MD be adopted seconded by Cllr.
 J. Walsh.

ITEM NO 12

To consider Chief Executive's Report, October 2018.

The Elected Members were circulated with the Chief Executive's Report for October 2018. The Chief Executive presented on the main highlights of the report for the month of October covering the following areas:- Funding received under the Town and Village Enhancement: Blessington €80,000; Hollywood €29,757; Newcastle €23,760; Newtownmountkennedy €120,488; Rathdrum €68,000; Tinahely €76,000; Wicklow Town €120,000: Total €518,005.

The Chief Executive also advised that planning will begin at Municipal District level to submit projects and apply for funding in the following year. He advised that there is an extra €318,000 for Local Improvements schemes and €500,000 for road improvements/weather damage in addition to the €600,000 payment for overtime incurred during the severe weather event. He referred to other areas of activity such as the Food Strategy for County Wicklow and the commencement of the County Wicklow Commuter Survey and that contracts are due to be signed with Arup Consulting Engineers for Junction 4, N11/M11 along with three new contracts for the development on playgrounds at Annacurra, Laragh and Roundwood. The Chief Executive mentioned that the Regional Spatial and Economic Strategy had gone on display this morning and paid tribute to the Cathaoirleach and Wicklow County Council members of the MERA for raising the issues of concern for County Wicklow and having secured improvements in the Strategy for County Wicklow around the areas populations targets, M11/N11, LUAS extension to Fassaroe, N81 Tallaght and other enabling infrastructure development proposals to be addressed in the draft strategy. The Elected Members welcomed the information contained in the report.

ITEM NO 13

To approve an overdraft accommodation of €20m for the financial year ending 31st December, 2019.

Elected Members were circulated with a letter from Mr. Brian Gleeson, Head of Finance requesting the approval of an overdraft accommodation of €20m for the financial year ending 31st December, 2018. It was proposed by Cllr. S. Bourke, seconded by Cllr. E. Timmins and agreed to approve an overdraft accommodation of €20m for the financial year ending 31st December, 2018.

At the conclusion of the presentation the issues and queries raised by the elected members were responded to. The issue of 'local access only' was raised in relation to residents in particular areas find themselves trapped in their houses when 'snow tourists' visit the area and abandon their vehicles, thereby blocking the roads. Elected Members also asked if there could be further distribution of sand and gravel to specific locations where there may be elderly and vulnerable people living.

Question submitted by Cllr. J. Whitmore:

Has Wicklow County Council had any discussions with stakeholders or the Department regarding the purchase of lands at Luggala?

Cllr. J. Whitmore advised that the Estate is for sale at €28m but that the proposal from Mountaineering Ireland and the National Parks is that the area proposed for recreational and tourism is smaller and estimated at around €2m. Cllr. Whitmore also mentioned the impact on the sale on the film industry. She made the following proposal: That Wicklow County Council writes to the Minister and request that the State acquire the uplands surrounding Luggala Estate in County Wicklow for the public's recreational use and that it be incorporated into the Wicklow National Park.' Cllr. Whitmore also requested that this letter be sent to Minister for Culture Ms. Josepha Madigan, Minister for Community Development Mr. Sean Kyne and also the Irish Film Board. This was seconded by Cllr. S. Matthews and agreed.

The Chief Executive advised that the Council had received written correspondence from Mountaineering Ireland in relation to the State purchasing the property, and that the State has appointed Planning Consultants in the matter which both he and the Director of Planning, Mr. Sean Quirke would be meeting with.
