### Item No. 24 Notices of Motion

# 1. Notice of motion in the names of Cllr. Christopher Fox and Cllr. Jim Ruttle (12<sup>th</sup> March 2018).

'That this Council would consider during extreme weather events designating certain roads as "Local Access Only". Inappropriate parking, car journeys and car abandonment during the recent snowfall severely impacted the council clearing our road network and in some cases delayed residents getting out of their homes by a number of days. The designation of Local Access Only should be done by way of bye-law if necessary'.

## 2. Notice of motion in the name of Cllr. Edward Timmins (10<sup>th</sup> May 2018).

That all betting advertising, online betting websites and over the phone betting come with a warning of the dangers of gambling, that it is addictive and may lead to serious financial difficulties. In addition that monthly statements be sent to all people who hold betting accounts. That this be communicated to the relevant minister".

### Notice of motion in the names of Bray Municipal District Elected Members (22<sup>nd</sup> May 2018).

"That Bray Municipal District condemns the decision by Wicklow County Council to exclude the Sa Bhaile organisation from providing future support for homeless people in North Wicklow having encouraged them to extend their remit to include North Wicklow in recent years. That the Director of Housing meet with Sa Bhaile and that the Members call on Wicklow County Council to reconsider this matter urgently".

### 4. Notice of motion in the name of Cllr. J. Behan (14<sup>th</sup> May 2018).

"That this Council joins with colleagues around the country in demanding that the Government reverse its decision to take Versatis Pain Relief patches from over 25,000 Irish citizens suffering from chronic pain."
