1. Notice of motion in the names of Cllr. Christopher Fox and Cllr. Jim Ruttle (12th March 2018).

"That this Council would consider during extreme weather events designating certain roads as "Local Access Only". Inappropriate parking, car journeys and car abandonment during the recent snowfall severely impacted the council clearing our road network and in some cases delayed residents getting out of their homes by a number of days. The designation of Local Access Only should be done by way of bye-law if necessary".
