'This Council calls on the Tanaiste and Minister for Social Protection to abandon the plan to phase out lone parents payments once children reach seven years of age. Some 11,000 lone parent families have already been affected by these gradual reductions. Further reductions will impact on 32,000 lone parent families in July this year, pushing families further into poverty. It is noted that the Tanaiste had previously make commitments that there would be affordable and accessible childcare before the reduction payments and that to date Ireland has one of the highest childcare costs in the OECD meaning more families will be pushed into poverty when there has already been a notable rise in child poverty over the last five years'
