 Notice of motion submitted by Cllr. M. McDonald, in the name of Sinn Fein Group (14<sup>th</sup> November 2016). "That Wicklow County Council calls on the government to abolish household water charges and fund investment in water and sanitation infrastructure through progressive taxation".
