**1 Notice of motion in the name of Cllr. G. Dunne (2nd November 2017).**

*"That Wicklow County Council provide the Members with a detailed report on the Coastal Erosion that has occurred over the last numbers of months at The Murrough, Wicklow Town. Furthermore, provide the Members with details of the proposed plan of action and timeframe to further remediate and maintain the coastline in this area".*
