4. HOUSING SUPPLY - PROGRAMME OF DELIVERY

Update on Kilbride Lane Social Housing Scheme, Bray, Co Wicklow

Following a number of consultations with Wicklow County Council and others and a number of separate appearances before the High Court over the past number of weeks, MDY Construction Limited exited the Examinership process with effect from 15th November 2018 when the High Court approved the Scheme of Arrangements proposed by the appointed Examiner. This occurrence has facilitated Wicklow County Council in withdrawing the termination notice previously issued to MDY, which in turn will allow MDY to complete the works at the Kilbride Lane 42 Unit Social Housing Development in Bray.

Negotiations ongoing with a number of developers at preplanning and planning stage. There are over 100 Part V units with planning permission but it's difficult to determine whether they will all proceed or even on what timescale.

6. PPP SOCIAL HOUSING PROJECT

[Bundle 1)

Development Site at Convent Lands, Wicklow for 51 Social Housing units. The Department of Housing

has dedicated €300 million towards delivery of housing through the public, private partnership model in the Rebuilding Ireland Action Plan. Wicklow has been included as a project in Bundle 1. The Part 8 was passed by the members at the Council Meeting of 3rd July 2017. The project is expected to commence on site in December 2018.

7. APPROVED HOUSING BODIES (AHB'S)

Capital Advance Leasing Facility (CALF) - 5 units were provided under a CALF lease to Co-operative Housing on the Greenpark Road in Bray.

6 apartments (Abbey St. Wicklow) purchase not yet completed. Tuath *AHB working to complete purchase as soon as possible.*

Approval has been received from the Department of Housing, Planning Community and Local Government for a leasing arrangement with Cluid to provide 45 units of accommodation on the Council's site at St. Earnan's View, Ballybeg, Rathnew. It is anticipated that works will commence in 2019.

The Approved Housing Bodies are actively pursuing a number of other potential CALF projects and are liaising closely with the Council on a regular basis. The members will be kept updated.

Capital Assistance Scheme (CAS) Purchase has been completed on 3 properties with Dublin Simon under the Capital Assistance Scheme in 2018 and 2 further properties have been agreed with Ark Housing. These properties will be allocated to households experiencing homelessness.

Expressions of Interest – Social Housing on Council lands - A preferred proposal has been identified.

8. HOUSING SCHEMES REMEDIATION

Glending, Blessington - Remediation

Stage 2 and Stage 3 Phase 3A – No 1 to No. 12 Glending Road have been completed.

Stage 3 Phase 3B – No. 1 to No. 10 *Glending Square and No. 1 to No. 4 Glending Way* – Contract commenced on 3rd January 2018 with internal works to 1-10 Glending Square complete. . External works on these properties substantially complete on 1 – 8 with tenants to re-occupy in the next 2 weeks. Internal and External works on 1-4 Glending Way are substantially complete.



Hillview, Wicklow - Remediation

Works substantially complete, with some outstanding ceiling works ongoing.

Homeless HAP

The recent appointment in October of the Homeless HAP Placefinder is seen as a welcome and necessary addition to the Homeless Team.

The Homeless HAP Placefinder will provide assistance in:

- seeking out potential properties suitable for households currently identified as homeless or at risk of homelessness:
- liaising with specific households to establish their specific needs;
- establishing relationships with local property agents and landlords; and,
- supporting those homeless households to (a) prevent the necessity to enter emergency accommodation or (b) to exit emergency accommodation and secure a tenancy.

16 tenancies completed to date (14 families and 2 single tenancies) through the Homeless HAP Placefinder service.

<u>Sonas Facility, Wicklow</u> - Transition to Family Homeless Hub

Following the advice that Sonas was withdrawing services from Wicklow, the operation of the facility was tendered out to Approved Housing Bodies to operate and manage the facility as a Family Homeless Hub. The successful tenderer was Dublin Simon Community, who will be in a position to commence operations and management of the facility from early 2019.



The Council has provided a support worker under a service level agreement with Dublin Simon Community to assist the families to transition to alternative, suitable accommodation.

Other Temporary Supported Accommodation

Wicklow County Council owned properties in Wicklow, Bray and Arklow, leased to AHBs, provide 22 units of low to medium supported accommodation targeted to the particular support needs of the clients. There has been a significant number of moveons from these properties, signalling the success of this model.

Housing First

With Housing First, the priority is to support a person who has experienced homelessness into permanent housing as quickly as possible, without any preconditions around sobriety or mental health treatment. Then, continue working intensively with them on these issues once they are housed. Housing First recognises that a stable home provides the basis for recovery in other areas.

The National Implementation Plan for Housing First 2018-2021 was published in September 2018. It commits to the rollout of Housing First in every county in Ireland and sets annual targets for each local authority. It also highlights the need for local authorities and Approved Housing Bodies to work together on increasing the supply of single person housing. The alignment of housing and health supports means that Housing First is very much a joint initiative of the Department, the Department of Health, local authorities, HSE and NGO providers.

Wicklow County Council is committed to implementing the Housing First model and is currently liaising with Kildare and Meath County Councils to prepare tender for services.

In advance of this and to ensure robustness of numbers, an analysis of rough sleepers in County Wicklow is being undertaken which will inform the plan.

Cold Weather Initiative

A property in Bray was identified as suitable to implement a Cold Weather Initiative and the facility opened its doors to homeless individuals in December. The initiative is a partnership arrangement between Dublin Simon Community,

Wicklow County Council and the Five Loaves Homeless Services.

11. SOCIAL INCLUSION COMMUNITY ACTIVATION PROGRAMME (SICAP)

SICAP

Bray Area Partnership and Co. Wicklow Partnership submitted their 2019 SICAP Annual Plans to the LCDC. These were approved at December meeting.

Both Partnerships are currently completing their 2018 actions and ensuring all targets are reached by year end, with a view to completing their end of year report by mid January.

Public Participation Network (PPN)

Elections took place to renew all PPN positions on Strategic Policy Committees (SPC's), Committees and Boards throughout the county. The newly appointed reps will hold their seats for the next three years.

Wicklow PPN will be holding interviews in January for the new position of PPN Support Worker.

12. County Wicklow Library Service

BOOK OF KELLS

Wicklow County Council has recently acquired a valuable edition of the Book of Kells. The work was carried out by John De Paor and entrusted to Ashford Heritage Centre. The book will be on display in Arklow library, in a specially designed display case. The launch of this will occur on Tuesday 22nd January in Arklow library at 7.30 p.m.

WICKLOW LIBRARY AND ARCHIVES

Extra finance has been secured from the Urban Regeneration Grants Scheme for Wicklow Library and Archives. This is part of overall grant aid for development of the Market Square area of Wicklow Town. The project will now go to tender, with a likely commencement construction date of April 2019. The library and archive will be completed within 10 -1 2 months, so the new library & archives should be open in early 2020.

MOBILE LIBRARY

The new mobile library is now being designed. Chassis has been ordered, with an expected arrival



date of 21st January 2019. The new vehicle will be with Wicklow County Council by late summer 2019. The current vehicle has travelled more than 400,000 km since 2004.

BALTINGLASS LIBRARY

It is planned to relocate the adult library in Baltinglass into the former courthouse part of the building. This work is being carried out in line with developments in restoration of the prison cells and creating a new visitor experience in the heritage centre. The courthouse building was restored in recent years and is very welcoming, with lots of natural light. The court features will be retained, including the witness boxes and the judge's bench. This will be at minimal cost, as the current library shelves and furniture will be relocated to the court room. This work will commence in the New Year and should be completed in spring 2019.

RATHDRUM LIBRARY

The opportunity has arisen to acquire a new library building for Rathdrum in the new market square development. It will be a ground floor building of approximately 130 square metres in size, adjoined to a coffee shop and pharmacy. The new HSE primary care development will be the anchor tenants in the development. It is envisaged that the building will be leased initially, with an option to purchase being retained for up to 5 years.

The current library in Rathdrum is less than 40 square metres in size, but is very well used. It is anticipated that usage will double in the new location, ensuring that in excess of 20,000 items per year will be borrowed. The new location will also complement other businesses in the town. Libraries are proven to provide a steady footfall to a location, so this should be of benefit to all. The building is likely to be completed in autumn 2019.

TECHNOLOGY GRANTS

Wicklow County Council has received €190,000 in grant aid towards technology that will be available in libraries throughout the county, being 75% of total costs of €254,000. The full range of technology was chosen in consultation with Wicklow County Council IT Section. This will include microfilm readers and Hublet stations, which provide additional laptops for

use in each library. As part of Wicklow County Council's "Dementia Friendly" policy, Dementia Tables will be available in Arklow, Blessington and Bray libraries. Other technologies will also be available, including an upgrade in PC's across the county.

13. COUNTY WICKLOW LOCAL SPORTS PARTNERSHIP (LSP)

Sport Capital Grants 2018 Breakdown Wicklow has submitted 79 Local and 3 Regional Applications under the 2018 Sports Capital Grant process.

Russborough parkrun celebrated its 1st anniversary on 1st December 2018. 44 parkruns have taken place to date in Russborough benefitting 1,540 people.

The Nationwide Operation Transformation 2019 advertisement poster is using Bray's 2018 walk as its background. Walks in 2019 are taking place on Saturday 12th January on Bray Seafront, Baltinglass GAA and Blessington.

AGE AND OPPORTUNITY FUNDING

Wicklow Local Sports Partnership received an allocation of €1,400 from Age and Opportunity to run their Go for Life Programme. In 2019 this funding will go towards two Go for Life Taster days, one in the East of the County and one in the West which will result in a County Wicklow Go for Life Team that will be attending the National Go for Life Games in DCU in June.

KATIE TAYLOR BURSARY

A total of 16 applications were received for the Katie Taylor Bursary 2018/19. A presentation was made to the successful applicant Amy Wall on 13th December 2018. Amy has distinguishing achievements in Kickboxing and Boxing.

CORAL LEISURE ARKLOW

Coral Leisure are currently refurbishing the Arklow Gym area and upgrading the gym equipment.

WICKLOW HOSPICE

Wicklow Hospice Foundation is displaying the model of the new Hospice in the reception area of the County Buildings from December to February 2019.

14. LOCAL ECONOMIC AND COMMUNITY PLAN (LECP) (COMMUNITY)

LECP

The Advisory Group is continuing to monitor the implementation of the LECP, both the community and the economic actions, and to ensure the integration of economic and community actions.



ECONOMIC DEVELOPMENT, PLANNING AND INFRASTRUCTURE

1. WICKLOW ECONOMIC THINK TANK (CWETT) ACTION PLAN/LOCAL ECONOMIC AND COMMUNITY PLAN (LECP) (ECONOMIC)

The Economic Development Unit of the Enterprise and Corporate Services Directorate is charged with implementing the economic actions in the Local Economic and Community Plan (LECP). Many of the 142 actions listed in the LECP have come from the County Wicklow Economic Think Tank (CWETT) Action Plan. The CWETT which was initiated in 2013 was a collaborative project initiated by Wicklow County Council and involved the business community from across the county and the County Enterprise Board (now LEO Wicklow).

FILM

The application for Regional Enterprise Development Funding (REDF) for a Screen Content Enterprise Hub for Wicklow County Campus was not successful. It is proposed to submit a revised application when the call for proposals reopens (circa May 2019) based on feedback recently received from Enterprise Ireland.

Wicklow County Council is in the process of developing a Masterplan for Wicklow County Campus, to complement its use as a Screen Content/Film hub.

RETAIL

The Florentine Centre

Work is well underway on the Florentine Site which is due to be completed this year. The contractor and developer continue to liaise with local residents and adjacent businesses.

TOWN TEAMS

Town Teams in Arklow, Blessington Greystones and Wicklow continue to meet on a monthly basis and to progress various projects.

Four County Wicklow Towns; Arklow, Bray, Roundwood and Wicklow participated in the Bank of Ireland Enterprise Towns Competition. This was an excellent opportunity for the towns to showcase their enterprising spirit and passion for each town and to show a mix of commercial and social enterprises and to demonstrate the great community spirit and talent that exists in our towns. All participating towns put in an excellent effort.

Arklow and Bray received awards

Arklow was awarded the Town Initiative prize which seeks to reward a specific project and brought with it a prize of €5,000. This was awarded for Arklow's Town of Garden's Theme.

Bray won a runner-up prize in their category, receiving an award of €1,000. Bray Chamber of Commerce and Bray Municipal District and members of the community including businesses all worked together to present the many interesting facets of Bray to the judges.

Over 90 entries were received altogether for this national competition which had a prize fund of over €157,000.

URDF Funding

Wicklow applied for funding for 9 projects under the Urban Regional Development Fund

The following 3 projects were awarded funding in the first round;

Arklow Historic Town Core €1,645,000

Redesign of public realm within historical centre of Arklow: enhanced landscaped public space, reduced parking, bicycle parking, enhanced bus stops.

Renovation of existing courthouse to make proper provision for the court services and to provide a digital hub space

Wicklow Library/ Fitzwilliam Sq. €1,626,000

The new modern public library facility will function as a communication hub and will incorporate Wicklow County Archive, Genealogical Services and Local Studies facility accessible to all.

Create a multi-functional space within Wicklow Town that would improve accessibility, enhance the presentation and public realm of the Town Centre at Fitzwilliam Square.



Bray Public Transport Bridge €3,450,000

A new Public transport Bridge over the River Dargle which will provide an essential link between development lands at former Bray Golf Club and DART Station.

It should be noted that these projects have planning approval and will start as early as possible in 2019.

TOURISM

Tourism Strategy and Marketing Plan 2018-2022

The strategy sets out a number of challenging but achievable priorities along with a series of detailed actions to be implemented over the next 5 years

The Key Priorities are

- 1. Develop New Accommodation
- 2. Develop Key Towns as Visitor Hubs
- 3. Develop a Masterplan for Glendalough
- 4. Grow Thematic Experiences
- Market our County by Developing A Common Narrative

A Tourism Implementation Group is being established to oversee these actions and drive all sectors towards helping Wicklow achieve the target of £200m in tourism revenue by 2023.

Next steps implementation – potential members of working groups identified a series of meetings will be held in January to address;

- Accommodation
- Towns as Visitor Hubs
- Thematic Experiences
- Marketing /Developing a common narrative
- Glendalough

Glendalough

The Chief Executive is chairing a working group consisting of representatives of Failte Ireland, NPWS, Coillte and OPW, aimed at progressing the development of Glendalough as one of Ireland's premier visitor destinations. The aim is to enhance the visitor experience through improved interpretation, signage, facilities and access.

MARITIME

National Marine Planning Framework

Wicklow County Council and the members of the Maritime Business Development Group made a submission to the Department of Housing, Planning and Local Government in respect of a Marine Spatial Plan for Ireland.

Maritime Strategic Review for County Wicklow

Tenders were invited from consultants to develop a Maritime Strategic Review for County Wicklow.

The intent of the strategic review is to provide non-statutory guidance for uses and activities within the marine area and to assist Wicklow County Council and other statutory agencies with their policy formulation process as well as providing Wicklow County Council with a clear picture of its maritime area so that it is in a position to respond and provide input to higher level policy, where necessary. The Strategic Review will identify ways the economic base of County Wicklow could be strengthened through its ports and harbours and formulate recommendation for Wicklow County Council.

This tender will be re-advertised in January.

COMMUTER SURVEY

A Commuter Survey was carried out during the first two weeks of November with the aim of capturing the current level of commuting and the opinion of those commuters. Wicklow County Council will use this information to encourage the development of facilities such as enterprise hubs, co-working spaces and second sites, to attract further investment into the county.

As the Survey was targeting commuters, online and social media advertising was used to encourage a greater response. For drivers, signs were erected along the M11 advising motorists to log on to the Wicklow.ie website to have their say.

Over 6,800 responses were received, this represents almost a third of persons commuting which is a very favourable response rate.

- 6,826 people completed the commuter survey during the two-week period from November 5th 2018 to November 18th 2018.
- 74% of those who completed the commuter survey reported themselves as unhappy or very unhappy with their commute, while only one in eight was happy or very happy.



- 70% of commuters who work outside County Wicklow said that they would be likely or very likely to consider switching to a job in County Wicklow if one were available and 33% said that they would be likely or very likely to consider a lower salary if it meant they could work in County Wicklow.
- Survey respondents were receptive to the idea of remote working, with 48% saying that they would be likely or very likely to consider working from an e-hub location in County Wicklow.
- The unhappiest commuters are those who travel by road, either as car drivers, car passengers or by bus. People who leave home before 8:00 or travel for more than 45 minutes are also likely to be dissatisfied with their commute.
- Commuters who are educated to third-level or higher as well as those who work in the

IT, Finance & Creative sectors are also likely to be unhappy with their commute.

- 37% of those who completed the commuter survey were working in the business or financial sector.
- The commuters most willing to consider working in County Wicklow are those who travel by motorcycle/scooter or by train/LUAS. A commute that starts before 7:00 or lasts for more than an hour also increases the chances that a person would prefer to work in County Wicklow.
- The industries most open to remote working are IT and Finance, especially for those educated to third level or higher.

The new Training programme for Spring/Summer 2019 has been finalised and information booklets printed and will be circulated directly to LEO Clients and to the general Public via Wicklow County Council Offices, Libraries, Citizens Information offices and social welfare offices throughout the county in early January.

The Ireland Best Young Entrepreneur Competition 2019 run by the network of Local Enterprise Offices is now open for entries at www.ibye.ie Entries are sought from Entrepreneurs between 18 and 35 years in three categories, Best Idea (Pre trading), Best Startup Business (trading for under 18 months) and Best Established Business (18 months Plus). A prize fund of €50,000 is up for grabs in County Wicklow.

Department of Culture, Heritage and the Gaeltacht. Consultation document circulated to members of Wicklow Heritage Forum for input and discussed at meeting on 5th Dec. Closing date for submissions end of Feb 2019.

Built Heritage Investment Scheme (BHIS) and Historic Structures Fund (HSF): The council has advertised grant funding under each of these schemes with closing dates 25th Jan and 31st Jan 2019 respectively. Owners of protected structures and other relevant buildings are eligible to apply. SCHEMES ON THE N81

N81 Annalecky and Poulaphuca Crash Barriers

RPS Consulting are the Design Consultants for this commission. They have been appointed PSDP + Design for the works. The works involve the provision of a Crash Barrier at Annalecky Bend which has no crash barrier and the provision of a replacement barrier on the Wicklow side of the Poulaphuca Bridge. Barrier repairs along the N81 between the Wicklow County Council/Carlow County Council border and the Wicklow County Council South Dublin County Council border are included. RPS is

collating information supplied by Wicklow on barrier defects at this time. A tender competition for all of the works should be held later in the year. All information required has been transferred from Wicklow County Council to RPS Consulting.

• N81 Knockroe Bend Realignment

Tender Documents were published at the beginning of October and are currently being assessed, it was anticipated that the contract for the main works will be awarded in December, but unfortunately further information was required, and tender award will be in January 2019, and works to commence on site in the first quarter of 2019.



The tender for the consulting contract for phases 5 and 6 are currently being reviewed, this will cover the construction contract and hand over, and again awarding of the tender for the consultant will also be in January 2019.

• N81 Small Scale Projects

The Roads Office received approval from TII to progress all four schemes in accordance with Phases 1 to 4 of the TII Project Management Guidelines (PMG) which include:

The project will be subject to various stages of planning, design and approval as well as public consultation. A Public Information Day was held on the 11th December in the Glenview Hotel. • N11 Kilmacanogue Parallel Service Road

Tender documents will be issued to contractors for the works on the construction of the new parallel service road in Kilmacanogue in December and the works are anticipated to commence during the first quarter in 2019.

WINTER MAINTENANCE

The Winter Maintenance 2018/2019 Season commenced on 16th October. During October, 23 call outs were made and approximately 103 tonnes of salt was used over the 9 individual routes across the County.

LOCAL IMPROVEMENT SCHEME

Wicklow County Council have been allocated a further €358,135 in funding for Local Improvement Schemes in 2018. Works commenced on 9 schemes in Greystones, Bray, Arklow, Wicklow and Baltinglass Municipal Districts.

5. I.C.T. REPORT

IT HELPDESK

- Workflow analysis of the IT Helpdesk function facilitated development of a proof of concept for customer care & case management systems. The initial deployment was a cloud based open source platform customised by staff in the Technical Support Unit.
- During 2018 more than 7,800 tickets were handled by the system. Heat mapping of issues arising has allowed development of a knowledge database which is in daily use.
- During 2018 the Asset Management Module of the ticketing system was deployed to allow performance monitoring across the network and prepare a strategic deployment model for ICT Infrastructure. This allowed preparation of an upgrade schedule for the PC estate.
- A Mobile Device Management (MDM) system is in place for all new mobile devices since Summer 2018. Roll out to existing estate commenced at that stage and continued through to the end of year. This system facilitates focus on data and information security

CUSTOMER RELATIONS MANAGEMENT (CRM)

- Business Process Modelling in the Housing & Environmental Services Departments were used for preparation and development of customer care unit proofs of concept.
- An initial implementation of Office 365 is in place and a "Sandbox" was created on Wicklow's Cloud Tenancy. This platform will be used for in-house development and testing purposes and will form the basis for development of organisational cloud strategy
- Microsoft Dynamics has been used to develop customer care initiatives in a number of departments and will be used to integrate to mobile data collection systems in HR, Transportation and Environmental Services directorates.

MANAGED PRINT SERVICE (MPS)

 Renewal of MPS is complete following vendor neutral print audit and RFT of December 2017.



- Project roll-out plan was completed in 2018 and all new devices have completed two full quarterly cycles.
- Full device utilisation and support centre analysis took place with the supplier in Q4 2018 with a view to ensuring continuous review and strategic management of all devices
- Managed Print Service policy is in place for all departments & MD's

UNIFIED COMMUNICATIONS

- Voice over IP phone solution has been extended to most Council sites across Wicklow. This includes Municipal Districts and other sites such as Clermont Campus, Fire HQ and Library HQ.
- The VOIP system will underpin county wide communications, improved customer services and unified communications.

CORE NETWORK

- Procurement of core and edge network hardware refresh is complete and Phase 1 of LAN upgrade was implemented in Q1 2018. Extension to other sites including Bray MD, Fire HQ, Library HQ, Clermont was completed during Q2 2018.
- A fully updated core network is now in place.
- Network traffic analysis and load balancing has informed update of virtual infrastructure and change

- from copper to fibre for connections to core network. This work is on-going.
- Business case for connection to government networks and government cloud networks is underway and will be advanced during Q1 2019.

DATA COLLECTION SYSTEMS

- Data collection systems using mobile devices are currently in place for Register of Electors Fieldworkers. Currently 94.25% of Electors have an assigned EIRCODE.
- Projects in Housing, Roads and Environmental Services departments are on-going and integration to CRM systems is being developed.
- A new project to update and edit Wicklow's Storm Water Network more effectively is underway and includes off site data collection.
- Revenue Collectors Handhelds have been upgraded to Tablets to allow more efficient data transfers to the financial management system.
- Offsite data collections systems have been consolidated and applied to Housing Condition Surveys, Health & Safety Audits, CCTV surveys etc.


