6. PPP Social Housing Project

[Bundle 1)

Development Site at Convent Lands, Wicklow. The Department of Housing has dedicated €300 million towards delivery of housing through the public, private partnership model in the Rebuilding Ireland Action Plan. Wicklow has been included as a project in Bundle 1. The Part 8 was passed by the members at the Council Meeting of 3rd July 2017.

7. Approved Housing Bodies (AHBs)

Capital Advance Leasing Facility (CALF) - 5 units were provided under a CALF lease to Co-operative Housing on the Greenpark Road in Bray.

Approval has been received from the Department of Housing, Planning Community and Local Government for a leasing arrangement with Cluid to provide 45 units of accommodation on the Council's site at St. Earnan's View, Ballybeg, Rathnew. Estimated delivery date of these units is quarter 3 2019.

Capital Assistance Scheme (CAS) The CAS call for 2017 has been recently advertised.

Expressions of Interest – Social Housing on Council lands - A preferred proposal has been identified.

8. Housing Schemes Remediation

Glending, Blessington - Remediation

Stage 2 and Stage 3 Phase 3A – No 1 to No. 12 Glending Road has been completed.

> Stage 3 Phase 3B - No. 1 to No. 10 Glending Square and No. 1 to No. 4 Glending Way - Contract has been signed and will start in New Year when all tenants have decanted.

> Tenants are currently being moved out of these properties for this phase of the development.

Parknasillogue, Enniskerry - Remediation

Remediation works completed. Legal proceedings ongoing.

Hillview, Wicklow - Remediation

Contract re. roofing to 11 blocks (44 houses) completed and now watertight. Extra works on above contract for re roofing of apartment blocks 19 and 20 (4 apartments) now started. Bridge works F Types 30% complete. Refurbishment works to B Types 90% complete. Ceiling repairs to B and C types 20% complete.

Oldcourt Energy Efficiency Scheme

Work was completed on 27 houses to the end of December 2017 with tranche 4 having started this month for an additional 9 houses with a completion date of the second week in March. The remainder of the houses – 33 – will be completed in phases during 2018.

Wicklow County Council owned properties in Wicklow, Bray and Arklow, leased to AHBs, provide 22 units of low to medium supported accommodation targeted to the particular support needs of the clients.

11. Social Inclusion Community Activation Programme (SICAP):

The negotiated process in relation to Co. Wicklow's two SICAP Lots is ongoing. The LCDC has contracted two separate consultants to work with the two Partnerships involved – Bray Area Partnership and Co. Wicklow Partnership. With support from the consultants, both Partnerships will redraft new tender documents over the next five weeks. Final submission date is 2nd March 2018.

12. Public Participation Network (PPN):

The development of Public Participation Networks (PPNs) by local authorities across the country has led to many LA's now utilising their local PPN as its first port of call to publicise news, events, public notifications.

In light of this, Co. Wicklow PPN would like to invite and encourage all staff in Wicklow County Council to contact them directly if they have any information which they feel should be shared with, or would be of benefit to, the communities of Wicklow. This may also include information about community

events/groups which they are involved with outside of work.

Co. Wicklow PPN is becoming recognised as a beneficial channel for the distribution of information generally. It produces and circulates a monthly Ebulletin full of information on events, funding opportunities, community plans, training events and public consultations to its 180 member groups (some of which are networks in their own right). Wicklow PPN also has a popular Facebook Page. A recent post about a new community initiative for older people reached 2,504 people, received 204 likes/reactions and 22 shares.

13. Wicklow Library Service

End of year statistics 2017

- Issues (items borrowed) reached a record high of 574,657 in 2017, compared with 468,373 in 2016 (22.7% increase).
- Library visits increased to 583,000, compared with 508,000 in 2016 (14.7% increase)
- There was 71,425 public internet and wi-fi sessions in Wicklow County Council's libraries in 2017, compared with 57,969 in 2016 (23.2% increase)
- The above increases are partly attributable to the restoration of full opening hours in Bray, Blessington and Greystones along with the benefit of having the new Arklow library open for the full calendar year.
- Wicklow library members borrowed 4.04 items per head, compared with a national average of 3.5



Wicklow Town Library & County Archives

Tenders were received for a lead architect for the new Wicklow library and county Archives. They are currently being assessed, with an appointment expected during February 2018.

Grant Aid

Grant aid was secured for tagging of stock and provision of state of the art self service machines under the "Right to Read" programme. Technology will be installed before end of January 2018 and the tagging will enable all stock to circulate across the country, as part of the national request service

14. Local Sports Partnership

Katie Taylor Bursary 2017

10 very good candidates were interviewed for the 2017 Katie Taylor Bursary from Wicklow County Council. *Emer Kelly of Wicklow Town was the successful applicant.* Emer has competed at national and international level in both swimming and Surf Lifesaving. Most recently she has won gold at both European and World championship events, and is now part of the elite athlete programme in University of Limerick.

Russborough Park Run

The first adult park run in Wicklow was in Russborough House, Blessington on 2nd of December. This is a free timed 5km run in the grounds of Russborough House that takes place 51 weeks of the year on a Saturday morning at 9:30am and is open to both walkers and runners alike. This project is supported by our activity leaders in the area who are part of the Tús programme with County Wicklow partnership and Healthy Ireland and is managed through the LSP.

Operation Transformation

Three walks were held in Wicklow for Operation Transformation on 13th of January. These were in Arklow, Blessington and Bray.

Economic Development, Planning and Infrastructure

1. Wicklow Economic Think Tank (CWETT) Action Plan/Local Economic and Community Plan (LECP) (Economic)

The Economic Development Unit of the Enterprise and Corporate Services Directorate is charged with implementing the economic actions in the Local Economic and Community Plan (LECP). Many of the 142 actions listed in the LECP have come from the County Wicklow Economic Think Tank (CWETT) Action Plan. The CWETT which was initiated in 2013 was a collaborative project initiated by Wicklow County Council and involved the business community from across the county and the County Enterprise Board (now LEO Wicklow).

BRAND

There was a preview of the web-portal and the brand at the Business Breakfast on 26th January it is intended to re-launch the brand in tandem with the launch of the new portal, in the coming weeks.

FILM

Wicklow County Council continues to liaise with local service providers and state agencies with regard to the development of the film industry in County Wicklow. The development of Wicklow County Campus as a Content Creation hub, with possible funding from the Regional Enterprise Development fund, is being explored.

Arising out of a visit to China, by a delegation representing Wicklow County Council and Wicklow County Tourism, the possibility of working collaboratively with Hainan Province on the development of the film industry is also being explored.

Further information has been submitted in respect of the Ashford Studios planning application

RETAIL

The Florentine Centre

By developing the Bray town centre Site at Main Street/ Quinsborough Road/ Florence Road, Wicklow County Council aims to rejuvenate the heart of the town and its environs, to enhance the retail mix to include a more diverse offering including fashion retail, to extend the trading period on Main Street and to add life and vibrancy to the Main Street area in the evenings.

Planning consent was granted to Wicklow County Council for the following:

- Two anchor stores
- 8 retail units at upper ground floor level and at first level
- · 3 restaurant units at upper ground floor level
- 3 business units at first floor level
- 5 screen cinemas at upper ground, first and second floor levels
- 256 car parking spaces at lower level with 320 cycle spaces
- Change of use of Nos. 6-7 Eglinton Road (protected structures) from residential to office use, demolition of rear returns and out buildings, construction of a glazed link extension to the rear of the structures and refurbishment of previous office use at No.8 Eglinton Road
- New urban street accessed from Main Street into the new development creating a central plaza with pedestrian access from Quinsborough Road, incorporating an events space, seating, landscaping and kiosks
- Demolition of Nos. 3 and 4 Florence Villas, Florence Road, and creating a new vehicular access for services at this location
- Demolition of No. 7 Main Street
- Demolition of the façade of No.5 Main Street.
 At the Wicklow County Council meeting of 15th
 January the members voted in favour of disposing of



the site to the developer Navybrook. It is anticipated that the contract will be signed in the coming weeks and that development will commence in quarter 2, 2018. The intention is to have the development available for December 2019.

Retail - Other

The Council and the Municipal Districts have worked with the various Town Teams and the Chambers of Commerce to support the various Christmas retail initiatives in order to encourage people to "shop local". Reports from Retail Excellence Ireland would indicate that the move towards online purchasing continues. Wicklow County Council via the Local Enterprise Office offers support and training for retailers wishing to sell goods online, it is vitally important that local retailers have an online presence.

In 2018 it is intended to further expand the Age Friendly Business Recognition programme for County Wicklow businesses in the retail and hospitality sectors.

TOWN TEAMS

Town Teams have been established in Bray, Arklow, Greystones and Wicklow .A key objective of the Town Team initiative is to encourage more collaboration, communication and cooperation between the Local Authority, business and the wider community and to develop one voice from one team for each town.

Towns Matter consultants have completed town centre health checks for Wicklow and Arklow Town.

Teams have made applications for LEADER funding for a variety of projects.

Arklow Municipal District with input from Arklow Town Team, has been awarded €40,000 funding by the Department of Justice for the installation of CCTV at 11 locations around the Main Street area.

The aim of this project is to deter illegal and antisocial behaviour and to make Arklow a safer and more attractive place for shoppers and for businesses.

Wicklow County Council is working with the Town Teams to develop one or more digital hubs within the County in 2018.

Town Teams will be established in Rathdrum and Blessington in 2018. A kick start meeting is due to

be held in Blessington on 30th January and in Rathdrum shortly thereafter.

WEB PORTAL PROJECT

The web-portal project is at the roll out and testing stage. The Portal will play a key role in communicating the new 'Wicklow' brand which encapsulates what Wicklow has to offer across multiple dimensions: start and grow a business, live and work, visit and stay. The web portal was previewed at the business breakfast on 26th January and will be formally launched in the coming weeks.

TOURISM

Tourism Statement of Strategy and Work plan 2017-2022:

Following a tendering process Wicklow County Council appointed 'Bluesail Consulting Ltd.' to draft a County Wicklow Tourism Strategy in November, 2017.

The overall vision is to make Wicklow the number one choice for visitors seeking an idyllic escape that harmonises a wide range of outdoor pursuits in Wicklow's world class natural arena, while driving job creation.

Blue Sail has carried out some initial analysis. In 2016 Wicklow welcomed 329,000 domestic visitors, they stayed for an average of 3.1 nights and spent €71 million. There has been very strong growth in numbers of domestic visitors coming to Wicklow in recent years. Also in 2016 Wicklow welcomed 272,000 overseas visitors who spent €86 million in the County.Wicklow has 3% of Ireland's visitor accommodation but only 2% of income from visitor accommodation.

A workshop will be held in mid February with representatives of Wicklow County Council, Wicklow Tourism Strategy Group and Wicklow County Tourism to present and test recommendations prior to the roll out of the tourism strategy.

Other Tourism Activity

In anticipation of direct flights from China commencing in 2018, Wicklow is positioning itself as the ideal location for visitors to base themselves while visiting Ireland. . Wicklow County Council and Wicklow Tourism will be participating in the 2018 EU China Lightbridge Project aimed at attracting increased visitor numbers from China though developing a better understanding of visitor needs.



As part of the EU China Lightbridge Project Wicklow County Council and Wicklow Tourism are working with Powerscourt House to light up Powercourt House on Friday 2nd March. This is the final event of Chinese New Year, known as the Lantern Festival. It is proposed to launch the Mandarin version of the Wicklow brochure at this event which will be attended by members of the Chinese community and the Chinese media.

A group of 20 educationalists from Lower Franconia will be spending a week in County Wicklow as part of an Erasmus programme. In addition to touring Wicklow and Dublin the group will be meeting educationalists in County Wicklow and visiting Wicklow County Campus.

MARITIME

Wicklow County Council has made a submission to the Department of Communications Energy and Natural Resources seeking to be included as a stakeholder given the likely impacts/ opportunities arising out of major offshore wind energy projects. The council has appointed consultants to prepare a vision strategy for Bray Harbour and will shortly commence procurement of consultants to prepare an overall maritime strategy which will include an audit of marine assets, and an audit of land available in the vicinity of the commercial harbours and a plan to maximise opportunities arising out of tourism, wind energy and aquaculture.

BREAKFAST BRIEFING

As part of its ongoing commitment to economic development, Wicklow County Council hosted the

2018 Breakfast Briefing and Workshop attended by key County Wicklow business stakeholders. There were over 100 participants representing all sectors of the business community from across the County.

The theme of the event was: "What can Wicklow County Council, State Agencies and Business Leaders do to enhance business opportunities in the county?"

The Cathaoirleach welcomed the participants; he said that it is clear that the business community needs a direct line into the Council as well as access to key decision makers. He encouraged more collaboration, communication and co-operation between the County Council, business and the wider community.

Addressing the delegates the Chief Executive said: "I believe that County Wicklow's unique attributes and proximity to the Dublin market, excellent quality of life, human capital, tourism, landscape, agriculture, marine and forestry resource makes it the best location in Ireland for Industry and Enterprise", adding that "the Council looks forward to working in partnership with the Business Community to deliver on the key objectives discussed."

The guest speaker at the event was Rachel Doyle, founder of the Arboretum.

The delegates participated in a workshop facilitated by Wicklow County Council management. The explored a number of themes about how best to develop and grow business and innovation in the County.

Winter Maintenance

The 2017/2018 winter maintenance programme continued during December with 163 call outs made and approximately 950 tonnes of salt used over 9 individual gritting routes across the county. Salt stocks were replenished with delivery of 1000 tonnes of salt to depots at Avoca, Baltinglass, Blessington, Carnew, Kiladreenan and Roundwood during the last week in November and throughout December.

3. Register of Electors

Following completion of the Draft Register, there were 100,027 electors in the system. 4,911 letters issued to those people that the fieldworkers were unsuccessful in contacting either through having moved out of the county or being unable to establish if they were still resident. All returned letters and forms received from voters still resident in Wicklow and for new constituents have been now been keyed onto the eReg system.

A further 1,200 letters that had been returned marked as "gone away" or "not known at this address" by An Post will have had another letter issued in January 2018 to give one last opportunity to either remain on the register in Wicklow or to provide a new address elsewhere. It is anticipated that in the region of 400 replies will be received.

The compiling of the Postal and Special Voters list is fully completed following voters being contacted to see if they wish to remain on or be removed from this list. A number of voters on this list will be removed due to change in circumstances or no longer requiring a postal or special vote. There has been an increase in the amount of army personnel on the Wicklow Register of Electors.

A complete re-run of the draft register took place on the 17th January 2018. This re-run will form the basis of the Live 2018/2019 Register.

Wicklow County Council expect to meet the statutory deadline of having the 2018/2019 Register of Electors published on the 1st February 2018. It should also be noted that Wicklow County Council have 95% coverage of Eircodes on properties on the eReg system as per Circular issued by the Department of the Environment, Heritage and Local Government.


