6. PPP SOCIAL HOUSING PROJECT

[Bundle 1)

Development Site at Convent Lands, Wicklow for 51 Social Housing units. The Department of Housing has dedicated €300 million towards delivery of housing through the public, private partnership model in the Rebuilding Ireland Action Plan. Wicklow has been included as a project in Bundle 1. The Part 8 was passed by the members at the Council Meeting of 3rd July 2017. The project is expected to commence on site in November 2018.



7. APPROVED HOUSING BODIES (AHB'S)

Capital Advance Leasing Facility (CALF) - 5 units were provided under a CALF lease to Cooperative Housing on the Greenpark Road in Bray.

6 apartments (Abbey St. Wicklow) due to be completed Q 3 2018 – CALF lease with Tuath AHB.

Approval has been received from the Department of Housing, Planning Community and Local Government for a leasing arrangement with Cluid to provide 45 units of accommodation on the Council's site at St. Earnan's View, Ballybeg, Rathnew. Estimated delivery date of these units is quarter 4 2019.

Capital Assistance Scheme (CAS) The CAS call for 2017 has been recently advertised.

Expressions of Interest – Social Housing on Council lands - A preferred proposal has been identified.

Stage 2 and Stage 3 Phase 3A – No 1 to No. 12 Glending Road has been completed.

Carraig Eden, Greystones - A consultant architect has been appointed to undertake a detailed design of the refurbishment of the building.

11. SOCIAL INCLUSION COMMUNITY ACTIVATION PROGRAMME (SICAP)

Implementation of the new SICAP programme (Social Inclusion Community Activation Programme) 2018-2022 continues. The two Partnerships involved are currently completing their Mid-Year Reports which will cover all aspects of their work to date and financial expenditure. The LCDC must then review and approve these Mid-Year Reports by 31st July.

12. PUBLIC PARTICIPATION NETWORK (PPN)

Co. Wicklow PPN has just launched an online Funding Handbook for its members, which is proving to be very popular. It lists over 50 funding streams available to community groups, and includes criteria for funding, amounts, timescales, contacts, as well as tips and advice on how to make applications. The content will be updated regularly given the constantly changing nature of funding streams. All local community groups are strongly encouraged to join the Wicklow PPN if they wish to access this useful information.

13. COMMUNITY AWARDS

Community Awards presentation evenings were held in May and June with the funds going to

sporting, social and community organisations throughout the county.

14. WICKLOW LIBRARY SERVICE

'OUR PUBLIC LIBRARIES 2022 - INSPIRING, CONNECTION & EMPOWERING COMMUNITIES"

The above mentioned document has been launched by Minister Michael Ring. It sets out a vision for the future of the public library, to be developed over the next 5 years. It lays out a vision over a number of strategic programmes and library buildings, digital development, opening hours, access, funding, staff and stock. Wicklow County Council Library Service is already a lead player in a number of the initiatives specifically mentioned, including "Work Matters2 and "My Open Library".

WICKLOW TOWN LIBRARY - UPDATE

Design and layout for new Wicklow library and County Archives has now been agreed with the architect led team. The tender process for construction firm will now be put in place, including short listing of interested parties, to whom main tender will be issued.

Allowing for construction to commence in the autumn, the realistic target remains of opening in late autumn 2019.

MOBILE LIBRARY TENDER

Wicklow County Council Library Development Plan 2016 – 2020 states the need for a new mobile library to be provided within the timeframe of the programme. The current vehicle is now 14 years on the road, with more than 350,000km covered. A tender has now been issued for provision of a new, custom made mobile library – closing date for applications is Friday 27 July. 45,000 items were issued from the current Mobile Library in



2017. The service has remained very well used down the years, serving 34 locations per fortnight.

SUMMER STAR PROGRAMME

The 3rd annual running of the Summer Star programme will be held from June 30 to August 31st, in libraries throughout the country. This initiative, co-ordinated by the LGMA, encourages children to continue to read during the long summer holidays and culminates in certificate presentation in September. Wicklow libraries had one of the largest numbers taking part in 2017, with more than 3,000 children taking on the challenge.

WEST WICKLOW POETRY BUS

A tour with a twist was inaugurated in West Wicklow last Saturday, 26 May. The West Wicklow Poetry Bus departed Blessington Library at 10 a.m. with six poets from the PoulaPoetry group aboard along with a singer-songwriter and an audience of twenty or so curious locals.

PoulaPoetry is a group of amateur poets from west Wicklow set up in 2017 with a view to encouraging each other's writing and promote greater engagement with poetry in the area. With the help and encouragement of Wicklow County Council Library Services, who host their monthly get-togethers in Blessington Library, the group has gone from strength to strength with different projects and readings bringing their poetry to local audiences.

On this occasion they brought their audience with them on a tour of a number of places of interest in west Wicklow. The idea was that at each stop one or more of the poets introduced and read in situ a poem they had written about the surrounding landscape, with the audience around them able to take in there and then the details mentioned in the verses.

Organiser, Paul O Connor, was pleased with the success of the day. "I'm delighted to hear that people had fun and enjoyed the experience. It was a bit of a leap of faith. If it helps to bring more poetry into more peoples' lives, then that's great. We hope to make it an annual event, definitely. Something quirky and unique that we can associate with the area, and add in to the mix of so many other community projects going on these days in west Wicklow, all aiming to enhance the area and encourage others to visit while bringing us closer as a community."

The 'Surprised By Place' exhibition of the poems and accompanying photographs will be open to the public at Blessington Library for the first two weeks of June.

CAREERS GUIDANCE EVENT AT ARKLOW LIBRARY 11TH JUNE 2018

Arklow library partnered with the local Intreo Office in promoting the Works Matters programme to the local community.

On 11th June . Arklow library was the venue for a iobs fair, where the focus of the event was on the Community Employment Schemes in Arklow -Guidance Services, Jobs Club Employability. Local groups taking part included Jobs Ireland (Arklow Intreo Office), Crosscare CE scheme, Tinahely CE, Wicklow County Partnership, Wicklow Community Support, KWETB, ABEC, Irish Wheelchair Association. Some local employers were also represented with stands taken by McDonalds, Intelligo Software, Thomas Montgomery. Also present were recruitment companies Jackson Stone Recruitment and FIT.ie.

150 people attended and it was very satisfying to note how many people engaged with several of the stands present. A number of 'break out' areas were created with comfortable seating, where people could sit and talk, or network. Lidl



Arklow provided the tea and scones which were very much appreciated.

There were many attendees who, though living locally, had never entered the building in the 2 years since it was opened. This gave library staff the opportunity to sign up new members, show them around and have the time to spend with them exploring the various online resources which are available, and which were of particular interest to the target audience on the day.

15. COUNTY WICKLOW LOCAL SPORTS PARTNERSHIP (LSP)

STREET FEAST - SUNDAY 10TH JUNE

Wicklow Local Sports Partnership partnered up with "Street feast" again this year and any neighbourhood hosting a Street Feast event was invited to collect a bag of play equipment provided by Wicklow Local Sports Partnership worth €50 to encourage fun and active play within their community. 25 estates registered for this year's Street Feast across County Wicklow. This was an increase of 15 estates compared to 2017.

BIKE WEEK 9TH - 17TH JUNE

Wicklow Local Sports Partnership received a funding of €5,000 for Bike Week. The Wicklow 200 was held Sunday 10th June in Bray Emmet's and Wicklow Local Sports Partnership organised 2 physiotherapists to be there on the day to do pre/post rubs at the start/finish line. Over 3000 cyclists took part. A Cycle Safety Programme, along with a Smoothie Bike and other cycling related activities were held in St Philomena's, Ravenswell in Bray on Wednesday 13th June. A fun bike event was also held in St Jonathan Swift National School, Dunlavin on Thursday 14th June.

CRINNIÚ NA NÓG RUSSBOROUGH - 23RD JUNE

Wicklow County Council's Culture team in partnership with Wicklow Local Sports Partnership are organising the parkrun and children's fun day at Russborough House. This event is taking place on the 23rd June from 9.30am to 1pm and is a fun, free family day. The course runs entirely on trail paths in beautiful Russborough Parklands and is 5K long. There will be free admittance for children to the Russborough maze on the day and children can enjoy trying out a smoothie bike.

ECONOMIC DEVELOPMENT, PLANNING AND INFRASTRUCTURE

1. WICKLOW ECONOMIC THINK TANK (CWETT) ACTION PLAN/LOCAL ECONOMIC AND COMMUNITY PLAN (LECP) (ECONOMIC)

The Economic Development Unit of the Enterprise and Corporate Services Directorate is charged with implementing the economic actions in the Local Economic and Community Plan (LECP). Many of the 142 actions listed in the LECP have come from the County Wicklow Economic Think Tank (CWETT) Action Plan. The CWETT which was initiated in 2013 was a collaborative project initiated by Wicklow County Council and involved the business community from across the county and the County Enterprise Board (now LEO Wicklow).

BRAND

A sub group of the Wicklow County Council Communications committee is developing guidelines for the use of the brand on Council stationery, emails etc.

FILM

Wicklow County Council is in the process of developing a Masterplan for Wicklow County Campus, to develop the site as a creative Content/Film hub.

An application is due to be submitted to Enterprise Ireland under Stream One of the Regional Enterprise Development Fund

RETAIL

The Florentine Centre

Work has commenced on the Florentine Site with a view to having the new shopping street in place by December, 2019. Wicklow County Council / Bray Municipal District has arranged alternative parking at Bray Institute of Further Education and at Ravenswell Road.

TOWN TEAMS

A key objective of the Town Team initiative is to encourage more collaboration, communication and cooperation between the Local Authority, business and the wider community and to develop one voice from one team for each town. An update on Town Team activity will be given at each Municipal District Meeting. Chamber of Commerce members on Town Teams have been asked to update their members on Town Team activity also.

Arklow Town Team

Arklow Town Team was successful in its bid to have the Dementia Friendly Garden, which won featured at Bloom in the Park, awarded to Arklow. In the coming weeks the award winning garden will be relocated to Arklow where residents with dementia and their carers will be made particularly welcome.

Arklow Town Team has also launched a Shop Front Painting Grant Scheme in conjunction with Topline Bolands and Dulux Paints Ireland.

Blessington Town Team

Building on Blessington's success in being selected as Leinster's Most Enterprising Town in 2017, Wicklow County Council and Blessington and District Forum are using the opportunity to involve other interested parties in establishing Blessington Town Team.

In order to ensure that the Team can begin its work on behalf of the community in Blessington as quickly as possible, a number of Working Groups - have been identified as follows:

- Public Realm and Tidy Towns
- Planning and Infrastructure
- Healthy Blessington
- Business
- Culture and Heritage
- Greenway and Tourism

Greystones 2020

Key Projects

Greystones Train Station

Driven initially by the Tidy Towns and subsequently joined by the 2020 committee, agreement was reached with Irish Rail to create a comprehensive landscaping and historical project along the eastern and western platforms of Greystones Train Station. Greystones 2020 has commissioned a series of very



large portraits of famous people with Greystones connections, among them Jack Butler Yeats, John Millington Synge, Samuel Beckett, Norah Hoult, Geraldine Fitzgerald, Éamon De Valera, Michael Collins and Ronnie Drew

The images will be framed by a wave shaped hedge which will have a dual function of mirroring the coastal location of the town whilst obscuring a visually unattractive palisade fence.

Irish Rail will contribute some materials and labour. A significant portion of the costs will be funded through sponsorship.

Public Realm Plan

Greystones 2020 is in the process of engaging consultants to develop a public realm plan for Greystones

The aim of the project is to develop a detailed action-based plan for the town's public realm, which can be used to guide public and private investment in the town to maximise and enhance its existing cultural assets in tandem with economic and social development.

It is intended that the plan will stimulate interest and activity among all the community aimed at enhancing the town of Greystones, and that all stakeholders will be involved in developing a shared vision for the economic, environmental and cultural development of the town.

Greystones 2020 has also developed a new website for Greystones which will promote the town nationally and internationally.

Wicklow Town Team

Town Team Projects Underway:

The establishment of a digital hub to attract small start up type businesses to locate in Wicklow.

The development of a Greenway/Blueway from Greystones to Wicklow Town will contribute to the economic and social well-being of County Wicklow.

At the request of Wicklow Town Team and with Financial Support from Wicklow County Council, the

Council has commissioned a study on the feasibility of developing this route.

Promoting the development of a park and ride facility close to the M11 aimed at reducing commuter traffic by encouraging a switch to bus transport.

Wicklow is working to achieve historic town status and has engaged in initiatives such as archaeological explorations of the Black Castle and the Abbey Grounds and the development of historic trails This includes backlighting of historic sites in the town

Wicklow Town Team has applied for funding under the Town and Village Renewal Scheme 2018 for backlighting of some of the historic buildings and bridges and for a Tourism Trail.

It is proposed to participate in the Age Friendly Business Recognition Programme.

The Wicklow Town Team conducted an online retail survey is to assess the shopping habits and needs of our residents over 1,500 responses were received. The Town Team is currently engaging with the retailers to establish retailer requirements and priorities.

WEB PORTAL PROJECT:

The new portal Wicklow.ie is now live. Wicklow.ie represents "all things Wicklow" in a fresh new and engaging way. There are up to 40 staff engaged in content management, led by a small team from IS and Enterprise and Corporate Services.

TOURISM

Tourism Statement of Strategy and Marketing Plan 2018-2022:

The Tourism Strategy has been completed and will be put before the CWETT Tourism Strategy Group prior to being forwarded to Wicklow County Council and Wicklow County Tourism..

Glendalough

The Chief Executive is chairing a working group consisting of representatives of Failte Ireland, NPWS, Coillte, OPW, aimed at progressing the development of Glendalough as one of Ireland's premier visitor destinations. The aim is to enhance the visitor experience through improved interpretation, signage, facilities and access.

Viking Coast

Wicklow County Council is working with Failte Ireland and counties Waterford and Wexford to explore the potential of developing a Viking Coast theme as part of Ireland's Ancient East.

MARITIME

The blue economy is an important pillar of Wicklow's economic development strategy.

Wicklow County Council is finalizing a vision statement for Bray Harbour and is currently preparing a brief for the statement of maritime strategy for the County, taking account of challenges and opportunities particularly in the areas of tourism, aquaculture and offshore energy.

COMMUTER SURVEY

Census 2016 indicated that 21,000 Wicklow residents commute outwards from the County to work each day. Wicklow County Council wishes to find out where commuters are travelling to, what they are working at with a view to identifying opportunities for reverse commuting.

Wicklow County Council has appointed consultants to carry out the Commuter Survey.

It is anticipated that the data analysis, using CSO data, will be carried out over the summer months and that the actual survey will commence in September when normal traffic volumes resume.

2. LOCAL ENTERPRISE OFFICE (LEO)

LEO Objectives

To foster an enterprise culture and stimulate enterprise at local level by:

3. PLANNING AND DEVELOPMENT

FORWARD PLANNING

Arklow and Environs Local Area Plan 2018:

Following submission of the Chief Executive's Report to the Minister on the Minister's Draft Direction to the plan, the Minister decided to appoint an independent inspector to prepare a report regarding one of the two sites that were the subject of the draft direction (Ballynattin – tourism zoning). The inspector completed his report on 30.05.18 and issued it to the Minister. On 01.06.18, the Minister circulated this report and requested any final comments from the Chief Executive and the elected members within 10 days. Thereafter the Minister has 3 weeks to make his final decision regarding the Direction and therefore the final decision is expected at the end of June 2018.

Bray Municipal District Local Area Plan 2018:

The Bray MD LAP was adopted by the members at the meeting of 14.05.18. The plan took effect on 10.06.18.

Variation 1 to the Wicklow County Development Plan:

At the Council meeting of 14.05.18, the elected members made Variation 1 to the County Development Plan. The purpose of this variation is to ensure that the plans for Rathdrum, Arklow and Bray align with the County Development Plan. This variation took effect from the day that it was made.

Newtownmountkennedy LAP:

The preparation of the Draft Plan continues at present.

National Planning Framework (NPF) & Regional Spatial & Economic Strategy (RSES):

The NPF was adopted by the Government in February 2018.

The Regional Assembly executive is in the process of preparing a draft RSES. Early working draft chapters have been circulated and we have engaged closely with the RSES term to provide feedback. The proposed draft RSES is due to be issued to the members of the Assembly for their approval in September 2018.

Vacant Site Levy:

Any sites that stood on the Register as of 01.01.2018 have been issued with notices under Section 11 of the Act reminding them that they sit on the register and that a levy will be payable from 01.01.19. This notice allows landowners to advise of any change in circumstances of the site e.g. to notify us if it no longer vacant. Any submission received must be assessed the Planning Authority and thereafter we shall determine if the site should stay on the Register. An appeal to ABP is available should the landowner not be happy with this decision.

Sites that stood on the Register as of 01.01.18 are currently being valued following the procurement of outside professional valuers.

Submissions received from landowners whose lands were assessed under Phase 1B, being sites within the lower settlements of Rathdrum, Kilcoole, Ashford, Baltinglass, Carnew and Enniskerry, are currently being assessed and considered.

HERITAGE

Notification was received from the Department of Culture, Heritage and the Gaeltacht, in respect of applications submitted for grant aid under two



schemes. Applications were successful under the following schemes:

Built Heritage Investment Scheme (BHIS) 2018:

• 7 applications approved to the value of €50,000

Structures at Risk Fund (SRF):

• 2 applications approved to the value of €24,000

The successful applicants have been notified of the grant approved in respect of their projects.

Wicklow County Council ranked 1st for Managing Waste Services

As part of the documentary "Ireland's Wild RTÉ Investigates environmental data from a number of sources including the EPA and the Department of Housing, Planning & Local Government, in order to identify the level of activity by each of the councils in the area of Waste Management. By of at the rates inspections. enforcements, prosecutions and staffing levels between 2014 and 2016, Wicklow County Council was ranked 1st of the 30 councils analysed and was deemed as the best council in Ireland for managing waste services.

It was reported that Wicklow conducted 6,174 non-routine inspections between 2014 and 2016, 4.5 times the national average of 1,371. It was also noted that between 2015 and 2016 Wicklow spent €19.67 per person on waste services, €2.45 more than the national average of €17.22. Overall Wicklow scored in the top 5 best for three categories that RTÉ Investigates looked at.

WHITESTOWN REMEDIATION PROJECT

Wicklow County Council have now employed Fehily Timoney Company to advise on the remediation of the site at Whitestown, in accordance with the judgments of Mr Justice Humphreys. They are independent experienced Environmental Consultants. An initial meeting has taken place with the consultants and a steering committee has been formed to monitor progress on the remediation project.

HARBOURS AND PORT

WICKLOW HARBOUR

Ahead of the summer season the "Wendy" raft was deployed off the new pier and the platform was secured to the pier. Buoys have been put in place to mark the bathing area from the working port. Replacement and additional ladders off the pier have been ordered and are expected to be put in place by the first week in June. This will allow easier and more access off the pier and will enhance the amenity and safety for swimmers.

Arklow Harbour

A tender application is being prepared for the operation of Marina. Located in the Dock in Arklow Harbour, it is a sixteen berth marina. The tender will be for the general operations of the marina, to provide facilities for those using the berths and for the collection of any associated fees. It is hoped to advertise the tender in June

BLUE FLAG BEACHES

WCC was delighted to host the national An Taisce Blue Flag and Green Coasts Awards in Bray in May. The event celebrated and rewarded Local Authorities, clubs & marinas, and community groups for the work they have done in achieving excellence in fresh water and marine environments. The awards were presented by Minister Eoghan Murphy and in all 90 Blue Flag and 59 Green Coast awards were presented. Wicklow retained their four Blue Flags in Bray, Greystones, Brittas Bay North and Brittas Bay South. Arklow retained their Green Coast award.

BEACH LIFEGUARDS

Interviews were held in May for the position of Temporary Beach Lifeguard. 17 applicants have been appointed. WCC provides a lifeguard service at 6 beaches in the county. The season runs from 1st June to 15th September. In advance of the summer season 3 new lifeguard huts have been purchased for Wicklow Harbour, Brittas Bay North & South. The huts are painted in the red and yellow livery and provide an enhanced vantage point for the lifeguards as well as being a visible and obvious point of contact for the public. WCC, through our Water Safety Development Officer,



works closely with Irish Water Safety. Preparation is being made for Water Safety Week and Lifesaving Week.

POLLUTION CONTROL

BATHING WATERS

- 6 identified bathing waters were sampled in May (pre-season samples) which includes 4 blue flag beaches at Bray South, Greystones South, Brittas Bay North and Brittas Bay South.
- The season runs from June to Mid September.
- All samples indicate excellent quality bathing waters.

M11/N11 - Kilmacanogue Parallel Service Road

Roughan & O'Donovan, Consulting Engineers, have been appointed to determine the feasibility of introducing safety measures on the southbound lane on the approach to junction 8 in Kilmcanogue.

The aim of the service road was to:

- Improve safety for all road users in and around the junction 8 area on the N11;
- Maintain and improve access to and from existing properties
- To increase the mainline speed of the N11 while maintaining or reducing the existing 60km/h speed on the parallel service road.

Part VIII Reference 18/382 submitted for the N11 Parallel Service Road on 13th April 2018. Submissions and observations are due by Monday 11th June 2018.

Junction 4 M50 to Kilmacanogue – Junction 14 Update – Main Scheme

In line with the requirements of the Public Spending Code, transposed into Department of Transport Tourism and Sport requirements via the Common Appraisal Framework (CAF) a Project Appraisal Report was prepared and submitted to the

Department of Transport Tourism and Sport in early April 2018.

Approval of the Project Appraisal Report was received from DTTaS on the 13th April 2018 which enables the Sponsoring Agency to commence the CAF preliminary appraisal stage. This aligns to the Transport Infrastructure Ireland Project Management Guidelines 2017 as the Phase 1 – Scheme Concept and Feasibility and Phase 2 Option Selection.

It is hoped that tender documents for the appointment of a consultant to aid in the appraisal process will be finalised. It is intended to appoint consultants during the Summer of 2018.

N81 Knockroe Bend Realignment

Archer Heritage Planning is the Contractor for the Archaeological Works Contract. The Archaeological dig is currently in progress with completion scheduled for May 2018. Invitation of tenders for construction works is projected for May with award in September. A grant allocation of €2.5m has been notified by TII for 2018.

3. REGISTER OF ELECTORS

The referendum took place on 25th May 2018. Wicklow had just shy of a 75% turn out, the 2nd highest in the country apart from Dublin Bay North. The turnout is a reflection of the accuracy of our register of electors. *Wicklow County Council also have a 94.93% coverage of Eircodes on their Register of Electors which is the highest in the country and a further reflection of the accuracy of Wicklow's Register.*

Following the Referendum letters have been issued to those electors who had polling cards returned

marked as 'gone away' to provide them with a further opportunity to update their details on Wicklow's Register of Electors or to pass on new details to another local authority. Work will also continue throughout the summer months on gathering further Eircodes to increase the figure from 94.93% to as high as possible prior to the publication of the next Live Register.

Work has now commenced on the compilation of the 2019/2020 Draft Register of Electors. Vacancies for Fieldworkers have been advertised and returning fieldworkers have been given their Workbook packs to commence the door to door calls to gather the information for the Draft Register. Electors are encouraged to engage with the Franchise Section and the Fieldworkers to ensure their details are accurately recorded and retained on the Register of Electors.

- Data collection systems using mobile devices have been used for the Register of Electors.
- Projects in Housing, Roads and Environmental Services departments are on-going.
- Upgrade to Revenue Collection Handhelds has now reached conclusion of trial phase.
 These units should be in place for all Collectors during this quarter
- Housing Condition Survey is live while other project including Health & Safety audit and CCTV survey have been advanced.


