# 6. PPP Social Housing Project

#### [Bundle 1)

Development Site at Convent Lands, Wicklow for 51 Social Housing units. The Department of Housing has dedicated €300 million towards delivery of housing through the public, private partnership model in the Rebuilding Ireland Action Plan. Wicklow has been included as a project in Bundle 1. The Part 8 was passed by the members at the Council Meeting of 3rd July 2017. The project is expected to commence on site in September 2018.

#### 7. Approved Housing Bodies (AHBs)

**Capital Advance Leasing Facility (CALF)** - 5 units were provided under a CALF lease to Co-operative Housing on the Greenpark Road in Bray.

Approval has been received from the Department of Housing, Planning Community and Local Government for a leasing arrangement with Cluid to provide 45 units of accommodation on the Council's site at St. Earnan's View, Ballybeg, Rathnew. Estimated delivery date of these units is quarter 4 2019.

**Capital Assistance Scheme (CAS)** The CAS call for 2017 has been recently advertised.

Expressions of Interest – Social Housing on Council lands - A preferred proposal has been identified.

#### 8. Housing Schemes Remediation

#### Glending, Blessington - Remediation

Stage 2 and Stage 3 Phase 3A – No 1 to No. 12 Glending Road has been completed.

> Stage 3 Phase 3B - No. 1 to No. 10 Glending Square and No. 1 to No. 4 Glending Way - Contract commenced on  $3^{rd}$  January 2018 on 1 - 4 Glending Square, with internal remediation works complete. Internal works to 6 - 8 Glending Square ongoing with works to commence on 1 - 4 Glending Way presently.

Decanting of the remaining properties is currently underway.

#### Hillview, Wicklow - Remediation

Roofing contract completed and contractor off site. Refurbishment works to "B Types"- 12 of 14 completed, 1 more almost completed but being kept for site storage and final house to start soon when tenant is decanted. Bridge works to "F Types" and ceiling repairs to "C and F Types" as before at 30% and 20% respectively.

# 11. Social Inclusion Community Activation Programme (SICAP):

Contracts were signed on 28<sup>th</sup> March 2018 for the 2018-2002 Programme. Bray Area Partnership, Quinsboro Road, Bray in conjunction with consortium partners Bray Community Enterprise and Bray Family Resource & Development Project based in Fassaroe were the successful bidders for the Bray and Greystones Municipal District areas. County Wicklow Partnership, Bridgewater Centre, Arklow were the successful bidders for the Arklow, Wicklow and Baltinglass Municipal District areas.

#### **Public Participation Network (PPN)**

Baltinglass Municipal District is one of four national pilot areas developing a community statement on well-being. To begin this process, Wicklow PPN facilitated two public consultation sessions in Hollywood and Carnew in February, with good attendance and participation at both. Guest speakers included Seamus Boland, CEO Irish Rural Link and Sara Bourke, Social Justice Ireland.

#### 12. Wicklow Library Service

#### "Creative Ireland

"Way with Words Wicklow "is a Wicklow County Council Initiative supported by Creative Ireland in collaboration with Wicklow County Council. A literary festival will be held in Arklow and Blessington libraries from March - May. The programme for the festival includes storytelling and illustrations workshops for children as well as poetry readings and talks by novelists, crime writers, poets and memoirists. Whilst the libraries will be the main centre of activity during the festival, writers will also be 'out and about' in Wicklow, visiting schools, community groups and others. The Mobile Library will be out and about with an illustrator on board and writing groups within the community will work with author-facilitators. Playwright and poets will be in residence in local schools as part of Reading Schools Wicklow - see www.waywithwords.ie for programme details.

#### "Healthy Ireland in your Library"

Healthy Ireland events took place at libraries throughout the county. A sample of the themes for March included "healthy eating", "emotional wellbeing" "chair yoga" and local walks (Dunlavin & Greystones), "digital detox",

#### 13. Local Sports Partnership

#### Rugby for All

Wicklow Sports Partnership has facilitated a 3 day camp for people with both physical and mental disabilities in Wicklow Rugby club in conjunction with Leinster Rugby. This camp has been funded through Healthy Ireland and began on 26<sup>th</sup> of March 2018. There has been great interest in this camp and it is the clubs intention to begin an inclusive section of their club as a result.

# 14. Local Economic and Community Plan (LECP) (Community)

#### LCDC

The LCDC Annual Report 2017 has been adopted and will be before the April meeting of Wicklow County Council.

#### **LECP**

The Advisory Group is continuing to monitor the implementation of the LECP, both the community and the economic actions, and to ensure the integration of economic and community actions.

#### Comhairle na nÓg

In addition to speaking at the Dáil and the Oireachtas, members of the Comhairle took part in the Government's Open Policy debate regarding online safety which took place at the Royal Hospital Kilmainham. The event had government. Ministers, Gardaí, experts from Google and Facebook as well as national organisations such as Children's Rights Alliance, ISPCC, etc.

#### Older Person's Council (OPC)

Preparations are underway for the County Wicklow Older Persons Council AGM which is due to take place on the 25<sup>th</sup> May 2018. An Older Person's directory, compiled by the Older Person's Council of Ireland (OPCI), will be launched on the day.



# **Economic Development, Planning and Infrastructure**

# 1. Wicklow Economic Think Tank (CWETT) Action Plan/Local Economic and Community Plan (LECP) (Economic)

The Economic Development Unit of the Enterprise and Corporate Services Directorate is charged with implementing the economic actions in the Local Economic and Community Plan (LECP). Many of the 142 actions listed in the LECP have come from the County Wicklow Economic Think Tank (CWETT) Action Plan. The CWETT which was initiated in 2013 was a collaborative project initiated by Wicklow County Council and involved the business community from across the county and the County Enterprise Board (now LEO Wicklow).

#### **BRAND**

During the research phase of the County Wicklow Economic Think Tank the committee ran a public engagement campaign entitled *What's the Big Idea?* The Campaign was designed to identify strategic priorities for County Wicklow. One such priority that emerged as the result of public engagement was to build a strong brand for County Wicklow.

It was further recommended that Wicklow.ie be redeveloped as a web portal and that together the new brand and the new web portal would project a fresh image and would take account of the way younger generations consume data.

Following a procurement process, the branding company Brando was engaged to develop the new brand. Brando considered the results of the surveys carried out as part of the What's the Big Idea Campaign, engaged with the CWETT Marketing and Communications Group and carried out focus groups and independent research. They developed the brand model based on the needs of the community, business and visitors and came up with the brand line "Endless Opportunities". The brand promise being that Wicklow offers you every opportunity to be what you want to be and to achieve what you want to achieve. The brand promise is supported by the logo representing the Sugarloaf and the sea.

A number of versions of the logo have been developed for use with and without the tagline and "As Gaeilge" as "Deiseanna Síoraí".

A sub group of the Wicklow County Council Communications committee is developing guidelines for the use of the brand on Council stationery, emails etc. The brand will be launched with the webportal in the coming weeks.

#### **FILM**

- Wicklow County Council granted planning permission to Ashford Studios. The development consists of 12 buildings including film studios, support services, a visitor centre storage, workshops, staff, visitor and coach parking on a 40 hectare site.
- Olcott Entertainment has completed the acquisition of Ardmore Studios. Siun Ni Raghallaigh will remain on as CEO.
- Wicklow County Council is in the process of developing a Masterplan for Wicklow County Campus, to develop the site as a creative Content/Film hub.

#### **RETAIL**

## **The Florentine Centre**

Wicklow County Council and Oakmount/ Navybrook have signed a contract which will see the development of the Florentine site on Bray's Main Street.

The development which consists of a new shopping street featuring retail, restaurants, a cinema and parking will serve to reinvigorate the heart of Bray. Oakmount and its associated companies and their extensive retail, hospitality and entertainment portfolio is an excellent fit for Bray and will breathe new life into the town

#### **TOWN TEAMS**

Town Teams have been established in Bray, Arklow, Greystones and Wicklow and most recently in Blessington. Wicklow County Council is working with the Teams to carry out Town Centre Health Checks and to apply for funding from a variety of sources such as LEADER, Town and Village Renewal Department of Justice etc.

An event to celebrate the success of Blessington winning the most Enterprising Small Town in Leinster will be held on 9<sup>th</sup> April.



This exciting achievement for the town was the culmination of a huge amount of hard work by the local Enterprising Town Committee with strong support from Blessington Forum, the local business community and the Baltinglass Municipal District.

Greystones was also successful and was awarded runner-up in the Leinster region in the over 7,000 population category. Thanks to the hard work of Greystones 2020 and Greystones Municipal District.

A key objective of the Town Team initiative is to encourage more collaboration, communication and cooperation between the Local Authority, business and the wider community and to develop one voice from one team for each town. An update on Town Team activity will be given at each Municipal District Meeting. Chamber of Commerce members on Town Teams have been asked to update their members on Town Team activity also.

#### **WEB PORTAL PROJECT:**

Following a procurement process late last year Wicklow County Council appointed the successful Tenderer 'INVENTISE' to Design, Develop and Host our new Web Portal.

The new portal Wicklow.ie is now live. Wicklow.ie represents "all things Wicklow" in a fresh new and engaging way. There are up to 40 staff engaged in content management, led by a small team from IS and Enterprise and Corporate Services.

The 3 main elements of the site comprise of Living, Business and Visit. There is a very powerful search function. The site will be formally launched in the coming weeks

#### **TOURISM**

# Tourism Statement of Strategy and Work plan 2017-2022:

The Tourism Strategy is almost complete. At the February workshop at which the draft strategy was presented to members of the tourism industry, further information on the origins of visitors to Wicklow was requested. A survey is to issue over the next week, when the results are back the strategy document will be completed.

#### **Objectives**

- Growth in tourism spend
- Year round business
- A viable alternative to the West coast.

#### Links with China

Unfortunately the Chinese New Year Celebration and brochure launch had to be cancelled due to snow. It is hoped that the Ambassador will come to Wicklow on 23<sup>rd</sup> April and that the brochure will be launched on that occasion. In spite of the snow Powerscourt House was lit up in red and filmed for the EU China Lightbridge Project. Images of Powerscourt were publicised on Chinese media and via Tourism Ireland.

On 7<sup>th</sup> of March a group of Wicklow businesses interested in doing business in China attended an event hosted by the Chinese Embassy. The purpose of the event was to promote a major import Expo to be held in Shanghai in November. The event was attended by El, IDA Bord Bia and many companies doing business in China as well as neighbouring local authorities. This was a good opportunity for Wicklow businesses to meet Ambassador Yue and the Commercial Attaché and her team.

Last week Hainan Airlines announced that it will commence direct flights to Dublin from June. Hainan is China's largest independent airline and it is launching a new service from Dublin to Beijing starting on 12 June. The new direct route will help Irish firms and exporters with operations and clients in China, whilst also encouraging Chinese companies to invest in Ireland.

Irish tourism is also set to benefit from the new initiative as Tourism Ireland estimates that about



70,000 Chinese visitors came to Ireland last year, up from 60,000 in 2016.

In Wicklow a special relationship has already developed with the island province of Hainan in recent years and in July of 2017 an Official Partnership Agreement was signed between Wicklow County Council and Hainan Province. The next steps will be to establish a Wicklow China partnership group.

#### **Other Tourism Activity**

During March a group of 20 educationalists from Lower Franconia spent a week in County Wicklow as part of an Erasmus programme. In addition to the education programme organised with support from KWETB the group attended the St Patrick's Day Parade in Bray and visited Dublin and Kilkenny.

Their tour of County Wicklow was curtailed somewhat due to snow.

#### **MARITIME**

The blue economy is an important pillar of Wicklow's economic development strategy.

Wicklow County Council is finalizing a vision statement for Bray Harbour and is currently preparing a brief for the statement of maritime strategy for the County, taking account of challenges and opportunities particularly in the areas of tourism, aquaculture and offshore energy.

- On 9<sup>th</sup> March 2018, 6 business availed of one to one Mentoring regarding Brexit, which took place in Wicklow County Campus.
- On 20<sup>th</sup> March 2018, the Wicklow county final of the Student Enterprise Programme took place in Clermont House, Wicklow County Campus. There were 39 projects on display across senior intermediate and junior categories. Students from Colaiste Craobh Abhann won Senior Category, Students from North Wicklow Educate together won the intermediate category while a Student from CBS Arklow claimed the title in the Junior Category. The winners of each category will represent Wicklow in the National Final in Croke Park on May 2<sup>nd</sup>.
- 2017/2018 saw the Highest ever participation in the Student Enterprise Programme in Wicklow with 1605 Students from 18 second level schools participating over the past number of months.
- On 21<sup>st</sup> March 2018, An Introduction to Lean Business Excellence training course took place in Clermont House, Wicklow County Campus with 10 attendees.
- On Tuesday 27<sup>th</sup> March the 'Accessing Finance for your Business' workshop took place with 5 participants.

#### 4. Planning and Development

#### **FORWARD PLANNING**

#### Arklow and Environs Local Area Plan 2018:

A Ministerial Directive was received in respect of this plan. Submissions have been invited from the public relating to this directive, with the closing date for receipt of such submissions being 27<sup>th</sup> March 2018.

# **Bray Municipal District Local Area Plan 2018:**

The closing date for receipt of submissions was on the proposed amendments was 9<sup>th</sup> March. A report on these submissions is being prepared for consideration by the Elected Members.

#### Newtownmountkennedy LAP:

A total of 43 submissions were received during the public consultation period, which are being considered as part of the preparation of the Draft Plan.

#### **Vacant Site Levy:**

Phase 1B sites within the lower settlements of Rathdrum, Kilcoole, Ashford, Baltinglass, Carnew and Enniskerry have been assessed and the first letters of intent have been sent out to landowners. Submissions received from these landowners are currently being assessed and considered.



#### Heritage:

The County Wicklow Heritage Plan was officially launched by Cathaoirleach Cllr Edward Timmins as part of a heritage event in Baltinglass Courthouse Tuesday 13<sup>th</sup> March.

Organised by the Heritage Office of Wicklow County Council in association with the Baltinglass Town Renewal Group, the event saw the official launch of the County Wicklow Heritage Plan 2017-22 and the launch of three new Heritage Trail brochures for West Wicklow; Blessington Lakeside, South West Wicklow and West Wicklow.

The three heritage trails were produced by the Heritage Office following a heritage recording project undertaken under the aegis of the Heritage Plan. The brochures were co-funded by the Baltinglass Municipal District office and The Heritage Council. As part of the event there was a presentation on online sources of heritage information about Baltinglass Abbey by <a href="www.monasticireland.ie">www.monasticireland.ie</a> and the showing of a short film outlining the Baltinglass Town Renewal groups proposals to develop the courthouse as a cultural heritage attraction and a hub for supporting local businesses.

In Wicklow Port, the cargo vessel MV "Telamon" made a delivery of 811 tonnes of Water pipes. This cargo has then transported to Roundwood for Irish Water's Varty Water Supply Scheme. #### **Winter Maintenance**

February was another busy month in the 2017/2018 winter maintenance programme with a total of 285 call outs made and approximately 1,200 tonnes of salt used over the 9 individual routes across the county. A further 500 tonnes was delivered to the depots at Avoca, Baltinglass, Blessington, Carnew, Kiladreenan and Roundwood during the last week of the month in order to replenish the stock levels in advance of Storm Emma. This was in addition to the 1000 tonnes delivered earlier in the month.

#### M11/N11 – Kilmacanogue Parallel Service Road Roughan & O'Donovan, Consulting Engineers, have been appointed to determine the feasibility of introducing safety measures on the southbound lane on the approach to junction 8 in Kilmcanogue. Survey Work has commenced on the N11 Parallel Relief Road at night time as part of this scheme.

The aim of the service road is to

- Improve safety for all road users in and around the junction 8 area on the N11;
- Maintain and improve access to and from existing properties
- To increase the mainline speed of the N11 while maintaining or reducing the existing 60km/h speed on the parallel service road.

#### N81 Knockroe Bend Realignment.

Archer Heritage Planning is the Contractor for the Archaeological Works Contract. The Archaeological dig is currently in progress with completion scheduled for May 2018. Invitation of tenders for construction works is projected for May also. A grant allocation of €2.5m has been notified by TII for 2018.

#### N81 Baltinglass Town Centre Surfacing Works.

There are design issues to resolve around the junction layout for the N81/R747 junction. The current programme envisages

- (1) Installation of ducts and relocation of services within remainder of Section 2 during 2018.
- (2) Construction and surfacing works in Section 2 during 2018.

The Council has made an application for funding to Transport Infrastructure Ireland for new lighting on this section of the N81.

#### **Local Improvements Schemes (LIS)**

The Department for Rural and Community Development (DRCD) by letter dated 28<sup>th</sup> February 2018 allocated a sum of €310,000 to Wicklow County Council. Following advertisement of the scheme 26 applications were received. The applications when assessed have to be submitted to the Department of Rural & Community Development by 28<sup>th</sup> March 2018, with works on successful applications to be completed by Friday 29<sup>th</sup> July 2018.

#### **Community Involvement Scheme (CIS)**

Ring-fenced funding of €10 million is being made available for the Community Involvement Scheme in 2018 by the Department of Transport, Tourism and Sport for the country.

Wicklow County Council received 10 applications, 3 not qualifying and they have been sent to the Department of Transport, Tourism and Sport for to be considered for funding.


