#### 4. HOUSING SUPPLY - PROGRAMME OF DELIVERY

### Update on Kilbride Lane Social Housing Scheme, Bray, Co Wicklow

The situation regarding MDY Construction Limited, the contracting firm engaged to construct the 42 Social Housing units at Kilbride Lane in Bray is complicated from a legal and procurement perspective.

Wicklow County Council is obtaining advice from their legal team on how best to proceed to continue with the development of this project and further updates will be provided when more clarity on the situation is known. The Examiner already appointed by the High Court for MDY Construction is due back before the Court on Monday 22<sup>nd</sup> October. In the meantime, Wicklow County Council is providing 24 hour security at the site.

### **Turnkey**

#### 6. PPP SOCIAL HOUSING PROJECT

### [Bundle 1)

Development Site at Convent Lands, Wicklow for 51 Social Housing units. The Department of Housing has dedicated €300 million towards delivery of housing through the public, private partnership model in the Rebuilding Ireland Action Plan. Wicklow has been included as a project in Bundle 1. The Part 8 was passed by the members at the Council Meeting of 3rd July 2017. The project is expected to commence on site in December 2018.

### 7. APPROVED HOUSING BODIES (AHB'S)

Capital Advance Leasing Facility (CALF) - 5 units were provided under a CALF lease to Cooperative Housing on the Greenpark Road in Bray.

6 apartments (Abbey St. Wicklow) purchase completed by Tuath AHB.

Approval has been received from the Department of Housing, Planning Community and Local Government for a leasing arrangement with Cluid to provide 45 units of accommodation on the Council's site at St. Earnan's View, Ballybeg, Rathnew. Estimated delivery date of these units is quarter 4 2019. The AHB's are actively pursuing a number of other potential CALF projects and are liasing closely with the Council on a regular basis.

### Capital Assistance Scheme (CAS)

Purchase has been completed on 3 properties with Dublin Simon under the Capital Assistance Scheme in 2018 and 2 further properties have been agreed with Ark Housing. These properties will be allocated to households experiencing homelessness.

Expressions of Interest – Social Housing on Council lands - A preferred proposal has been identified.

#### **Homeless HAP**

The recent appointment in October of the Homeless HAP Placefinder is seen as a welcome and necessary addition to the Homeless Team.

The Homeless HAP Placefinder will provide assistance in:

- seeking out potential properties suitable for households currently identified as homeless or at risk of homelessness;
- liaising with specific households to establish their specific needs;
- establishing relationships with local property agents and landlords; and,
- supporting those homeless households to (a) prevent the necessity to enter emergency accommodation or (b) to exit emergency accommodation and secure a tenancy.

Two rental properties have been identified and tenancies completed to date in October through the Homeless HAP Placefinder service.

### **Sonas Facility, Wicklow** (Domestic Violence)

6 Adult (Female) & 10 children.

Sonas has advised that it is withdrawing services from Wicklow. The operation of the



facility is being tendered out to Approved Housing Bodies to operate the facility as a Family Homeless Hub. Current residents will be assisted into alternative accommodation with a dedicated support worker being assigned to this project.

### **Other Temporary Supported Accommodation**

Wicklow County Council owned properties in Wicklow, Bray and Arklow, leased to AHBs, provide 22 units of low to medium supported accommodation targeted to the particular support needs of the clients. There has been a significant number of move-ons from these properties, signalling the success of this model.

### **Housing First**

With Housing First, the priority is to support a person who has experienced homelessness into permanent housing as quickly as possible, without any preconditions around sobriety or mental health treatment. Then, continue working intensively with them on these issues once they are housed. Housing First recognises that a stable home provides the basis for recovery in other areas.

The National Implementation Plan for Housing First 2018-2021 was published in September 2018. It commits to the rollout of Housing First in every county in Ireland and sets annual targets for each local authority. It also highlights the need for local authorities and Approved Housing Bodies to work together on increasing the supply of single person housing. The alignment of housing and health supports means that Housing First is very much a joint initiative of the Department, the Department of Health, local authorities, HSE and NGO providers.

Wicklow County Council is committed to implementing the Housing First model and is currently liaising with Kildare and Meath County Councils to prepare tender for services.

In advance of this and to ensure robustness of numbers, an analysis of rough sleepers in County Wicklow is being undertaken which will inform the plan.

#### **Cold Weather Initiative**

A property in North Wicklow has been identified as suitable to implement a Cold Weather Initiative and negotiations are underway to secure this property.

# 12. SOCIAL INCLUSION COMMUNITY ACTIVATION PROGRAMME (SICAP)

### SICAP:

Local Community Development Committees have submitted their 2018 Case studies to Pobal and LCDC based on work to date. These reports currently under review by Pobal and LCDC.

County Wicklow Partnership is currently filling a new Enterprise & Employment Officer position which will enhance the delivery of these services in the Wicklow, Arklow and Baltinglass MD Areas.

Qtr 4 funding has been released to both LDC's totalling €328,264.

### **Public Participation Network (PPN):**

The PPN National Conference took place on 11<sup>th</sup> and 12<sup>th</sup> October in Athlone. Wicklow was well represented and the Wicklow PPN Resource Worker was a guest presenter. The development of "Community Well-Being" statements for each Wicklow MD area is continuing. See Wicklow PPN website for more details.

Wicklow PPN now has 230 registered groups.

### Katie Taylor Bursary 2018/2019

The Katie Taylor Bursary scholarship interviews took place on Thursday 18<sup>th</sup> October 2018 and Friday 19<sup>th</sup> October 2018. Wicklow LSP has 16 participants for the interview phase.

### **Sports Capital Funding**

The deadline for Sports Capital Funding was Friday 19<sup>th</sup> October 2018. Wicklow LSP made applications on behalf of 5 different clubs/organisations in County Wicklow which totals 8 applications altogether.

### 14. County Wicklow Arts Office

### **CREATIVE IRELAND PROGRAMME**

Ministers Josepha Madigan and Eoghan Murphy together with an Taoiseach Leo Varadkar launched the new Creative Ireland County Plans at the Irish Architecture Archive in Merrion Square. In an unprecedented Government line up for local cultural development these came together to herald further investment in the creative sector until 2022. In 2018 Wicklow County Council received from the Departments of Housing, Community & Local Government and Culture, Heritage and the Gaeltacht the amount of €111,000 for the Creative Ireland Wicklow Programme. The minimum investment for this programme in 2019 will be €116,000.

### **CREATIVE YOUTH IRELAND PROGRAMME**

An application was made to the Creative Ireland new Creative Youth Programme fund for a pilot investment of 100,000 in 2019. The application was a joint application of the Local Authority and KWETB which will be managed by KWETB if we are one of three successful applicants to the scheme. The programme would see the investment of €60,000 in capacity and programme building cultural measures for children and young people in our selected West Wicklow (Baltinglass MD) area.

#### **CULTURE NIGHT 2018**

2,500 people attended as audience and participants the WCC Culture Night Programme coordinated by the Arts Office on Friday 21<sup>st</sup> September. Wicklow County Council coordinated some 16 events throughout the county featuring music, film, readings, literature, and workshops.

### **Community Enhancement Programme 2018**

Annacurragh, Laragh and Roundwood are the 3 new playground sites.

# Opening of All-Inclusive Playground in Greystones

In Greystones, an all – inclusive playground was officially opened by Minister of Health, Simon Harris TD on the 08<sup>th</sup> of October 2018. The South Beach playground represents an investment of over €300,000. The playground was mainly funded by Wicklow County Council and the Greystones South Beach Playground Committee who raised an unprecedented level of funds for this project. There was also a generous contribution made by a local Greystones resident and a contribution from the Department of Transport, Tourism and Sport. The design of the playground equipment includes a musical play area, an ability swing, a sensory path, a toddler play area, a wheelchairaccessible sand factory, zip lines and a large activity set. This playground is designed for children to be together, play together and learn together.

This playground project was shortlisted by Engineers Ireland, for the 2018 Local Authority Engineering Initiative Award. The winner will be announced at the Engineers Ireland Excellence Awards on Friday, 9 November 2018.

### **ECONOMIC DEVELOPMENT, PLANNING AND INFRASTRUCTURE**

# 1. WICKLOW ECONOMIC THINK TANK (CWETT) ACTION PLAN/LOCAL ECONOMIC AND COMMUNITY PLAN (LECP) (ECONOMIC)

The Economic Development Unit of the Enterprise and Corporate Services Directorate is charged with implementing the economic actions in the Local Economic and Community Plan (LECP). Many of the 142 actions listed in the LECP have come from the County Wicklow Economic Think Tank (CWETT) Action Plan. The CWETT which was initiated in 2013 was a collaborative project initiated by Wicklow County Council and involved the business community from across the county and the County Enterprise Board (now LEO Wicklow).

### **FILM**

Wicklow County Council is in the process of developing a Masterplan for Wicklow County Campus, to develop the site as a creative Content/Film hub.

An application has been submitted to Enterprise Ireland under Stream One of the Regional Enterprise Development Fund. The project team made a comprehensive presentation to Enterprise Ireland in September. Funding announcements will be made in November.

### **RETAIL**

### **The Florentine Centre**

Work is well underway on the Florentine Site development. Wicklow County Council/Bray Municipal District has arranged alternative free town centre parking for the duration of the works. The pace of construction work has accelerated over the last month the basement frame is well underway, piling and temporary works are complete the project will see a rapid change in the coming weeks. The contractor and developer continue to liaise with local residents and adjacent businesses.

### **TOWN TEAMS**

Town Teams in Arklow, Blessington Greystones and Wicklow continue to meet on a monthly basis and to progress various projects.

Arklow Town Team CCTV committee has progressed the Community CCTV project to tender award stage. Grants have been awarded to 26 retailers in Arklow, under the Retail Painting Grant Scheme (subsidised by AMD, Dulux and Topline Bolands). The Lightship Lantern has been placed at the Roundabout at Junction 20. All 8 Roundabouts are now sponsored by local businesses. Arklow Town Team has been shortlisted in the annual Chambers Ireland Excellence in Local Government Awards. Plans are well underway for the second Spook - Tacular Halloween Festival in Arklow Town

Blessington Town Team will receive the results and recommendations of the Town Centre Health Check (funded under Town and Village Renewal Grants) at the November meeting. Work has been done to progress the application for funding for CCTV. This project has paused temporarily pending the resolution of an issue at national level. The funding application for Blessington Greenway has been the focus of the tourism group within Blessington Town Team.

Greystones 2020 is working with Greystones Municipal District on the Christmas Lights and the Christmas promotion which will be launched on 24<sup>th</sup> November. The Greystones 2020 website will be launched before the end of the year. An application for LEADER funding has been made in respect of a Public Realm Plan for Greystones.

Wicklow Town has been awarded Town and Village Renewal Funding for the lighting up of landmarks around the town. Wicklow Municipal District provided funding to engage a lighting designer to develop the design and the tender documents. A committee representing the Municipal District and the Town Team has been set up to drive this project forward

The membership of Bray Town Team is under review; Bray MD is liaising with Bray Chamber in this regard. The Bray Business Guide aimed at attracting new business to the town and assisting existing businesses has been launched. This is



available online also. A Business Guide, using the Bray model, will be developed for the other towns in conjunction with the Town Teams. A free public wifi project for Bray is being progressed at present this will be launched in 2019.

#### **TOURISM**

### **Tourism Strategy and Marketing Plan 2018-2022**

Our vision is to make Wicklow the number one choice for visitors seeking an idyllic escape that harmonises a wide range of outdoor pursuits in County Wicklow's world-class natural arena, while driving job creation in the local economy.

The strategy sets out a vision of what can be achieved in Wicklow, with clear priorities and a series of detailed actions and next steps to ensure the County is realising its potential over the next 5 years

The Key Priorities are

- 1. Develop New Accommodation
- 2. Develop Key Towns as Visitor Hubs
- 3. Develop a Masterplan for Glendalough
- 4. Grow Thematic Experiences
- 5. Market our County by Developing A Common Narrative

It is anticipated that these five actions identified above will help Wicklow push on to achieve the target of £200m in tourism revenue by 2023

### Glendalough

The Chief Executive is chairing a working group consisting of representatives of Failte Ireland, NPWS, Coillte and OPW, aimed at progressing the development of Glendalough as one of Ireland's premier visitor destinations. The aim is to enhance the visitor experience through improved interpretation, signage, facilities and access.

### **MARITIME**

### **National Marine Planning Framework**

Marine spatial planning is a process that brings together multiple users of the ocean to make informed and coordinated decisions about how to use marine resources sustainably. It is a process by which the relevant public authorities analyse and organise human activities in marine areas to achieve ecological, economic and social objectives.

Ireland's National Marine Planning Framework (NMPF) will be the key consideration for decision

makers on all marine consents. All applications for activity or development in Ireland's marine area will be considered in terms of its consistency with the objectives of the plan. It will therefore create the overarching framework for decision making that is consistent, evidence-based and secures a sustainable future for the marine area. Through extensive public involvement, it will offer everyone with an interest in our seas and coasts the opportunity to have a say in how their marine area is managed.

Officials from Wicklow County Council attended the regional launch of the National Marine Planning Baseline Report. The Baseline Report sets out the context for the development of National Marine Planning Framework. The public consultation process is open until **midday on 18<sup>th</sup> December.**, All those interested in maritime activities are encouraged to engage with the process.

### Maritime Strategic Review for County Wicklow

Wicklow County Council has recently advertised on e-tenders for consultants to develop a Maritime Strategic Review. The intent of the strategic review is to provide non-statutory guidance for uses and activities within the marine area and to assist Wicklow County Council and other statutory agencies with their policy formulation process as well as providing Wicklow County Council with a clear picture of its maritime area so that it is in a position to respond and provide input to higher level policy, where necessary. The Strategic Review will identify ways the economic base of County Wicklow could be strengthened through its ports and harbours and formulate recommendation for Wicklow County Council.

### **COMMUTER SURVEY**

From Monday 5<sup>th</sup> November Gamma Consultants will conduct a Commuter Survey on behalf of Wicklow County Council. Our objective is to capture the current level of commuting and the opinion of those commuters. Wicklow County Council will use this information to encourage the development of facilities such as enterprise hubs, co-working spaces and second sites to attract further investment into the county.

One of the aims of the Commuter Survey is to establish where the citizens of Wicklow are commuting to, what skill sets they possess and what



level of educational attainment they have. Another aim is to reduce carbon emissions created by increased commuting levels and become more environmentally friendly and sustainable. The ultimate aim will be to enhance the quality of life for citizens of Wicklow through a reduction in commuting, a better work/life balance and the provision of employment locally. The results of the Commuter Survey will be included in marketing

material for the promotion of Wicklow as the best place to do business.

The Commuter Survey will be widely publicised over the coming weeks. Commuters can complete the survey online at Wicklow.ie

### **HERITAGE**

Building Conservation Projects: All projects allocated funding by Wicklow County Council under the

Department of Culture, Heritage and the Gaeltacht's Built Heritage Investment Scheme (BHIS) and the Structures at Risk Fund (SRF) are underway. The heritage office is overseeing the completion of approved conservation works on eight projects. The allocations for county Wicklow are €50,000 (BHIS) and €24,000 (SRF) which will be recouped by the end of the year.

The Heritage office in association with the Wicklow PPN hosted a public event on the theme of Coastal Communities in Wicklow Town on 13<sup>th</sup> September. The event highlighted projects being co-ordinated by the Heritage Office through the Local Biodiversity Action Plan fund, including the Brittas Bay Management Report and related initiatives such as the Coastwatch Survey, activities of the LAWCO office and opportunities for funding under the Flag programme.

# Avoca Recycling Centre Pakman Awards Finalist 2018

Congratulations to the Avoca Recycling Centre on being shortlisted as one of 2018 finalists in the Community Recycling Project of the Year category for the Pakman Awards 2018. The Pakman Awards was launched in 2015 by Repak and are national awards that recognise excellence in waste management and recycling among businesses, organisations, community groups and initiatives in Ireland.

### WHITESTOWN REMEDIATION PROJECT

Wicklow County Council have now employed Fehily Timoney Company to advise on the remediation of the site at Whitestown, in accordance with the judgments of Mr Justice Humphreys. They are independent experienced Environmental Consultants. An initial meeting has taken place with the consultants and a steering committee has been formed to monitor progress on the remediation project.

### **PORTS & HARBOURS**

Improvements have continued in Wicklow & Arklow Harbours over the summer. Fendering works have been carried out along the quay walls in both harbours. A new engineer is expected at the start of September and she will progress other projects such as improvements to the upper deck of the East Pier and importantly replacing the mooring bollard on the Packet Pier in Wicklow. In Arklow, Arklow Marina Ltd. won the franchise to operate the 16 berth marina in Arklow.

### **Wicklow Harbour**

- Following on from works in 2017 Phase 2
  Repairs to Harbour Wall at South Quay
  commenced Mid September and were
  completed the first week of October. The
  cost of the works was in the region of
  €80,000 incl. VAT. Works funded by DAFM.
- Discussions are ongoing with tenders / contractors regarding the installation of a new bollard for tying up ships on the Packet Pier.
- New safety signage to be erected on the East Pier, Wicklow.

- Works to install two new ladders due to commenced in October. Project is funded by Inland Fisheries Ireland. Approximate cost €4,000 Ex. VAT.
- Swim Buoys were successfully removed from Wicklow Harbour on the 04/10/2018 and the Wendy Raft was taken out on the 18/10/2018.
- Process of putting together Bye Laws sanctioning the importation of Explosives through Wicklow Harbour commenced mid October. The byelaws will be drafted in consultation with the Dept. Of Justice, Equality and Law Reform.

### **Arklow Harbour**

- Notice regarding 6 wrecks / un-seaworthy vessels in Arklow Harbour published in Wicklow and Wexford People in September 2018. Owners were given 14 days to remove their vessels. One vessel was removed. Quotes currently been sought for the removal of five remaining vessels.
- Works to install two new ladders due to commenced in October. Project is funded by Inland Fisheries Ireland. Approximate cost €4,000 Ex. VAT.

### **EAST COAST GREENWAY TASK FORCE MEETING**

Minister Simon Harris, who opened up the proceedings, was responsible for inviting senior executives and all relevant bodies to the meeting. The Wicklow TD outlined his support for the project and commitment to seeing it through to a successful outcome. Mr. Frank Curran also expressed his support and commitment to fulfilling the crucially important project.

The meeting was attended by The Wicklow County Council, Irish Rail, National Parks and Wildlife, OPW, Fáilte Ireland, Wicklow Tourism, Sports Council, and the Chief Engineer from the consultancy firm WS Atkins – who have begun work on the feasibility study required to begin the project.

WS Atkins outlined the scope of work involved and expect to have their report by end of December for our next meeting in early January.

The ARUP consultancy firm, who were hired by Irish Rail, have begun work on the coastal defense plan that will provide the basis for the project.

The ARUP report is expected to be completed by August 2019.

The East Coast Greenway Group have expressed their gratitude to all who attended the meeting and look forward to working with them in the months ahead.



#### **SCHEMES ON THE N81**

### N81 Annalecky and Poulaphuca Crash Barriers

RPS Consulting are the Design Consultants for this commission. They have been appointed PSDP + Design for the works. The works involve the provision of a Crash Barrier at Annalecky Bend which has no crash barrier and the provision of a replacement barrier on the Wicklow side of the Poulaphouca Bridge. Barrier repairs along the N81 between the Wicklow County Council/Carlow County Council border and the Wicklow County Council/South Dublin County Council border are included. RPS is collating information supplied by Wicklow on barrier defects at this time. A tender competition for all of the works should be held later in the year. All information required has been transferred from Wicklow County Council to RPS Consulting.

### • N81 Knockroe Bend Realignment

The main Archaeological dig & excavation works are complete. Tender Documents are to be published at the beginning of October.

# • N81 Baltinglass Town Centre Surfacing Works

Progress continuing on design of layout for the N81/R747 junction. The current programme for the surfacing works at this location includes surfacing works in Section 2 (500 metre length on Main Street, either side of R747 junction) to be commenced at the end of September 2018.

### • N81 Small Scale Projects

- (i) Grant funding of €10k each has been allocated to progress schemes at Hangman's Bend, Irishtown, Tuckmill and Whitestown Lower for 2018. Revised submissions will be issued to TII early October for approval to progress the schemes.
- N81 2018 Pavement Works including Surface Restoration
- (i) Resurfacing at the combined site of Mullycagh and Tuckmill will commence at the end of September, waiting on Kilsaran to finalise staring date.
- (ii) Arkil Contracting have completed the pavement works at Hempstown to Kilteel and Rathattin to Athgreaney, some relining has to be completed.

### IT HELPDESK

- Workflow analysis of IT Helpdesk function has been used to develop a working model for customer care & case management processes.
- Tickets handled by IT Support have reached almost *6,945* in the year to date
- Asset Management Module has been implemented to allow performance monitoring across the network and prepare strategic deployment model for ICT Infrastructure. This was deployed to in identification of final list of PC's with a virtual xp client
- Updated Mobile Device Management (MDM) system is being deployed for all mobile devices. Roll out to existing estate will commence in October

### **CUSTOMER RELATIONS MANAGEMENT (CRM)**

- Business Process Modelling is underway in the Housing & Environmental Services Departments in preparation for development of customer care unit
- A Pilot of Office 365 is underway and a "Sandbox" has been created on Wicklow's Cloud Tenancy. This platform will be used

WICKLOW

- for in-house development and testing purposes
- A number of Dynamics licences have been provided to facilitate the next phase of deployment in Wicklow CoCo and cloud based systems are used in HR & Road Transportation directorates.

### MANAGED PRINT SERVICE (MPS)

- Renewal of MPS is complete following vendor neutral print audit and RFT of December 2017.
- Project roll-out plan was completed in Q1 2018 and all new devices are now in place
- Second Quarterly Review is now underway
- Managed Print Service policy is in place for all departments & MD's

### **UNIFIED COMMUNICATIONS**

- Voice over IP phone solution has been extended to most Council sites across Wicklow. This includes Municipal Districts and other sites such as Clermont Campus, Fire HQ and Library HQ.
- The VOIP system will underpin county wide communications, improved customer services and unified communications.

### **CORE NETWORK**

 Procurement of core and edge network hardware refresh is complete and Phase 1 of LAN upgrade was implemented in Q1 2018. Extension to other sites including Bray MD, Fire HQ, Library HQ, Clermont was completed during Q2 2018.

- A fully updated core network is now in place.
- Business case for connection to government networks and government cloud networks is underway
- Ongoing Network traffic analysis will allow identification of bottlenecks and load balancing.

### **DATA COLLECTION SYSTEMS**

- Data collection systems using mobile devices are currently in place for Register of Electors Fieldworkers. Currently 94.25% of Electors have an assigned EIRCODE.
- Projects in Housing, Roads and Environmental Services departments are on-going and integration to CRM systems is being developed.
- A new project to update and edit Wicklow's Storm Water Network more effectively is underway and includes off site data collection.
- Revenue Collectors Handhelds have been upgraded to Tablets to allow more efficient data transfers to the financial management system.
- Offsite data collections systems have been consolidated and applied to Housing Condition Surveys, Health & Safety Audits, CCTV surveys etc.
- Microworks which is an integrated GISenabled water quality and environmental management solution allows high quality services management and ensures compliance with national and EU Regulations.


