#### Restart Grant Plus Launched To Help Businesses Reopen & Get People Back to Work -

Applications to the Restart Grant Plus Scheme which gives financial aid to businesses to help them reopen, have opened in County Wicklow. The Restart Grant Plus is a key part of the government's July €7.4bn Stimulus package designed to stimulate a jobs-led recovery and build economic confidence while continuing to manage the impact of Covid-19.

Key changes to the Restart Grant Plus Scheme include:

- €300m additional funding in addition to €250m previously committed
- **Grant amount has increased substantially.** Minimum grant is now €4,000 and maximum is €25,000. Previous grant amounts were €2,000 and €10,000 respectively
- **Medium sized companies now eligible** Companies with up to 250 employees can now apply (previously the grant was for companies with less than 50 employees)
- Increased eligibility Non-rateable B&Bs, sports clubs with commercial activities and trading charity shops are now eligible

# €3.3 million Allocated by the NTA for Cycling & Walking Projects under the July Jobs Stimulus Plan - Wicklow has been allocated funding totalling some €3.342m covering 25 projects supporting pedestrian and cyclist movement and to enhance accessibility in towns and villages by the National Transport Authority.

The funding is to support local authorities' response to Covid-19 challenges and assist in equipping local communities and businesses with improved walking and cycling infrastructure. The funding will also allow for changes to traffic management arrangements to facilitate the reallocation of overall road space to improve facilities and safety for pedestrians and cyclists.

**Rural Regeration and Development Fund** – Newtownmountkennedy is to get an investment of nearly €500,000 The project is being led by Wicklow County Council and will design upgrades to the public realm, street landscaping, traffic management, public spaces and community facilities.

**Wicklow Gaol Wins Trip Advisor Award -** Wicklow's Historic Gaol has won a prestigious 2020 Trip Advisor Travellers' Choice - Best of the Best award.

Wicklow Gaol is now rated in the top 10 per cent of attractions worldwide. Prior to this Wicklow's Historic Gaol had received five consecutive Certificate Excellence awards from Trip Advisor.

#### **COVID 19 UPDATE**

The current pandemic has had a major effect on the programme.

Sites were closed for 7 weeks with 3 exceptions, which were allowed to re-open early (Convent Lands Wicklow, Farrenkelly Greystones and Whitehall Baltinglass. All sites are now open.

Progress is being monitored on site to establish any ongoing effects.

#### 7. PPP Social Housing Project

#### [Bundle 1)

Development Site at Convent Lands, Wicklow for 51 Social Housing units commenced on site in March 2019. The project is progressing well and is currently due for completion in June 2020.. The Department of Housing has dedicated €300 million towards delivery of housing through the public, private partnership model in the Rebuilding Ireland Action Plan. The Convent Lands site in Wicklow has been included as a project in Bundle 1.

Nominations for allocations have been advised to the Approved Housing Body operating the scheme.

#### **Capital Advance Leasing Facility (CALF)**

The Approved Housing Bodies are actively pursuing a number of potential CALF projects and are liaising closely with the Council on a regular basis. The members will be kept updated.

- Acquisition by AHB of 38 turnkey units via CALF in Arklow due by Q4 2020.
- Acquisition by AHB of 8 (Part V) units via CALF in Ashford due by Q4 2020. A further 4 units (2 turnkey and 2 Part V) due in 2021.
- Construction ongoing on a 40 units (including 4 Part V) via CALF Turnkey in Dunlavin.

#### **Capital Assistance Scheme (CAS)**

Wicklow County Council is continuing to support acquisitions under the Capital Assistance Scheme with Dublin Simon, Circle Housing, Ark Housing and Peter McVerry Trust.

**Expressions of Interest – Social Housing on Council lands -** A preferred proposal has been identified.

#### 8. Housing Schemes Remediation

#### Glending, Blessington - Remediation

Stage 2 and Stage 3 Phase 3A - No 1 to No. 12 Glending Road have been completed.

Stage 3 Phase 3B - Glending phase 3b is complete as of 18th December 2018.

#### **COVID 19 UPDATE**

The Homeless Team continues to provide key support by phone, working from both office and home. B&B proprietors currently retained by the Council are continuing to provide emergency accommodation for homeless clients. All Covid 19 protocols are in place in the facilities.

#### **Self Isolation Units**

A number of vacant houses being refurbished for reletting have been kitted out in anticipation of the need for families to self isolate for the required period from emergency accommodation.

#### Emergency Measures in the Public Interest (Covid-19) Act 2020

With effect from Friday, 27<sup>th</sup> March 2020, new emergency measures were introduced into law to protect tenants during the Covid-19 emergency period. In summary, a notice of termination cannot be served during the Covid-19 emergency period. All notices of terminations which were served before the emergency period are paused until end of June, and tenants in general cannot be obliged to leave their rented accommodation during this time.

The Mid East Region Homelessness Management Group has completed a brief analysis of the impact of the moratorium on evictions to date, on the extent of homelessness in the region and is recommending that the emergency measures pertaining to notice of terminations be extended, as a homeless preventive measure, with an exemption to be applied to termination notices that relate to rent arrears and/or antisocial behaviour.



#### **Cold Weather Initiative**

The Cold Weather Initiative, a partnership arrangement between the Council and the Dublin Simon Community, with the assistance of Five Loaves Homeless Services, opened on 14<sup>th</sup> November 2019, in Bray to provide emergency night shelter for homeless individuals.

Referral protocol is through Wicklow County Council, Dublin Simon, Five Loaves and the Gardai.

#### **COVID 19 UPDATE**

A new operational model has commenced at the Cold Weather Initiative to endeavour to achieve the necessary health and safety standards around Covid 19 protocols. Opening hours have been extended with a corresponding increase in staffing resources. Sanitary facilities have been increased and extensive temporary modifications have been introduced to ensure separation of beds and provision of secure isolation unit.

Due to the high risk to clients if there should be Covid + cases reported in the CWI, the Council is finalising plans to relocate the residents to another, more suitable facility, where 24 hour accommodation will be provided and adequate self isolation facilities will be available.

#### **Homeless HAP**

The Homeless HAP Placefinder provides assistance in:

- seeking out potential properties suitable for households currently identified as homeless or at risk of homelessness;
- > liaising with specific households to establish their specific needs;
- establishing relationships with local property agents and landlords; and,
- > supporting those homeless households to (a) prevent the necessity to enter emergency accommodation or (b) to exit emergency accommodation and secure a tenancy.

To date, 256 households (200 families & 56 singles) have been assisted under the Homeless HAP Scheme in Wicklow County Council from the inception on 1<sup>st</sup> October 2018 to 31<sup>st</sup> July, 2020.

123 homeless cases and 133 prevention cases to date. 85 properties were sourced by WCC.

#### **COVID 19 UPDATE**

The Homeless HAP Placefinder and the HAP team continue to progress cases. Key focus at present is on maintaining payments to landlords and reviewing differential rent of those clients who have reduced income during this time.



#### **Sonas Facility, Wicklow** - Transition to Family Homeless Hub.

Following the advice that Sonas was withdrawing services from Wicklow, the operation of the facility was tendered out to Approved Housing Bodies to operate and manage the facility as a Family Homeless Hub.

The successful tenderer was Dublin Simon Community, who will be in a position to commence operations and management of the facility pending finaisation of the legal handover.

#### **COVID 19 UPDATE**

Refurbishment work is substantially complete on the facility, initially providing self isolation units for vulnerable clients during the current crisis.

#### **Other Temporary Supported Accommodation**

Wicklow County Council owned properties in Wicklow, Bray and Arklow, leased to AHBs, provide 22 units of low to medium supported accommodation targeted to the particular support needs of the clients. There has been a significant number of move ons from these properties, signalling the success of this model.

#### **Housing First**

With Housing First, the priority is to support a person who has experienced homelessness into permanent housing as quickly as possible, without any preconditions around sobriety or mental health treatment. Then continue working intensively with them on these issues once they are housed. Housing First recognises that a stable home provides the basis for recovery in other areas.

Peter McVerry Trust has been appointed as the Housing First Programme Implementer for the Mid East Region and Wicklow County Council is committed to working with them to achieve the targets identified in the programme. Properties will be provided by both Wicklow County Council and Peter McVerry Trust for the programme.

Wicklow County Council has successfully accommodated 3 clients under Housing First. Other clients proposed for Housing First have been assessed by the team and are availing of key support work pending finalisation of accommodation.



#### 11. Wicklow Community Call

The Community Call continues to respond to requests for help from the public during the COVID-19 crisis, though the number of calls has decreased over the last few weeks. The helpline is now housed in the CC&SD section in Wicklow County Council.

The Community Response Forum, chaired by the Chief Executive Frank Curran, continues to meet fortnightly to oversee the community response, to exchange updates and information and to co-ordinate and enable cooperation. The forum has a number of statutory bodies, community organisations and community groups at the table. In addition the forum has identified and responded to two particular issues that have emerged as result of COVID-19. These are food poverty and digital poverty.

#### 12. Food Poverty Research

Food poverty has always been a feature of overall poverty but this issue was exacerbated by the COVID-19 shutdown and was highlighted as a problem through the Community Call Helpline. A subgroup has been set up under the umbrella of the County Wicklow Food and Beverage Strategy to look at the issue of food poverty and food sustainability. This group is conducting research at present, among responders and those at risk of experiencing food poverty. This is in order to get an accurate picture of the issues involved and the most appropriate responses to them.

#### 13. Digital Poverty Scheme

€44,900 has awarded, by Wicklow County Council, to applicants under the Digital Poverty Grant Scheme.

Digital equality is a theme of the County Wicklow Digital Strategy but like food poverty, has been highlighted recently. The Community Response Forum became aware that many crucial services are now being delivered online because of COVID-19 restrictions. However there has been a breakdown in access to these services by some because of a lack of digital equipment or wifi. Wicklow County Council, through the Community Response Forum, set up a fund aimed at enabling organisations to purchase vital equipment such as laptops and dongles that can be accessed by those in most need of them. The projects funded will achieve an impact in one or more of the following:

- Enabling on-line education, reskilling or training for disadvantaged groups
- Enabling online youth work/mental health interventions
- Support for vulnerable families
- Support for people with disabilities
- Support for those in Direct Provision
- Community outreach to vulnerable groups while social distancing
- Combating isolation for older people

A further four rounds of applications will be made in August and September.

#### 14. County Wicklow Library Services

#### **Capital Projects Update**

**Wicklow Library and Archives** is on target to be completed in 2020. Allowing for furniture fit out and stock, early Spring 2021 is a realistic opening date. The project, when completed, will be circa €6m, with €4m of this being grant aided from DRCD and URDF. The possibility of sourcing further URDF grants is being explored.

**Rathdrum** library lease is currently being finalised. During the initial 2 year lease period, there will be an option for Wicklow County Council to purchase for a set price of €400,000. It is anticipated that construction will be completed by early summer 2021.

**Baltinglass** courthouse and library is currently out to tender for initial investigative works on the building. The vision is for the adult library to be relocated in a tiered design in the current courtroom. The project is one of three approved for Baltinglass under RRDF grants. Grant aid of €600,000 was approved towards this element. The possibility of sourcing further RRDF grants is being explored for the project.

#### **Resumption of Library Services**

All of Wicklow County Council's 13 libraries had reopened to the public before the end of June. Throughout late May and early June, there was a gradual reintroduction of services. Allowing public access to library PCs was reintroduced in July. Like in other areas of society, the public have been slow to return to libraries. This is reflected, nationally.

The national issue figure for July is 469,097, down considerably from 1,155,941 in July 2019. This is just a little over 40% of last year's figure. Wicklow's stats are at 46% of those of 2019.

Wicklow accounts for 4.1% of the national total the July 2020 figure. This time last year we accounted for 3.5% of the national total. (Wicklow's population of 142,425 is 3% of national population of 4,761,865)

Despite the low total, statistics show Wicklow has nearly doubled our issues between June and July. With resumption of Saturday opening at the end of August, it is anticipated that a significant increase will occur in the coming months.

This is a combination of delivering books to villages on the Mobile Library route + door to door drop of books to people self-isolating, as identified by branch library staff. It is anticipated that the Mobile Library will resume in September.

Wicklow Sports and Recreation Partnership received €4,000 in funding from Sport Ireland for European Week of Sport which will be held and have events running on 23<sup>rd</sup> – 30<sup>th</sup> September 2020.

#### **Healthy Ireland County Coordinator**

A County Co-ordinator has been appointed in respect of the Healthy Ireland Programme and will take up duty on 31<sup>st</sup> August 2020.



# COMMUNITY ENHANCEMENT PROGRAMME 2020 – TRANCHE 2 COMMUNITY CENTRES AND COMMUNITY FACILITIES

Joe O'Brien TD, Minister of State for Community Development and Charities at the Department of Rural and Community Development, announced details of €5m funding for community centres and facilities under the July stimulus package on 10<sup>th</sup> August 2020. The funding will be provided under the **Community Enhancement Programme**, and is in addition to €2m provided under that programme earlier this year. This €5m funding will provide capital grants to help improve community centres, and other community buildings and facilities. This €5m funding will be administered through existing structures that are in place under the Department's Community Enhancement Programme. Funding will be allocated to each Local Authority area, and the Local Community Development Committee will administer the programme in each area. Wicklow has been allocated €150,438. The closing date for submission of applications is 5.00 p.m. on Thursday 15<sup>th</sup> October 2020.

The application form and guidelines have been circulated via email to the Members, all Wicklow Local Authority Staff and the PPN. Advertisements have been placed in the local papers and on the Wicklow County Council website. #### 18. Blessington eGreenway

As part of the investment and rejuvenation initiatives into Blessington and its environs, Wicklow County Council (WCC) will construct a 42.4 km greenway around the lakes of Blessington. The main route is a loop of 28.7 km around the Blessington lakes and the remaining 13.7 km will include links to nearby villages Valleymount, Ballyknockan & Lacken and spurs to Russborough House and Tulfarris Hotel & Golf Resort. This project will consist of walking and cycling trails, mostly through forest and woodlands adjacent to the shoreline of Poulaphouca Reservoir – more commonly referred to as the Blessington Lakes.

The greenway will link into the existing 6.5km trail to the south of Blessington Town which links the town with the Palladian Mansion at Russborough House. The lands on which the Greenway will be constructed are in the ownership of the ESB. A licence agreement between WCC and the ESB will be put in place to construct and operate the Greenway on these lands.

It is envisaged that the overall cost of this project will be in the region of €10 million, with funding of the sum of €5 million from the Department of Transport, Tourism and Sport and WCC contributing the remaining balance. The project will see significant job creation in the area as it is estimated that for every €1m of tourism revenue supports 27 jobs in the locality. In addition, it will cater for the growing tourist market for outdoor activities for both local residents and tourists alike. The Greenway development is an exciting and distinctive project for County Wicklow and the region and will become Ireland's first "E" destination.



#### **Status**

In October 2019, WCC appointed consultants, Aecom Ireland Ltd to progress the scheme to detail design stage. Over the last few months, site walkovers have been carried out by WCC and ESB personnel for most of the proposed 42.4 km route. An indicative route map of the greenway is attached.

It was originally proposed that the surface type of the greenway would consist of crushed stone. The proposal is to upgrade the surface type to tarmacadam, making for a more durable and smoother surface for cycling. With this change and other additional works required, it will be necessary to carry out further surveys and reports including an appropriate assessment screening report, an environmental report and an Ecological Report for a new planning submission. During the preparation of these reports and planning submission WCC will proceed with a 5km pilot section between Valleymount and Ballyknockan villages. This 5km pilot phase will check how construction is managed and its impacts on the locality.

#### **Next Steps to progress the project**

- The completion of the site walkovers with WCC and ESB personnel, which are scheduled for the end of August 2020.
- A tree felling licence application to the Department of Agriculture, Food and the Marine
- Construction of the Pilot Section (Valleymount to Ballyknockan length 5km). It is hoped that construction works could start in November / December 2020.
- The consultants Aecom will continue with the detail design of the following elements of the scheme
  - The remainder of the route (23km)
  - New Bridges
  - 5 existing car parks to be extended (including new macadam surface, lighting,
  - o toilets, electric charging points)
  - o Phase 1 (Pilot) Valleymount to Ballyknockan macadam surface.
  - Existing trail; Blessington to Burgage, to be up upgraded and widened with macadam surface.
  - Existing but unused Tunnel connection to Russborough to be upgraded
  - Links to nearby villages Valleymount, Ballyknockan & Lacken, Tulfarris Hotel and Russborough House
- Further surveys and reports including an appropriate assessment screening report, an
  environmental report and an Ecological Report for a new planning submission. These reports will
  include further assessment of the archaeology, biodiversity, ecology, water, landscape, visual,
  hydrology, and cultural heritage of this project.
- Public consultation with local landowners and community.



#### **Economic Development, Planning and Infrastructure**

1. Wicklow Economic Think Tank (CWETT) Action Plan Local Economic and Community Plan (LECP) (Economic)

The Economic Development Unit of the Enterprise and Corporate Services Directorate is charged with implementing the economic actions in the Local Economic and Community Plan (LECP). Many of the 142 actions listed in the LECP have come from the County Wicklow Economic Think Tank (CWETT) Action Plan. The CWETT which was initiated in 2013 was a collaborative project initiated by Wicklow County Council and involved the business community from across the county and the County Enterprise Board (now LEO Wicklow).

#### Retail

#### **Bray Town Centre**

Roof weathering works are progressing on the roofs of block 2 & 3. The roof structure for block one has been formed and the slating and weathering works have also commenced.

Lift installation is almost 80% complete and the installation of the travelators and escalators is scheduled to commence in the next 10 days. Mechanical & electrical works are progressing throughout blocks 2 & 3 and both levels of the car park. All M&E works are ready to be installed in the stairwells. Handrails for the stair cores have been agreed and fabrication has now commenced.

ESB and Gas Network Ireland have completed install and connection to the site.

The revised practical completion date is November 2020.

#### **Town Teams**

Town Teams in Arklow, Blessington, Bray, Greystones and Wicklow continue to meet on a monthly basis and to progress various projects. Due to the Covid-19 pandemic meetings with a number of community groups and other various stakeholders have been postponed to later dates. This may reflect in the updates below.

#### **Arklow Town Team**

Arklow Town Team has been granted funding by LEADER for the following projects:-

1. **SEAnanagins Seafood Festival** which is proposed to take place in conjunction with the World Shore Angling Championships in 2021. Events will include cookery demonstrations with local seafood, seaside themed workshops, beach activities and live entertainment. The festival will promote and attract visitors to the town.



2. Visit Arklow –To design and develop a new website specifically to promote Arklow Town and its environs.

Arklow Town Team, Arklow Chamber of Commerce and Wicklow County Council are fully committed to supporting the local business community in getting back up and running.

#### **Blessington Town Team**

The next meeting is scheduled to take place on 7th September 2020. The COVID 19 committee response group volunteers continue to provide support and assistance to potentially vulnerable neighbours.

The Blessington reopening committee continues to support the Wonderful West Wicklow campaign, to support local businesses and service providers.

#### **Bray Town Team**

The Bray Reopening Committee is a joint initiative with local stakeholders across the community, including members of Bray Chamber of Commerce, the Health Service Executive and An Garda Síochána to plan for a considered, responsible return to civic life which is vital to help to restart the local economy in the town. This is in line with the Government's phased roadmap for reopening the country socially and economically.

The Committee focused on understanding best practices, planning for protections and protocols that businesses and the community will need in place in order to feel confident about resuming activities, once the Covid-19 restrictions are lifted, while emphasising a message that as a society, we all have a collective responsibility to ensure that reopening proceeds smoothly and safely.

Topics the Reopening Committee considered included:

- Looking at workable solutions so that businesses can reopen safely from queuing in public spaces, delivery times to waste collection times
- Temporary changes in the town centre to make it safer and more spacious for pedestrians to
  encourage social distancing including looking at the feasibility of widening pavements,
  pedestrianised zones, putting up new signage, setting down two-metre marker dots to provide a
  'visual guide', removal of some on-street parking, the introduction of one-way systems, relocating
  bus stops and the removal of street furniture
- Business and public consultation
- A comprehensive communication strategy
- 'Shop Local First' marketing campaign
- Robust cleaning and maintenance regime



Promote positive mental health and wellbeing

#### **Greystones 2020**

The Think Local Buy Local campaign launched by Greystones 2020 has been a huge success. Over 350 businesses have now been listed on the Greystones.ie website. The WhatsApp group has seen a wide range of support and information been shared together.

The statistics for interactions since the **#ThinkLocalBuyLocal** campaign launched on June 24th to July 23rd are as follows:

- Twitter 50k
- Facebook 46.3k
- Instagram 22.7k
- Video content 597
- Website Visits: 3.6k / Page views: 8k
- Overall combined total = 131.2k

Since the **#ThinkLocalBuyLocal** campaign was launched back on June 24th, the first 30 days have achieved 39.96% of the total reach to date.

We will continue with our increased social engagement and will include:

- 1. Sharing important HSE and Government #StavSafe guidelines.
- 2. Highlight what Greystones 2020 are doing to help stabilise the local economy.
- 3. Highlight all relevant supports available in the Business Hub on the website
- 4. Help promote and support all types of enterprise by showcasing local businesses

#### **Culture Night:**

Greystones will host a drive in movie in the Park & Ride as part of culture night in conjunction with the Greystones MD and Wicklow Arts Office on Friday 18th September.

#### **Christmas Lights:**

Due to the burden already placed on business' over the past months, Greystones 2020 are exploring alternative ways to ensure that the funding is available for Christmas Lights in the town and are already working on a plan to ensure the town will be lit up as normal for the switching on ceremony on Saturday 21st November.

#### **Wicklow Town Team**

Wicklow Town Team held their meeting on the 15th July 2020 and a number of issues were discussed which included the Greenway, Parking in Wicklow Town, Heritage Trail, Illumination of Historical Sites and Leader funding applications. The Team are working on advancing these projects to completion. The next meeting of the Town Team is scheduled for 26th August 2020.



#### **Town Re-opening Committees**

Following the success of the Bray Re-opening Committee, Wicklow County Council proposed the establishment of re-opening committees in each Municipal District – the purpose of these committees is to support businesses as they re-open and to encourage members of the community to support local business.

Membership of the Re-Opening Committees consists of the MD Cathaoirleach (Chair), MD Manager, MD Administrator, MD Engineer, Chair of the Town Team, Representative of the Chamber of Commerce and An Garda Síochána.

A Town Team / Tourism recovery meeting was held in on 28th July 2020 with a number of ideas provided including identifying a number of 'visitor hotspots' around the County and setting up kiosks to get people to sign up to the 'Wicklow Passport' which will hopefully encourage people to visit other places in the County.

#### **Tourism**

#### **Tourism Strategy and Marketing Plan 2018-2022**

The strategy sets out a number of challenging but achievable priorities along with a series of detailed actions to be implemented over the next 5 years

#### The Key Priorities are:

- 1. Develop New Accommodation
- 2. Develop Key Towns as Visitor Hubs
- 3. Develop a Masterplan for Glendalough
- 4. Grow Thematic Experiences
- 5. Market our County by Developing A Common Narrative

A Tourism Implementation Group has been established to oversee these actions and drive all sectors towards helping Wicklow achieve the target of €200m in tourism revenue by 2023.

**Accommodation:** Fáilte Ireland has engaged Crowe Consultants to develop a Toolkit to help attract investment in accommodation. It is estimated that Wicklow requires an additional 175 Hotel Rooms over the next five years based on 4% growth, this is assuming that the additional 50 rooms that have extant planning permission are developed. The re-activation of the County Wicklow Accommodation working group is proposed for the end of July.



The County Wicklow Accommodation working group was re-activated at the end of July and met in the Brockagh Centre, Laragh. A number of ideas were raised and it is hoped to have a follow up meeting at the end of September.

**Destination Town Funding -** An application to Failte Ireland on behalf of Wicklow Town has been made in respect of Destination Town Funding. If successful this could result in funding of over €500k in respect of development of tourism amenities in the town.

**Key Towns as Visitor Hubs:** Fáilte Ireland has announced an investment of €15.5 million available through local authorities to boost the attractiveness and tourism appeal of towns across the country. Funding of between €250,000 and €500,000 will be available to local authorities to develop towns in their area which have the potential to become a 'destination town' for tourists. The 'destination towns' will need to demonstrate their capacity and appeal to attract more international visitors to stay overnight.

Fáilte Ireland has set aside up to €500,000 in Destination Town Funding for County Wicklow; Wicklow County Council is working on an application for funding under this theme.

#### Glendalough Masterplan and Wicklow Visitor Orientation Study

Failte Ireland, with its strategic partners OPW, NPWS with Wicklow County Council advertised for consultants to develop tourism Masterplan for Glendalough and the Wicklow Mountains National Park and a Visitor Orientation Plan for County Wicklow. Consarc consultants have been appointed.

#### **Thematic Experiences**

**Tracks and Trails** - Wicklow County Council have engaged the producers of Tracks and Trails to redevelop some of the existing programmes for use on the Wicklow.ie website and social media and also to develop shorter tracks and trails videos aimed at internet viewers, airlines and traditional media.

The Bray Head to the Great Sugarloaf Trail was launched via Facebook in July. Similarly the Tinahely Looped Walk will be launched in the coming weeks. It had been intended to hold an outdoor event to mark this launch; however recent additional Covid 19 restrictions make it less likely.



**Wicklow Passport**: A Wicklow Passport aimed at encouraging locals and visitors to explore Wicklow have been introduced by the Wicklow Tourism Alliance. Passport holders can collect various Wicklow Stamps and discover the activities, attractions, and hospitality on offer across the county. Loosely based on the 'Camino Passport' in Spain, the Wicklow Passport is a series of stamps that can only be collected at the respective towns or villages represented on each stamp. For example, you can only get the Shillelagh stamps at stamping locations around Shillelagh.

The Wicklow Passport can be purchased for €2 online at <a href="http://visitwicklow.ie/passport">http://visitwicklow.ie/passport</a>. Or can be collected free-of-charge from participating stamping locations, or through the Wicklow Libraries at Bray, Greystones, Arklow and Blessington. The list of stamping locations is available at <a href="http://visitwicklow.ie/passport">http://visitwicklow.ie/passport</a> by clicking on each icon.

**Eco Trail**: Unfortunately this year's Eco Trail edition has been cancelled due to Covid 19. It's obviously a huge disappointment but following from latest safety guidelines, it was impossible to safely run the event. There was very strong communication for the event though, with approximately 1550 registered runners, almost 500 more than last year. This shows the amazing interest that the event has generated for its second edition, and proves the viability of the event for the future. Furthermore, Ecotrail has generated an amazing level of interest for the destination and the sport here in Ireland and abroad.

It is intended to continue to use the Ecotrail platform to showcase our county as a fantastic outdoors destination.

**Covid 19**: Failte Ireland, Wicklow County Council, LEO Wicklow are providing a range of supports and advice for tourism providers and are following all advice and guidelines set out by NPHET and the Government.

#### **Rural and Urban Regeneration Development Fund Grant Applications**

There are currently three 2018 URDF projects underway; Arklow Historic Town Core, Wicklow Library and Fitzwilliam Square and the Bray Public Transport Bridge. URDF applications were also submitted in May 2020 for the Regeneration of the Arklow Quays, Bray Harbour Regeneration and the regeneration of Wicklow's Waterfront.

With regard to the RRDF applications, Wicklow County Council was awarded funding to develop the public realm in Newtownmountkennedy. A new round of RRDF funding has been announced with a closing date 1st December 2020.



#### **Climate Action**

Climate Action Applications have also been submitted in respect of Wicklow and Arklow Harbours aimed at ensuring both harbours can benefit from development of the offshore wind energy industry.

The Wicklow harbour application was submitted to apply for funding to develop the physical infrastructure in Wicklow harbour in order to accommodate crew transfer vessels servicing the offshore wind sector.

Similarly the application in respect of Arklow is to facilitate servicing of the offshore wind industry and to investigate the possibility of developing enterprise units for small businesses engaged in marine activities. Offshore wind has a cross governmental mandate secured through the delivery of the Climate Action Plan targets of 3.5 GW of offshore wind by 2030.

#### **Maritime**

#### **Maritime Strategic Review for County Wicklow**

The Strategic Review will identify ways in which the economic base of County Wicklow could be strengthened through its ports and harbours and formulate recommendation for Wicklow County Council.

#### Key Recommendations:

- To maximise the Offshore Wind Opportunity
- To investigate the feasibility of a new harbour facility at Wicklow
- Aquaculture Support
- Marketing Strategy for County Wicklow as a Coastal Tourist Destination

The Strategic Review is at the core of the applications for Climate Action and URDF funding.

#### **Maritime Business Development Group**

An Aquaculture working group has been established to work with industry experts and investigate the proposal to restore natural oyster reefs off the coast of County Wicklow.

The MBDG held their last meeting on 23<sup>rd</sup> July 2020 at which a presentation was given to the group by a delegation from the Codling Wind Park.



#### **FLAG Funding**

Wicklow County Council has supported applications for FLAG funding in respect of the Native Oyster Reef Restoration project and also in respect of a Wreck Fishing proposal.

The Native Oyster Reef Restoration (NORRI) project is a plan to establish self-sustaining native oyster habitats in the Irish Sea, in collaboration where possible, with Wind Energy and Coastal Defence Development. A workshop is planned for the end of March to publicise this project.

The Wreck fishing FLAG is an application supported by the Maritime Business Development Group. It is a proposal aimed at surveying current wreck fishing sites and eventually attracting leisure type fishing in these areas.

Approval has been granted for funding in respect of the Wreck Fishing project and the project is underway.

#### **Food and Beverage Strategy**

Wicklow County Council was awarded Leader funding for the implementation of the Food and Beverage Strategy.

#### Progress to date:

- The Wicklow Naturally Brand has been established
- WicklowNaturally.ie website has been developed
- 70 Producers have been signed up
- A draft strategy for the development of a Food Hub has been prepared this is due to be followed up by a survey of food producers
- The formal launch of Wicklow Naturally will be held on 6<sup>th</sup> October, (subject to Covid 19 restrictions)
- A range of promotional events, tastings etc has been planned for October under the banner
   October Feast, however this is under review in the light of current restrictions.



#### 2. Local Enterprise Office (LEO)

Applications to the Restart Grant Plus Scheme which gives financial aid to businesses to help them reopen, have opened in County Wicklow. The Restart Grant Plus is a key part of the government's July €7.4bn Stimulus package designed to stimulate a jobs-led recovery and build economic confidence while continuing to manage the impact of Covid-19.

#### **LEO Objectives**

To foster an enterprise culture and stimulate enterprise at local level by:

- Promotion of the enterprise message at local level.
- Working with the relevant stakeholders in the county to foster entrepreneurship.
- Delivering appropriate enterprise training and mentoring to entrepreneurs.
- Providing funding options to entrepreneurs, early stage promoters and viable businesses to support growth and development of micro enterprises.
- Developing a progression pathway for clients to Enterprise Ireland
- Acting as a 'First Stop Shop' for business information and referral

#### **Forward Planning**

# Regional Spatial & Economic Strategy for the Eastern and Midlands Regional Assembly 2019-2031 & Metropolitan Area Strategic Plan

The new Regional Spatial and Economic Strategy (RSES) for the Eastern and Midland Region (EMRA) came into effect on the 28th June 2019. This was subsequently subject to a Ministerial direction which was confirmed in January 2020. The final RSES and accompanying documentation is available at the following link: https://emra.ie/final-rses/

The requirement for a **Metropolitan Area Strategic Plan (MASP)** to be prepared for the Dublin metropolitan area as part of the RSES is set out in Project Ireland 2040 – National Planning Framework (NPF). The MASP provides a 12 to 20 year strategic planning and investment framework for the Dublin metropolitan area.

A MASP implementation group has been formed, with 'terms of reference' and governance structure agreed by the Regional Assembly in May 2020. The Implementation Group, whose function is to oversee progress on the implementation of the Dublin MASP, offers an opportunity for enhanced spatial coordination of land use planning and strategic infrastructure delivery in the Dublin metropolitan area. The Implementation Group will drive strategic housing, employment and regeneration opportunities that are identified in the MASP in tandem with the delivery of key public transport, enabling infrastructure and metropolitan scale amenities, in order to achieve targeted population and employment growth as set out in the accompanying RSES and NPF.

The membership of the MASP Implementation group comprises representatives from each of the seven metropolitan local authorities, the Department of Housing Planning and Local Government (DHPLG) and key infrastructure, transport and enterprise agencies.

#### **County Development Plan Review**

Notice to review the current County Development Plan 2016 - 2022 and prepare a new County Development Plan 2021 - 2027 was given on the 6th November 2019.

Closing date for submissions was Friday 10th January 2020.

156 submissions were received. All of the submissions are available to view on the website.

The First Chief Executive's Report was issued to the Elected Members on Friday 12<sup>th</sup> June 2020. This Report forms part of the statutory procedure for the review of the existing plan and the preparation of the new plan. There is an item on the agenda for the September meeting to consider the First Chief Executive's Report prepared under Section 11 (4) of the Planning and Development Act 2000 (as amended) regarding the review of the County Development Plan and to consider any directions regarding the preparation of the Draft County Development Plan 2021 – 2027 proposed by the members under Section 11(4)(d) of the Planning and Development Act 2000 (as amended)

#### **Climate Action**

An Implementation plan with actions from the Climate Adaptation Strategy and the Climate Charter are being developed by a task group of which M Cahill is a member. The draft Implementation Plan (guidance and templates for all LAs) will be submitted to environment committee of the CCMA for approval and rollout.

Pilot training for Climate Action Officers is being held in October and WCC County Council's Climate Action Officer will attend and will provide feedback to the CARO

#### Priority Action items:

- Installation of EV Charging points in Greystones. Considering the pros and cons of a pilot scheme to install a number of chargers in South Beach Car Park, near the council offices.
- Tree Policy to be drawn up for the County. Initial consultation underway and internal meeting on 9<sup>th</sup> June to progress this. – Three consultants were invited to tender to compile the Policy however none of the parties were interested in tendering – alternative options are now being considered
- Community Woodlands: All sections are asked to identify public lands which could be suitable for community woodlands. CARO will issue guidance on this project which is being funded by the DAFM.
- LIFE2020 funding application for Sustainable Flood Protection in the Upper Avoca Catchment. Awaiting response from County Wicklow Partnership on whether they are willing, and have the resources, to be involved in the management of this application.

#### **Environmental Awareness**

Environmental Services continued to support National Spring Clean after it was rescheduled due to Covid 19. Clean up kit was provided to participating groups and collections organised for the bagged litter.

The Relove fashion competition piloted successfully in 2019 in partnership with Meath, Westmeath and Dublin City Councils and the Rediscovery Centre in Ballymun was relaunched for 2020. Six more local authorities joined the competition which is a Wicklow County Council initiative, The focus is on producing wearable clothing design



and good use of skill with textiles will be strengthened in the competition to develop circularity skills among students in textiles and fashion. Schools were notified about this year's competition so teachers can incorporate it into their planning for the year

Work has continued with the Wicklow PPN to explore the development of a mapping tool to record projects and actions that deliver on the Sustainable Development Goals. A first draft of the map was developed inhouse by the IT section.

A project to fund the collection, repair and shipping to Africa of old bikes is to be funded under the Anti –Dumping Initiative. The Rotary Club, Bray is a partner in the project. Planning for the August event commenced. Bike repair workshops with the Rediscovery Centre are also planned.

A new tree grant has been developed as a climate action to facilitate more planting of trees by local groups in County Wicklow.

Wicklow County Council worked with Laois, Meath and Westmeath to develop an online version of the Stop Food Waste Challenge which was delivered by video on social media. Catherine Fulvio was the presenter for the four week series of videos which features some of her recipes as well as tips and advice on avoiding food waste. The first two videos were broadcast in July with the first video achieving over 10,000 views.

The EPA put out a call for projects under the Local Authority Prevention Network, LAPN. Two applications for funding were submitted by Wicklow County Council. The first was a project to develop composting solutions for the management of the high levels of grass production which must be lifted when green space is being managed for pollinators. This project will help to facilitate Wicklow County Council's commitment to designate spaces for pollinators. The second project is a joint initiative with six regional local authorities to undertake a campaign to facilitate and promote sale of recycled paints produced by the Rediscovery Centre in Ballymun. The project aims to establish localised collection points for recycled paint purchased online and provide a social media campaign to promote the product. Wicklow is the lead local authority for the project.

The annual Tidy Towns, Estates and Environmental Awards were launched at the beginning of July with a closing date set for the end of July for groups to submit applications.

#### **Recycling Centres**

Wicklow's 5 Recycling Centres are now working at almost normal capacity; some reductions remain in opening hours to facilitate additional cleaning of the centres. Social distancing markings have been painted on the ground and in buildings.

Anti-Dumping Initiative 2020:

WCC was granted approval for 5 projects under the Anti-Dumping Initiative 2020. Total value of the approvals is €54,495. The projects approved are:

- Tackling the increased dumping at bottle banks during the Covid-19 lockdown restrictions. Value €6,045
   This project will use CCTV to identify people/cars dumping at particular bottle banks that have seen a significant amount of dumping during the current lockdown.
- 2. Mattress amnesty Bray. Value €24,500

  There have been a significant number of mattresses dumped throughout the county this year. This project will provide an outlet for the public in the north of the county.
- 3. Mattress Amnesty Arklow. Value €17,100

  This project will provide an outlet for the public in the south of the county.



4. Preventing dumping at Charity Shops. Value €4,200

Dumping outside charity shops is an issue on the rise in each of the towns. This project will purchase CCTV cameras that WCC can deploy outside any charity shop where dumping is an issue.

5. Bikes for Africa. Value €6,650

WCC is working with the Rotary Club of Bray to collect, repair and ship bikes to Africa in County Wicklow. Bikes that have been dumped or abandoned will be gathered by WCC and given to the Rotary Club. The Rotary Club will repair these and ship them to Gambia. The regional waste office in Dublin is planning environmental waste awareness campaigns for the region.

#### Lifeguards

The Lifeguard season commenced on the1st June. Lifeguards are present on Bray South Promenade, Greystones, Wicklow Harbour, Brittas Bay North, Brittas Bay South and Arklow. Lifeguards are present on these beaches from 11am to 7pm daily.

#### Caravan Park Season

Caravan Park owners were written to in March 2020 and informed not to open due the Covid-19. Under the Government's accelerated roadmap to reopening Ireland, caravan parks reopened on June 29th. Applications have been received and all parks are being run in line with government guidelines.

#### **Whitestown Remediation Project**

Wicklow County Council have employed Fehily Timoney & Company to advise on the remediation of the site at Whitestown, in accordance with the judgments of Mr. Justice Humphreys.

- Priority Geotechnical Limited completed site Investigation on Friday 13<sup>th</sup> September and factual report received in January 2020 - results of the site investigation will inform the proposed remediation plan which is scheduled for completion in November 2020.
- Website is up and running and regular updates will be made to keep the Public and Members informed of progress.
- Environmental risk assessments as per EPA guidance document and a draft remediation plan are currently being carried out.

#### Harbours and Ports

Eleven cargo vessels berthed in Wicklow Port during July 2020. Nine were importing forestry products five with timber and four with logs. Two ships exported scrap metal.

There was one marine notice in July.

Contracts were awarded for the following:

- Supply and installation of navigation lights on the North and South Piers, Arklow.
- Supply and installation of new fenders and railings on the East Pier, Wicklow.
- Supply and installation of new ladders on the North and South Quays. Wicklow.

A request for quotations was sought for the provision of solar powered LED lighting on the East Pier, Wicklow.

The Wicklow County Council Roads Direct Labour Crew have commenced resurfacing works on the East Pier.



#### **Pollution Control**

#### Pollution Response & Investigation

- 4 Water pollution complaints were received and investigated.
- 1 Noise Pollution complaints were received and investigated.

### **Private Water Supplies**

- 8 Private water supplies to caravan parks were monitored and were found compliant with microbiological standards.
- 8 Private water supplies to caravan parks were monitored and 1 was found non-compliant with chemical standards and water supplier requested to take remedial action.
- 1 Boil Water Notice was lifted from a Private Drinking Water Supply after remedial action had been taken and satisfactory water quality sample results obtained.

## Deco Paints and Solvent Regulations

5 Dry Cleaner and 5 Vehicle refinisher (car spraying) installations were inspected.

Septic Tank Inspections - National Inspection Plan 2020

• 5 Septic tank inspections were carried out – 2 compliant, 3 non-compliant and 3 advisory notices were issued to rectify the non-compliances.

Water Framework Directive National Monitoring Programme

- 6 Lakes were monitored involving 14 samples taken for checking compliance with environmental quality standards
- 14 Rivers were monitored at 19 station involving 121 samples for compliance with environmental quality standards.

## **Bathing Water Monitoring Programme**

There are 6 designated bathing waters, 4 of which fly Blue Flags\*, which will be monitored 10 times through the season until 15<sup>th</sup> September. Results for July are shown below. Poor results were obtained for Clogga Beach and Wicklow Harbour Lifeboat Area on 27<sup>th</sup> July associated with rainfall events and bathing prohibition notices were issued upon HSE advice on 29<sup>th</sup> July. Subsequent sampling returned excellent results and the prohibition notices were lifted on 31<sup>th</sup> July.

A revised water grant scheme is now in operation effective from date of issue of Departmental Circular. This financial assistance is towards the improvement of water supply which is not wholesome or clean or is not sufficient to meet the domestic needs of a household in the opinion of the Housing Authority.

There are 3 categories of grant are available for houses of 7 year and older, a 100% treatment grant of €1,000, rehabilitation grant for pumps/well protection of 85% cost up to € 3,000 and a new well grant of 85% of cost up to € 5,000. 3 quotations for each grant category of work are required from tax compliant contractors.

The cost of sampling/testing the quality of the well where treatment is required may only be included under the treatment grant. The cost of testing the quantity of a well may be included under the new.



#### **Arklow Flood Relief Scheme**

The Office of Public Works (OPW) and Wicklow County Council have commissioned Byrne Looby PH McCarthy (BLP) and Arup to undertake engineering and environmental studies respectively to assess and develop a viable, cost effective and sustainable Flood Relief Scheme for the Avoca River, Arklow.

The process of identifying a preferred scheme to address fluvial and coastal flooding in Arklow includes a detailed assessment of a range of flood risk management measures to determine their technical, economic, social and environmental viability.

Following a detailed scheme options assessment process, the series of measures that will make up the emerging preferred flood relief scheme for the Avoca River, Arklow have now been identified.

A number of changes in design have resulted in the need to update the Public realm drawings which is presently being done expected completion: in the next few weeks. Possible disposal options for the dredge material are currently being investigated.

Following the confirmation of the preferred flood relief scheme an Environmental Impact Statement will be prepared and submitted to An Bord Pleanala.

Initial meeting with the foreshore section of the Department of Housing Planning and Local Government has taken place.

## N81 Knockroe Bend Realignment Scheme

Traffic is now diverted onto the new alignment of the N81 at Knockroe Bend Realignment and scheme is progressing.

There are still traffic lights at the north end of the project to enable the last part of the tie-in to be constructed. Speed limits are still in place until completion of the works.

### **Car Parks**

Two new car parks have been opened during Covid 19 at Laragh and Luggala which are improving accessibility and amenities in our beautiful county to allow the public to avail of parking.

Laragh car park is beside the GAA grounds in Laragh- opening hours 8.00 a.m. to 8.00 p.m. all week

Luggala car park - opening hours at weekends only from 9.00 a.m.

#### M11/N11 Junction 4 to 14 Improvement Scheme

Site Surveys and Field Walk over works recommenced on Monday 18th of May, these include:

Topographical Survey, Biodiversity and Road Safety Audit Stage F.

The Arup Design Team are progressing the Preferred Options Assessment Report. Tenders awarded recently include: the appointment of GVA Donal O'Buachalla as Property and Land Valuation Consultancy Services for Phases 2 through to 4.

#### N11 Kilmacanoge Parallel Service Road

Surfacing works commenced on August 4th along the southbound carriageway to enable the switching of traffic onto the new lane as part of Phase 2 Traffic Management and Phase 2 Construction Works.

Phase 1 works are on programme to be complete at the end of August with works then switching the verge side of the southbound carriageway.

## **Road Schemes**

**Blessington Greenway** - Alignment of trial section completed, with Tree Felling License to be submitted by ESB for trial. Remainder of route to be agreed with ESB.

**Glendalough Junction** - Ministerial Consent for Archaeological Assessment & Alignment Drawing complete. This project will be progressing to Ministerial Consent for Construction.

Ballinaclash Junction - Consultant has been appointed and layout agreed. Ongoing progression.



**Bray Public Transport Bridge** – Ground Investigation Works underway (originally delayed due to COVID 19). Detailed design proceeding through consultants.

**Arklow Courthouse Refurbishment** - Refurbishment works anticipate completion date Quarter three.

**Arklow Public Realm** – Ground Investigation completed. Detailed design and tender document preparation ongoing.

**Fitzwilliam Square** - Phase 1 Monument Area "65% complete, boundary wall and railing complete, paving within monument area commenced, soft landscaping commenced, planter walls ongoing.

Phase 2 Church Street Upper "70% complete, paving and kerbing ongoing.

Phase 3 Church Street Lower "10% complete, services installed.

Phase 4 Bridge Street 10% complete services installed.

**Baltinglass Town Centre Plan** – Arup appointed as Consultants. Aim to construct playground/river walk element in 2020.

Delgany / Blacklion Road Improvements - Detailed design finalised.

**Blessington Inner Relief Road** – Progression of scheme ongoing. Section 85 agreement will be required with Kildare County Council.

**Arklow to Shillelagh Greenway** - Consultant engaged to undertake the bridge design, flood risk assessment, planning report to accompany the NIS planning submission to An Bord Pleanala.

**Strand Road Aquarium & Putland Road -** Detailed Design Completed. Tender process complete, with contract to be awarded over the coming weeks.

**Kilmacanogue to N11 / Southern Cross Greenway** - EIA and Archaeological survey commenced. GI/Topo surveys due to commence shortly, pending site access.

Framework for Traffic Management N11 Fassaroe - Draft finding report and recommendations completed.

**Swan River Greenway** - Constraints Study & Options Report completed. Community Engagement not possible over recent months due to COVID 19, Working Group to be formed and workshops to be organised once safe to do so under Covid-19 restrictions.

**WPAR to Wicklow Train Station** - Documents completed to procure consultant. Tender to issue once NTA Framework in place.

#### **Water Services**

In 2020 Wicklow County Council staff continued to provide Water and Wastewater Services under the current Service Level Agreement (SLA) with Irish Water.

### Covid 19:

All staff in the Water Services Department, technical, outdoor and administrative staff continued to work throughout the Covid 19 period and whilst some non-essential work was put on hold during this period, there was no interruption to supply and services throughout the crisis. Full operational services across water and wastewater have now been restored.



## **Upgrading Projects:**


Throughout 2020 upgrading works continued across Water Services. The current projects in progress include:


- Back yards Kindlestown and Upper Grattan Park.
- Replacement of 2.1m water main in Ashford.
- With €450k allocated to pressure management between now and the end of the year.

## Sustainability:

Sustainability continues to be a key concern of both Wicklow County Council and Irish Water, with Wicklow County Council staff playing a key role in locating and managing leaks throughout the county. Under the Find & Fix Project, Wicklow County Council staff has carried out repairs saving 3.8 mega litres of water per day in 2020.







#### **Key Performance Indicators (KPI's):**

Under the Annual Service Plan with Irish Water, Wicklow County Council continued to be scored on Key Performance Indicators. The 2019 overall score was 87.1%. In 2020 the KPI performance score for Quarter 1 was 93.9% and for Quarter 2 was 95.5%. This reflects the excellent performance of Wicklow County Council staff across all pillars within the Annual Service plan. The overall score for Wicklow County Council is comprised of a range of KPI scores over the year, including:

- A score of 100% was achieved for microbiological compliance in the drinking water supply.
- A score of 99% was achieved for chemical compliance in the drinking water supply.
- A score of 100% was achieved for the number of compliant assessments taken at Waste Water Treatment Plants meeting mandatory UWWTD effluent quality standards.
- A score of 92% was achieved for the notification of interruptions.
- A Score of 97% was achieved for a timely response to Workflow Queries.
- A Score of 99% was achieved for Financial Operations Expenditure Control.

There were **72 incidents** attended during the month of July 2020. Fire Stations were mobilised on a total of **101 occasions** including 2 incidents in neighbouring counties.

Operational activity for the month of July was similar to the preceding month (June 2020 – 101 mobilisations). Activity for the month was down 14% on the equivalent month last year, July 2019. This was due mainly to a decrease in alarm activations and outdoor fires.

01/07/2020 Rathdrum and Wicklow Town crews attended an RTC in Ballinaclash. 2 casualties taken by ambulance.



07/07/2020	Baltinglass and Dunlavin crews attended a domestic fire in the Glen of Imaal.
13/07/2020	Tinahely and Carnew crews were mobilised to a house fire on Mangan's Lane, Tinahely. Empty house extensively damaged by fire.
13/07/2020	Arklow and Wicklow Town crews were mobilised to an RTC south of Brittas Bay. Head on collision between car and motorbike.
17/07/2020	Arklow and Wicklow Town crews were mobilised to an RTC in Arklow Town. Single car had struck and damaged railway bridge.
25/07/2020	Wicklow Town and Rathdrum crews were mobilised to an RTC at the bridge in Rathdrum. There was one fatality.
26/07/2020	Bray and Greystones crews attended a domestic fire in Albert Walk, Bray. One casualty removed by ambulance from the scene.

## Kildare (1-incident)

31/07/20 Dunlavin Fire Crew were mobilised to a Fire Alarm Activation in Kilcullen, County Kildare – false alarm.

## Wexford (1-incident)

13/07/20 Arklow Fire Crew were mobilised to support Gorey Fire Station at a suspected vehicle fire near Inch in County Wexford.

## General

Firefighter Jason Keogh (Carnew) received national media coverage for his development, production and free distribution to front line workers of plastic clips to attach the loops of facemasks behind the head, making wearing them more comfortable.

Station Officer Derek Ryan (Dunlavin) completed over 600 deliveries to vulnerable members of his local community since the introduction of restrictions. Firefighters in Greystones also provided a similar service.

All stations have received the latest guidance from Wicklow County Council in relation to Covid-19 and each station has been assessed, ongoing measures are in place to ensure compliance.

All stations have resumed Weekly On-Station Training. It is also used to update members on a weekly basis if additional guidance or protocols have been issued.

Plans are underway with other Fire Training Centers and the National Directorate for Fire and Emergency Management on the resumption of Fire-fighting Skills (Recruit), Breathing Apparatus Wearers and Officer Courses commencing August/September. Wicklow County Fire Service will have a major role to play in setting a standard national approach for this training.

#### **Civil Defence**

## 12<sup>th</sup> August 2020

- At approximately 1840hrs a member of the public requested Civil Defence assistance through Garda to use drone to find a horse that was believed to have fallen into an inaccessible area.
- Drone unit and vehicles arrived on scene at approximately 2000hrs.
- Drone was launched and horse was located via thermal imaging camera at the bottom of a very steep gully in thick brush and swamp/marsh/water which looked very inaccessible by foot. Footage of horse showed that the animal was still alive.
- Call made to try and access horse with a vet on foot, Incident Support Vehicle and team called to assist.
- After an hour of trying to gain access to horse on foot it was determined only way to access the horse was via ropes from the top of the field.
- Due to fading light and no rope equipment CDO contacted 999 and requested assistance from Coast Guard with rope unit.
- Coast arrived on scene at approximately 2230hrs.
- Vertical access systems were set up by Coast Guard rescue team, drone team using thermal imaging was used to direct vet and rope access team to injured horse.
- Horse was Euthanised and both teams packed up equipment.
- At approximately 0100hrs Field debrief conducted between Civil Defence and Coast Guard.

 Wicklow Civil Defence took delivery of New Ford Ranger from Civil defence HQ in Roscrea adding to the units vehicle response capability.



# 20<sup>th</sup> August 2020

- Wicklow Civil Defence requested to respond to assist with reports of 3 persons in the water in Rathdrum by Coast Guard, Dublin Civil Defence and Kildare Civil Defence also requested to assist.
- Persons located before Civil Defence Units Arrival to assist other responding units.

#### **Register of Electors**

The Franchise staff are continuing to work on database maintenance required to maintain the Register of Electors. Letters are continuing to be issued to electors to establish whether they are still resident at the address which they are registered and the replies are being updated onto the Register or forwarded to other local authorities for registration at new addresses as required.

RFA forms are also being issued to new estates that have come on stream since February 2020. Contact has also been made with Nursing Homes in the County to update their Disabled Special Voters List. It is hoped that when Covid-19 restrictions are lifted, we can continue with our planned engagement with the Older Persons Network with a view to contacting electors who are still living at home, but unable to visit a Polling Station for health or mobility reasons, to be issued with a Disabled Postal Vote. We are also looking at the feasibility of contacting year heads in schools to register students who will reach 18 on or before 15<sup>th</sup> February 2021 taking Covid-19 restrictions and regulations into account.

Due to the Covid 19 Emergency and restrictions there will be no Fieldworkers carrying out work on the Draft Register of Electors for 2021/2022.

#### **Refurbishment Works**

Works are continuing in the County Buildings -

- New floors are currently being laid in the foyer area.
- Public toilets are being tiled and fitted over the next few weeks.
- Painting is ongoing in the area.
- Works have commenced refurbishing the Seminole room.

#### **Customer Service Innovation Hub**

- New security glass is due to be fitted next week on the main Counter of the hub.
- Works have commenced to refurbish the Planning/Environment and Housing counter areas.

### **Phase 1** of the refurbishment:

- The New Customer Service Innovation hub is scheduled to be completed towards the end of August/beg of September.
- Completion date for the full project including the Council Chamber is scheduled for December.
- Holding the first Council meeting there in January (if Covid 19 restrictions are lifted).



#### Communication

Communication has been a vital tool in our organisation, especially over the challenging last few months. Due to the need for us all to maintain social distancing alternative methods of holding and administrating meetings had to be introduced. Various technologies such as Microsoft Teams, Zoom and Cisco WebEx have been tested and deployed throughout the organisation, depending on the business need.



**Six Month Rates Waiver:** A 100% waiver of commercial rates will be applied for a 6-month period from 27 March 2020 to 27 September 2020 to all ratepayers except a small number of categories. The waiver will be applied as a credit in lieu of rates for the 6-month period covered in 2020. The excluded categories are mainly utilities, banks, large supermarkets and corporates.

There is no application process required for this scheme. Wicklow County Council will automatically apply a 100% credit in lieu of commercial rates, for a six-month period, to classes and categories of occupied rateable property where the occupying business is not in an excluded category. In the event that a business qualifies for the six-month credit in lieu of rates and the business has already paid their full rates bill for 2020, a refund or credit will be arranged by the Council.
