This month:

• €80,000 ALLOCATED TO 50 COMMUNITY GROUPS WORKING ON COVID-19

Almost €80,000 has been distributed by Wicklow County Council to 50 groups who are supporting their communities across the county during the COVID-19 emergency. Each county in the country received a grant from the Department of rural and Community Development to assist Community and Voluntary groups involved in the delivery of COVID -19 community response efforts.

Amongst those sharing the grant in Wicklow are:

- 9 groups providing meals to those in need
- 8 sporting organisations aiding
- 9 groups supplying face masks for frontline staff
- 5 groups offering technology support
- 4 groups providing PPE (Personal Protective Equipment)

The other groups involved provide a mix of assistance such as transport, financial advice etc.

• Wicklow Naturally launches website to showcase the county's finest producers

A website, which highlights Wicklow's food and drink producers has been launched by the new food and drink network, Wicklow Naturally. The website, wicklownaturally.ie tells the story of food and drink producers and promotes the businesses selling the county's produce.

The network, created following the publication of the Food and Beverage Strategy, which was launched at Killruddery Estate in April 2019, stands for sustainability, best practice, authenticity and demonstrates the pride people share in The Garden of Ireland for food and drink produced in Wicklow.

Wicklow Naturally is a partnership between the Local Enterprise Office Wicklow (LEO), Wicklow County Council and County Wicklow Partnership (CWP) and is being implemented through LEADER funding.

• RESTART GRANTS AVAILABLE FOR SMALL WICKLOW BUSINESSES

Applications for the Government-backed Restart Grant Scheme are invited by Wicklow County Council from small businesses across the County. Under the €250m scheme, micros and small businesses can apply for grants of between €2,000 and €10,000 to get their businesses up-and-running again.

The scheme is being administered by Wicklow County Council and grant applications can be made online through the Council's website, <u>www.wicklow.ie</u>.

Eligible businesses who have stayed open throughout the crisis, as well as those who are reopening under Phase 1 (from 18th May) and Phase 2 (8th June) of the Government's Roadmap for Reopening Society and Business, are encouraged to apply now for the Restart Grant.





The applications will be prioritised for payment by the Council based on the roadmap phases.

To avail of the Restart Grant, applicants must be a commercially rateable business and:

- 1. Have an annual turnover of less than €5m and have 50 or less employees;
- 2. Have suffered a projected 25%+ loss in turnover from 1st April 2020 to end June 2020;
- 3. Commit to remain open or to reopen if it was closed;
- 4. Declare the intention to retain employees that are currently on The Temporary Wage Subsidy Scheme

7. PPP Social Housing Project

[Bundle 1)

Development Site at Convent Lands, Wicklow for 51 Social Housing units commenced on site in March 2019. The project is progressing well and is currently due for completion in mid 2020. The Department of Housing has dedicated €300 million towards delivery of housing through the public, private partnership model in the Rebuilding Ireland Action Plan. The Convent Lands site in Wicklow has been included as a project in Bundle 1.

Capital Advance Leasing Facility (CALF)

The Approved Housing Bodies are actively pursuing a number of potential CALF projects and are liaising closely with the Council on a regular basis. The members will be kept updated.

- Acquisition by AHB of 38 turnkey units via CALF in Arklow due by Q4 2020.
- Acquisition by AHB of 8 (Part V) units via CALF in Ashford due by Q4 2020. A further 4 units (2 turnkey and 2 Part V) due in 2021.
- Construction ongoing on a 40 units (including 4 Part V) via CALF Turnkey in Dunlavin .

Capital Assistance Scheme (CAS) Wicklow County Council is continuing to support acquisitions under the Capital Assistance Scheme with Dublin Simon, Circle Housing, Ark Housing and Peter McVerry Trust.

Expressions of Interest – Social Housing on Council lands - A preferred proposal has been identified.

Stage 2 and Stage 3 Phase 3A - No 1 to No. 12 Glending Road have been completed.

COVID 19 UPDATE

The Homeless Team continues to provide key support by phone, working from both office and home. B&B proprietors currently retained by the Council are continuing to provide emergency accommodation for homeless clients. All Covid-19 protocols are in place in the facilities.

Self-Isolation Units

A number of vacant houses being refurbished for re-letting have been kitted out in anticipation of the need for families to self-isolate for the required period from emergency accommodation.

Cold Weather Initiative

The Cold Weather Initiative, a partnership arrangement between the Council and the Dublin Simon Community, with the assistance of Five Loaves Homeless Services, opened on 14th November 2019, in Bray, to provide emergency night shelter for homeless individuals.

Referral protocol is through Wicklow County Council, Dublin Simon, Five Loaves and the Gardai.

COVID 19 UPDATE

A new operational model has commenced at the Cold Weather Initiative to endeavour to achieve the necessary health and safety standards around Covid-19 protocols. Opening hours have been extended with a corresponding increase in staffing resources. Sanitary facilities have been increased and extensive temporary modifications have been introduced to ensure separation of beds and provision of secure isolation unit.

Due to the high risk to clients if there should be Covid + cases reported in the CWI, the Council is finalising plans to relocate the residents to another, more suitable facility, where 24 hour accommodation will be provided and adequate self-isolation facilities will be available.

Homeless HAP

The Homeless HAP Placefinder provides assistance in:

- seeking out potential properties suitable for households currently identified as homeless or at risk of homelessness;
- liaising with specific households to establish their specific needs;
- establishing relationships with local property agents and landlords; and,
- supporting those homeless households to (a) prevent the necessity to enter emergency accommodation or (b) to exit emergency accommodation and secure a tenancy.

To date, 232 households (178 families & 54 singles) have been assisted under the Homeless HAP Scheme in Wicklow County Council from the inception on 1st October 2018 to 30th April, 2020.

116 homeless cases and 116 prevention cases to date. 79 properties were sourced by WCC.





COVID 19 UPDATE

The Homeless HAP Placefinder and the HAP team continue to progress cases. Key focus at present is on maintaining payments to landlords and reviewing differential rent of those clients who have reduced income during this time.

Sonas Facility, Wicklow - Transition to Family Homeless Hub.

Following the advice that Sonas was withdrawing services from Wicklow, the operation of the facility was tendered out to Approved Housing Bodies to operate and manage the facility as a Family Homeless Hub.

The successful tenderer was Dublin Simon Community, who will be in a position to commence operations and management of the facility pending finaisation of the legal handover.

COVID 19 UPDATE

Refurbishment work is substantially complete on the facility, initially providing self isolation units for vulnerable clients during the current crisis.

Other Temporary Supported Accommodation

Wicklow County Council owned properties in Wicklow, Bray and Arklow, leased to AHBs, provide 22 units of low to medium supported accommodation targeted to the particular support needs of the clients. There has been a significant number of move ons from these properties, signalling the success of this model.

Housing First

With Housing First, the priority is to support a person who has experienced homelessness into permanent housing as quickly as possible, without any preconditions around sobriety or mental health treatment. Then continue working intensively with them on these issues once they are housed. Housing First recognises that a stable home provides the basis for recovery in other areas.

Peter McVerry Trust has been appointed as the Housing First Programme Implementer for the Mid East Region and Wicklow County Council is committed to working with them to achieve the targets identified in the programme. Properties will be provided by both Wicklow County Council and Peter McVerry Trust for the programme.

Wicklow County Council has successfully accommodated 2 clients under Housing First. Other clients proposed for Housing First have been assessed by the team and are availing of key support work pending finalisation of accommodation.



11. Community Cultural & Social Development

WICKLOW COMMUNITY CALL

The Wicklow Community Call centre started operations on Tuesday 31st March 2020 and is based in the Arklow library. It is open seven days a week from 8am to 8pm. The Call centre is staffed by CCSD and library staff. The centre was set up with a special Helpline and dedicated email – which is open every day from 8am to 8pm – is available to elderly and vulnerable people who need urgent assistance at this time.

Up to and including the 6th May 2020 the call centre had dealt with over 675 calls.

- 209 cases related to collection and delivery of shopping.
- 373 cases related to information/volunteering
- 24 cases related to social isolation and supports
- 12 cases related to meals and delivery of same
- 7 cases were Garda related
- 51 cases were medical or health related.

A CRM system and a Mapping system were developed by the IT section to streamline the functions of the helpline. Each case is logged on the CRM (customer relations management) tool and followed up if needed. The community responders are mapped to make it easy for helpline staff to connect people in need with someone to help them.

There are a huge number of volunteers linked to the community call including a number of GAA clubs, tennis clubs, Meals on Wheels, Tidy Towns, Order of Malta and the Irish Red Cross (Wicklow branch). Volunteers have completed a range of tasks including dog walking, grocery deliveries, prescription collection and other services.

The community response has been overseen by the County Wicklow Community Response Forum, chaired by the Chief Executive of Wicklow County Council, Frank Curran.

The overall objective of the Community Response Forum is to contain COVID-19, minimise its impact and facilitate the most appropriate community response to the needs of vulnerable people living in the community where their usual sources of support become unavailable.

12. Covid-19 Emergency Response Fund

The Department of Rural and Community Development allocated €78,414 to County Wicklow, through the Local Authority, under the COVID-19 Emergency Fund. The aim of the fund is to provide funding to the community groups and organisations that are directly involved in the community response to the COVID-19 pandemic. The funding is intended to cover expenditure related to the COVID-19 response activities. Over 40 applications were received and the payments are currently being made to successful applicants.

13. Local Sports Partnership (LSP)

"GET ACTIVE AT HOME"

Wicklow Sports & Recreation Partnership created an exercise activity booklet "Get Active at Home" which is targeted at those cocooning at home. These exercises can be completed in the comfort of your own home. The booklets have been distributed through various groups throughout the county such as Meals on Wheels, Community Groups, Garda Stations and Municipal Districts. The activity booklet has been distributed to more than 1,000 people in Wicklow and is available from the Sports Partnership. If you would like a copy posted out, please e-mail wicklolsp@wicklowcoco.ie Thank you to 'Meals on Wheels' who have distributed the leaflets to a huge number of people cocooning throughout Wicklow.

HSE GRANT

Wicklow Sports & Recreation Partnership has received a grant of €7,000 from the HSE to provide physical activity opportunities for those suffering from Mental Health and Long Term Illness.

ACTIVE HOME WEEK - 27TH APRIL TO 1ST MAY 2020

Active Schools week was substituted to Active Home Week for primary schools around Wicklow. Wicklow Sports & Recreation Partnership made contact with primary schools to inform them of #AHW running from 27th April – 1st May. Skill Challenges were posted on our social media platforms. These challenges were delivered by Áine O'Gorman (FAI Football Player), Jackie Kinch (Co. Wicklow GAA Player), Aidan Kearney (Development Officer Leinster Rugby) & Emer Kelly (previous Katie Taylor Bursary Winner & Surf Lifesaving Athlete). Schools/ parents taking part in our Skill Challenges were asked to tag us on Facebook or on Instagram taking on the challenge with a sport equipment pack up for grabs. Schools also took part in our one million step challenge as part of #AHW.

14. Social Inclusion Community Activation Programme (SICAP)

Both SICAP Programmes in Wicklow have pivoted their plans to support the new and evolving needs of disadvantaged individuals, voluntary groups and communities during the Covid-19 pandemic. SICAP supports are now being provided by telephone, email and video conferencing. Some SICAP courses are still being provided for clients using online conferencing technology.



15. County Wicklow Public Partnership Network (PPN):

County Wicklow Public Partnership Network is participating in WCC's Community Support Response to Covid-19 Forum and in Wicklow Community Champions meetings.

The PPN is developing Covid-19 Resources Pages on PPN website and acting as a central point for Covid-19 local and national supports information and is also progressing a Mental Health and Well-being online training module.

16. County Wicklow Library Services

Online Library Activities

Wicklow County Council Library Service has responded to the Lockdown by finding new ways to service its thousands of users.

All of the libraries closed to the public on March 13^{th,} but the staff wanted to remain as relevant as possible to patrons during this time.

"Right To Read" Campaign

"Spring Into Storytime" is usually part of the "Right To Read" campaign and usually the month of April is dedicated to emphasising the importance of story time sessions for children and parents. With the buildings closed to the public, library staff have recorded themselves reading picture and chapter books and making simple crafts in their own homes or from their back gardens. The stories have been delivered in Irish, French and English and so far have been collectively viewed almost 8,000 times on Facebook during the month of April. Staff have also linked up with local pre-schools and set up Zoom Story Times: an arrangement between the preschool operators and the librarian.

Music Generation Wicklow

Music Generation Wicklow produced podcasts have been shared on Facebook where people can learn to sing and play popular tunes. This is proving very popular with people cocooning or just at home due to the restrictions who have been practising or learning to play an instrument.

Borrowbox

The Borrowbox Book Club facility is also very popular. This has been set up using title on the library's ebook and audiobook resource where multiple copies of titles have been made available. Patrons download the book in either format and engage in a discussion via Zoom and the librarian. There has been a great interest in this virtual book club as it provides the perfect platform for people who love to read and then share their opinions and feelings about the current book. Borrowbox is a resource in use for many years by the library service but the pandemic restrictions have seen a huge increase in usage – Wicklow County Library Service has seen an almost tripling in usage since mid-March with almost 5,000 people actively using these resources.





Compose a Limerick

An invitation to compose a limerick and submit it be viewed on Facebook was hugely popular with adults and children alike – and a month later the library service is still getting submissions.

Wicklow poetry lovers are feeling a bit deprived because of the shutdown. To bridge this gap, Wicklow Libraries have partnered with Poetry Ireland and been given permission to publish archived work by Irish poets on social media, thus giving enthusiast, as well as general public, access to this valuable material.

Reopening of Libraries

Libraries have been listed in Phase 2, with a phased reopening planned from 8th June onwards. Emphasis is now turning to plans to ensure safe compliance with regulations for both staff and public. This is being carried out with direct consultation with Local Government Management Association (LGMA) and Wicklow County Council management and library staff. The national model is looking at initially providing a "click and collect" model, where the public will pre-order stock and collect it from the library door, without having access to the library building. A phased roadmap is provided by LGMA, which will be adhered to.

17. County Wicklow Arts Office

ARTIST GRANTS 2020

Artist grants were assessed and awarded for 2020. The categories of funding were Arts Groups / Organisations, Arts Festivals and Individual Artist Award Schemes. Given that with Covid-19 most of the activity of arts groups was not feasible as proposed, a redistribution of funding towards artist proposals which could be realised was agreed. Artists were awarded approximately 30,000.00 for applications which met the criteria. The Artist Award Scheme panel was independent, facilitated by Artist / Arts Manger Lian Bell, chaired by Jenny Sherwin Arts Officer and assessed by Artist Neil Martin and Arts Manager / Organisational Consultant Janice Mc Adam. The Arts Groups / Organisations and Arts Festival applications were assessed by the same panel which comprised of Katherine Zesserson Mouthful UK and Martin Drury Arts Consultant. The panel was chaired by Jenny Sherwin and Managed by Susan Coughlan Organisational Behaviour Consultant. The total funding awarded was in line with the provision in the 2020 budget process, approximately 3,000 was awarded to Arts Groups / Organisations and 15,000 to Arts Festivals. ARTISTS CONNECT PANEL

The new Wicklow Arts Office Artists Connect Panel which was established in late 2019 as an action under the Arts Strategy 2020 - 2025 took their business online to Zoom. The panel made recommendations on resources which were helpful to artists right now as well as beginning to reprogramme the planned artist talks and development initiatives to be rolled out by Wicklow County Council in 2020 in light of the impact of Covid-19. The panel will continue meeting every six weeks and the Arts Office will put in place a number of new resources to support artists responding to the current crises.

ARTS STRATEGY 2020-2025

The Arts Strategy 2020 - 2025 was adopted by the members of Wicklow County Council at their April meeting and a quotation has been sought for the design of the document. It will be available online both



in English and Irish from the end of June 2020. Publication of the document will be paused due to the Covid-19 pandemic.

ARTS PROJECTS AND PROGRAMMES RESTRUCTURE DUE TO COVID-19

Restructuring of Arts Projects and Programmes in light of the impact of Covid-19 took place. This meant the postponement or cancellation of events from the end of April onwards in line with the advice of NPHET and the Government. Prior to the last week, the Way with Words Literature Festival between the Arts Office and Library Service had in excess of 1,000 children and adults participate in writing workshops, readings, performances and events in Blessington Library, Arklow Library, Baltinglass Hospital and a variety of Schools. Artists included Niall de Burca, Christine Dwyer Hickey, Dermot Bolger, Miss Pink, Niamh Boyce and many more.

CRUINNIÚ NA NÓG

Early development of Cruinniú na nÓg took place with plans in place for a virtual Cruinniú na nÓg pending the national approval to proceed with the day. Cruinniú na nÓg is the national day of creativity for children and young people under the Creative Ireland Programme and supported by RTÉ. Last year 5,000 Wicklow children and families took part. This year it is imagined that Wicklow Council will run a series of initiatives online which reflect the local authorities Culture Team in Arts, Libraries, Film and Heritage services.

MOUTHFUL UK

Mouthful UK (<u>www.mouthfulway.co.uk</u>) commenced their three - year residency programme to develop community choral activation in Wicklow and to promote singing for well being, creativity, health and development. The a Cappella Group will make a number of visits over the course of the three years and will work with choirs, community groups, schools, direct provision centres and supporting children with complex needs. Alongside participation, quality of singing and accessibility are key. The group has performed from Glastonbury in the UK to Brazil - and almost everywhere in between!

18. Age Friendly Initiatives

"LET'S PLAY IRELAND"

Let's Play Ireland is a whole of Government campaign led by the Department of Children and Youth Affairs to promote the importance of play and to provide play resources for families during this time. The campaign is supported by a web page on Gov.ie <u>https://www.gov.ie/en/campaigns/lets-play-ireland/</u> and by the twitter hashtag #letsplayireland.

The aim of the initiative is to highlight the importance of play for children, particularly in the challenging time and to provide information and resources for families to support their children's play. The campaign will run throughout May and June in conjunction with the overall Government campaign on Wellbeing. Every Wednesday new resources will feature on the website across a range of themes including; Early Years, Playful Families, Storytelling; Playful Learning, Active Play, Creative Play and Play to Support Well Being.

This week new resources on playful families and playful parenting feature on the website; <u>https://www.gov.ie/en/publication/lets-play-families/</u>. Thank you in particular to Dublin City Children and





Young People Services Committee and Tusla for allowing us to share their resources on playful parenting.

The initiative is by no means intended to create another pressure for parents, rather the opposite, it intends to provide positive messages to parents about just allowing their children to play and supporting a positive environment for this. The website provides information on

- Why play?
- playing in a crisis,
- ideas for play,
- playful families,
- screen time as part of play and
- useful links and resources.

The Department of Children and Youth Affairs has worked with key experts across various sectors, Early Years, Education, Health, Local Authorities, Academic Partners in UCC and Mary Immaculate College, Creative Ireland, Tusla and others, in order to develop this resource.

TOGETHER APART - COLLECTING WICKLOW 2020 STORIES

A new initiative from Wicklow County Council is setting out to create a "People's Archive" to capture and share photos, stories and experiences of Wicklow life 2020 and all are invited to participate. Whether home cocooning, remote working, home-schooling children or providing an essential service to keep society functioning, the "Together Apart: Wicklow 2020 Stories" will record these experiences.

For many, being compelled to "Stay Home to Stay Safe" has awakened a new curiosity in local heritage, history and nature; others have learned new skills, rediscovered creative talents and taken up new hobbies. Whether it is queues at your local supermarket, yoga in the kitchen, wildlife in your garden or proud baking achievements, your photographs and first-hand observations can really capture the moment and create a powerful record for future generations. Restrictions around funerals have been particularly difficult at this time and the archive would be privileged to publish tributes to those who have passed.

People of all ages are invited to participate by sending photographs, stories, drawings, poems, sketches, anecdotes, articles and observations. All content received will be archived and shared on our online community heritage website <u>www.heritage.wicklowheritage.org</u>. Economic Development, Planning and Infrastructure

1. Wicklow Economic Think Tank (CWETT) Action Plan Local Economic & Community Plan (LECP) (Economic)

The Economic Development Unit of the Enterprise and Corporate Services Directorate is charged with implementing the economic actions in the Local Economic and Community Plan (LECP). Many of the 142 actions listed in the LECP have come from the County Wicklow Economic Think Tank (CWETT) Action Plan. The CWETT which was initiated in 2013 was a collaborative project initiated by Wicklow County Council and involved the business community from across the county and the County Enterprise Board (now LEO Wicklow).

Retail

Bray Town Centre

This project was delayed earlier in the year due to weather, and in more recent times due to Covid 19. The developer has indicated that it will take some time to fully mobilise, an updated programme is awaited. Similarly an updated report on negotiations with anchor tenants is awaited.

Town Teams

Town Teams in Arklow, Blessington, Bray, Greystones and Wicklow continue to meet on a monthly basis and to progress various projects. Due to the Covid-19 pandemic meetings with a number of community groups and other various stakeholders have been postponed to later dates. This may reflect in the updates below.

Arklow Town Team

An application for a community project was submitted under the Bank of Ireland – Begin Together Fund.

Arklow Town Team continue to research and identify individual projects that will positively impact Arklow as a place in which to live, work, visit and invest.

Blessington Town Team

Blessington Town Team would like to acknowledge the efforts of all the volunteers who are assisting the most vulnerable in our community during the current crises as part of the Blessington Town Team Covid 19 Community Response group. These volunteers continue to give selflessly to provide a much needed service to the community of Blessington and surrounding areas. Blessington Town Team are encouraging everyone to shop local and support local businesses in these difficult times. The Town Team acknowledges the work of Blessington and District Forum in partnership with the ESB in reopening the Blessington Greenway on the 18th May. The Greenway is being reopened for the benefit of the local



community and users are asked to adhere to the guidelines. Extra signage been added at all entrances to remind people of what is expected.

Bray Town Team

A Zoom meeting took place last week with the Bray MD Members in relation to the Town Centre Health Check. A discussion took place on how to progress some of the recommendations and it was agreed that at the next Bray Municipal District Meeting a strategy on the Public Realm recommendations would be agreed.

Greystones 2020

Greystones 2020 are holding regular meetings remotely and are focussing on how best to promote, encourage and facilitate business locally. A number of initiatives have been discussed and agreed which Greystones 2020 hope to progress over the coming weeks, including a Local is Best campaign and branding. The focus is on signposting supports for local business, and highlighting local businesses offering goods and services via the Greystones.ie website.

Wicklow Town Team

A constructive meeting of the Wicklow Town Team Tourism group, along with the Heritage Officer, Council Officials and local historian John Finlay took place on the online platform, zoom on the 30th April to further progress Wicklow Towns Heritage Trail.

The Town Teams development of the Towns Heritage Trail is a joint initiative with Wicklow County Council and Wicklow Municipal District.

The Heritage Trail will include various points of interest around the town with each having an audio/visual QR link.

To help develop the audio/visual QR link, a recent appeal was advertised inviting young people between the ages of 6-18 to share their stories and to record a short 1-2 minute podcast or video telling the story (in their own words) of the history of any of the historical sites in Wicklow Town which include:

- St Patrick's Church
- The Abbey Grounds
- Captain Robert Halpin
- Town Hall/ Market Square
- Billy Byrne
- The Black Castle
- Travelahawk Beach and Saint Patrick
- Barrow Green
- Wicklow Gaol

Each entry is to be submitted by email to wicklowheritage@gmail.com with "Wicklow Heritage Trail Stories" in the subject line, by Friday 5th June 2020 at 5pm. The winning submission for each site will



receive Wicklow Town Vouchers to the value of €50 each. Winners will be invited to participate in making a video based on their entry for inclusion in the Heritage Trail.

Tourism

Tourism Strategy and Marketing Plan 2018-2022

The strategy sets out a number of challenging but achievable priorities along with a series of detailed actions to be implemented over the next 5 years

The Key Priorities are:

- 1. Develop New Accommodation
- 2. Develop Key Towns as Visitor Hubs
- 3. Develop a Masterplan for Glendalough
- 4. Grow Thematic Experiences
- 5. Market our County by Developing A Common Narrative

A Tourism Implementation Group has been established to oversee these actions and drive all sectors towards helping Wicklow achieve the target of €200m in tourism revenue by 2023.

Accommodation: Fáilte Ireland has engaged Crowe Consultants to develop a Toolkit to help attract investment in accommodation. It is estimated that Wicklow requires an additional 175 Hotel Rooms over the next five years based on 4% growth, this is assuming that the additional 50 rooms that have extant planning permission are developed.

Key Towns as Visitor Hubs: Fáilte Ireland has announced an investment of \in 15.5 million available through local authorities to boost the attractiveness and tourism appeal of towns across the country. Funding of between \in 250,000 and \in 500,000 will be available to local authorities to develop towns in their area which have the potential to become a 'destination town' for tourists. The 'destination towns' will need to demonstrate their capacity and appeal to attract more international visitors to stay overnight. Fáilte Ireland has set aside up to \in 500,000 in Destination Town Funding for County Wicklow; Wicklow County Council is working on an application for funding under this theme.

Masterplan for Glendalough: Wicklow County Council is working with Fáilte Ireland and its strategic partners, the Office of Public Works and the National Parks and Wildlife Service to engage consultants to develop a Masterplan for Glendalough and the Wicklow Mountains National Park with a Visitor Orientation Plan for County Wicklow.





Thematic Experiences

Tracks and Trails previous programmes have been digitised and are available online. Two new 10 minute programmes have been commissioned featuring the Tinahely hiking trails and the Bray Head to Sugarloaf Trail and are due to be launched on 2nd April

Wicklow Passport: Featuring stamps designed representing attractions, towns and villages when a visitor obtains 15 stamps they will qualify for a certificate as a Wicklow Ambassador

Eco Trail: The Eco Trail is the largest Trail Running Event in Ireland and takes place on 26th September 2020

Covid-19: some visitor attractions such as gardens were able to reopen on 18th May, other businesses may not be in a position to open this year. Failte Ireland, Wicklow County Council, LEO Wicklow are providing a range of supports and advice for tourism providers.

Rural and Urban Regeneration Development Fund Grant Applications

RRDF applications have been submitted in respect of Blessington, Newtownmountkennedy and Rathdrum. Blessington's application is based around the urban regeneration of the town square and linkages to the proposed inner relief road and the greenway. Newtownmountkennedy's application is to develop design solutions for the regeneration of the town, enhancing its public realm and infrastructure provision and to drive increased footfall, encouraging the regeneration of business. Rathdrum's application was based on the development of a community enterprise centre and the regeneration of the town core.

URDF applications are being developed in respect of Bray, Wicklow and Arklow Harbours incorporating the public transport Bridge in Bray and the Pottery Museum in Arklow. The applications will focus on master planning of the harbours, increasing berthage and quay space where required, addressing dereliction and under use of properties, identifying opportunities for residential development and developing Wicklow as a centre of excellence for offshore wind energy. The closing date for these applications is 29th May.





Climate Action

Climate Action Applications have also been submitted in respect of Wicklow and Arklow Harbours aimed at ensuring both harbours can benefit from development of the offshore wind energy industry.

The Wicklow harbour application was submitted to apply for funding to develop the physical infrastructure in Wicklow harbour in order to accommodate crew transfer vessels servicing the offshore wind sector.

Similarly the application in respect of Arklow is to facilitate servicing of the offshore wind industry and to investigate the possibility of developing enterprise units for small businesses engaged in marine activities. Offshore wind has a cross governmental mandate secured through the delivery of the Climate Action Plan targets of 3.5 GW of offshore wind by 2030.

Maritime

Maritime Strategic Review for County Wicklow

The Strategic Review will identify ways in which the economic base of County Wicklow could be strengthened through its ports and harbours and formulate recommendation for Wicklow County Council.

Key Recommendations:

- To maximise the Offshore Wind Opportunity
- To investigate the feasibility of a new harbour facility at Wicklow
- Aquaculture Support
- Marketing Strategy for County Wicklow as a Coastal Tourist Destination

The Strategic Review is at the core of the applications for Climate Action and URDF funding.

Maritime Business Development Group

An Aquaculture working group has been established to work with industry experts and investigate the proposal to restore natural oyster reefs off the coast of County Wicklow.

FLAG Funding

Wicklow County Council has supported applications for FLAG funding in respect of the Native Oyster Reef Restoration project and also in respect of a Wreck Fishing proposal.





The Native Oyster Reef Restoration (NORRI) project is a plan to establish self-sustaining native oyster habitats in the Irish Sea, in collaboration where possible, with Wind Energy and Coastal Defence Development. A workshop is planned for the end of March to publicise this project.

The Wreck fishing FLAG is an application supported by the Maritime Business Development Group. It is a proposal aimed at surveying current wreck fishing sites and eventually attracting leisure type fishing in these areas.

A decision on these FLAG funding applications is expected in the coming weeks.

Food and Beverage Strategy

Wicklow County Council's Economic Development Unit and Community, Cultural and Social Development section, along with LEO Wicklow supported the development of a Food and Beverage Strategy for County Wicklow.

County Wicklow Partnership with the support of Wicklow County Council, have been awarded LEADER funding for the implementation of the Food & Beverage Strategy. Following a procurement process, Jonathan Birnie Associates (JBA) were awarded the contract and are currently engaging with the Food and Beverage steering group.

Working groups have been established to progress actions from the Strategy viz:

- 1. Tell the Wicklow Story
- 2. Develop a Food Activity Calendar
- 3. Get Local Food to Local Consumers
- 4. Provide Appropriate Business Supports

Some of the key actions achieved to date include

- 1) The drafting of a definition for Wicklow Food.
- 2) The creation of a website and social media feed dedicated to the food strategy.
- 3) Creation of a Wicklow Food and Beverage Network

Membership of Wicklow Naturally is growing strongly and now has members from Food & Drink Production, Accommodation Providers, Restaurants and Retailers.



Website & Social Media

The Wicklow Naturally website and social media accounts were established in March 2020 and have received a very good initial response, with 1500 individual visits as of May 18th 2020 (April 21st to May 18th).

Food Poverty

Two food poverty meetings have been held and the need for a food poverty expert's group has been identified. Six members of the group have been identified and one person has been approached about chairing the group. The intention is to hold the first expert's group at the very end of May or early June. An action plan for the group has been identified and will be discussed at the first meeting.

Food Incubation Centre Report

The Food Incubation Centre report is an additional piece being delivered within the tender. A first draft of the study has been produced and circulated for feedback.



2. Local Enterprise Office (LEO)

LEO Objectives

To foster an enterprise culture and stimulate enterprise at local level by:

- Promotion of the enterprise message at local level.
- Working with the relevant stakeholders in the county to foster entrepreneurship.
- Delivering appropriate enterprise training and mentoring to entrepreneurs.
- Providing funding options to entrepreneurs, early stage promoters and viable businesses to support growth and development of micro enterprises.
- Developing a progression pathway for clients to Enterprise Ireland
- Acting as a 'First Stop Shop' for business information and referral

3. Planning and Development

Forward Planning

Regional Spatial & Economic Strategy for the Eastern and Midlands Regional Assembly 2019-2031 & Metropolitan Area Strategic Plan

The new Regional Spatial and Economic Strategy (RSES) for the Eastern and Midland Region (EMRA) came into effect on the 28th June 2019. This was subsequently subject to a Ministerial direction which was confirmed in January 2020. The final RSES and accompanying documentation is available at the following link: https://emra.ie/final-rses/

The requirement for a Metropolitan Area Strategic Plan (MASP) to be prepared for the Dublin metropolitan area as part of the RSES is set out in Project Ireland 2040 - National Planning Framework (NPF). The MASP provides a 12 to 20 year strategic planning and investment framework for the Dublin metropolitan area.

A MASP implementation group has been formed, with 'terms of reference' and governance structure agreed by the Regional Assembly in May 2020. The Implementation Group, whose function is to oversee progress on the implementation of the Dublin MASP, offers an opportunity for enhanced spatial coordination of land use planning and strategic infrastructure delivery in the Dublin metropolitan area. The Implementation Group will drive strategic housing, employment and regeneration opportunities that are identified in the MASP in tandem with the delivery of key public transport, enabling infrastructure and metropolitan scale amenities, in order to achieve targeted population and employment growth as set out in the accompanying RSES and NPF.

The membership of the MASP Implementation group comprises representatives from each of the seven metropolitan local authorities, the Department of Housing Planning and Local Government (DHPLG) and key infrastructure, transport and enterprise agencies.

County Development Plan Review

Notice to review the current County Development Plan 2016 - 2022 and prepare a new County Development Plan 2021 - 2027 was given on the 6th November 2019. Closing date for submissions was Friday 10th January 2020. 156 submissions were received. All of the submissions are available to view on the website. Work is currently underway on the Chief Executive's Report on submissions received.

Heritage

Heritage & Biodiversity Plan Actions:

- Phase 2 County Swift Project underway. Community engagement with Tidy Towns groups and individuals being asked to report sightings within 5km. New nesting boxes and callers installed in county buildings and at Dunlavin library.
- Our Wicklow Heritage launched: A new community heritage multi-platform website hosting County Wicklow Heritage and the following community heritage recording groups; Delgany Tidy Towns, Glens Of Lead, Medieval Bray Project, Glendalough Heritage Forum and , The Glen/ Donard. National Biodiversity Week 18th – 22nd May online biodiversity promotion programme.
- Gardening for Biodiversity Publication: Local Authority Heritage Officer publication made freely available as an online resource and via hard copy
- Together Apart Wicklow Stories 2020 Project launched: A campaign which will use the heritage website to curate a people's community heritage archive of life in Wicklow in 2020.



Protected Structures Grants: The Council assessed applications and recommended projects under the county allocation of €60000 to the Built Heritage Investment Scheme, and shortlisted 5 projects for submission under Historic Structures Fund. WCC are awaiting decision of recommendations at this point.

Climate Action

Due to the Covid-19 outbreak the climate Action Team has not yet convened but in the meantime the Climate Action Officer is working with the Assistant Environmental Awareness officer and the heritage officer to progress actions as identified in both the Climate Charter and the Climate Change Adaptation Strategy as adopted by Wicklow County Council.

Wicklow County Council is part of a sub region of the Eastern and Midlands Climate Action Region along with Kildare Meath and Louth. Going forward Wicklow will collaborate with these other Local Authorises to source funding for larger scale project across the region. At present the subgroup of which the Wicklow County Council Climate Action Officer is a member is tasked with drafting an climate adaptation implementation plan

An SPC to update the members two of whom are new on the work in progress will be held in early May

Environmental Awareness

National Spring Clean was postponed due to Covid-19. Collections for clean-up events when requested were still undertaken but groups were asked not to organise further public events.

Work commenced on relaunching the Relove fashion competition piloted successfully in 2019 in partnership with Meath, Westmeath and Dublin City Councils and the Rediscovery Centre in Ballymun. The competition will be expanded to include more local authorities. The focus on producing wearable clothing design and good use of skill with textiles will be strengthened in the competition to develop circularity skills among students in textiles and fashion. It is hoped to launch the competition earlier this year as schools can encourage students to work from home on the development of their projects.

A meeting was held with the PPN to develop an event in May looking at the use of the Sustainable Development Goals for Climate Action. The event has since been postponed but it is hoped to continue work by mapping the use of the sustainable development goals in County Wicklow.

Four project ideas with and educational and awareness focus were developed for the Anti-Dumping Initiative. The projects will address engaging transition year students, working with clubs on marine litter, developing a post



Covid-19 clean-up campaign and a bikes-for-Africa project. The applications were submitted to the DCCAE as part of a suite of ten anti-dumping initiatives.

Social Media was used to raise awareness on a range of Covid 19 related waste issues including littering of PPE, a spike in illegal dumping and problems with dumping at bottle bank sites.

Recycling Centres

Wicklow's 5 Recycling Centres have remained open during the Covid-19 crisis with some restrictions in place due to lack of outlets for materials and to ensure the safety of our staff. These include the following:

- Arklow Recycling centre not taking paint or clothes at present
- Bray Recycling centre not taking clothes
- Modified opening hours in Bray and Avoca to allow for additional cleaning.
- Restrictions on the number of people who can enter at one time in order to keep social distancing requirements.

Bottle bank sites have been extremely busy with 253 tonnes of glass collected in April during 122 collections. This is more than a 50% increase in material collected compared to April 2019. In order to cope with increased demand 35 additional service visits were carried out. Additional CCTV has been sourced to help combat illegal dumping at bottle bank sites.

Lifeguards

Applications are currently being assessed and interviews will be held in early May for the positions of life guards for the 2020 Bathing season which begins on 1st June

Dog Licences

The total amount of dogs licenced in County Wicklow during the month of April 2020 was 274, with 138 being renewed through Licence.ie. Reminders continue to be issued by An Post.

Whitestown Remediation Project

Wicklow County Council have employed Fehily Timoney & Company to advise on the remediation of the site at Whitestown, in accordance with the judgments of Mr. Justice Humphreys.

- Priority Geotechnical Limited completed site Investigation on Friday 13th September and factual report received in January 2020- results of the site investigation will inform the proposed remediation plan which is scheduled for completion in May 2020.
- Website is up and running and regular updates will be made to keep the Public and Members informed of progress.
- Environmental risk assessments as per EPA guidance document and a draft remediation plan are currently being carried out.

9 Cargo vessel berthed in Wicklow Port during April, 8 had a single transaction (import or export) while 1 had double transaction (export and import)

and Environmental Awareness Offices operate programmes to maintain, inform and educate us about the rich natural heritage of our beaches.

Arklow Flood Relief Scheme

The Office of Public Works (OPW) and Wicklow County Council have commissioned Byrne Looby PH McCarthy (BLP) and Arup to undertake engineering and environmental studies respectively to assess and develop a viable, cost effective and sustainable Flood Relief Scheme for the Avoca River, Arklow.

The process of identifying a preferred scheme to address fluvial and coastal flooding in Arklow includes a detailed assessment of a range of flood risk management measures to determine their technical, economic, social and environmental viability.

Following a detailed scheme options assessment process, the series of measures that will make up the emerging preferred flood relief scheme for the Avoca River, Arklow have now been identified.

A number of changes in design have resulted in the need to update the Public realm drawings which is presently being done expected completion: at the end of May. Possible disposal options for the dredge material are currently being investigated.

Following the confirmation of the preferred flood relief scheme an Environmental Impact Statement will be prepared and submitted to An Bord Pleanala.

Initial meeting with the foreshore section of the Department of Housing Planning and Local Government has taken place.

Transportation Statistics (General)

Winter Maintenance

The 2019/2020 Winter Maintenance Season commenced on 14th October 2019 and finished on the 3rd May 2020. April was a very mild month with only 2 call outs made and 6 tonnes of salt spread. Over the 2019/2020 Season Winter Maintenance Crews made 642 call outs and spread 2,703 tonnes of salt over the nine routes within the County.

TII funded projects

M11/N11 Junction 4 to 14 Improvement Scheme

Due to the Covid-19 Pandemic all meetings with individual landowners have been suspended, however work is continuing with Preferred Options Assessment Report.

All site survey works have been suspended, approximately 90% of the Biodiversity Survey have been completed and the remainder will be accessed upon first visit, once Covid-19 restrictions are lifted. The Topographical surveys commenced and two priority areas were completed prior to the Covid -19 restrictions, all other areas will be completed once restrictions are lifted.

Each of the Sub-consultants are preparing to return to work after May 18th with the necessary operating procedures in place and reviewed by Arup in advance of this date.

N11 Kilmacanoge Parallel Service Road

Works on site have been suspended from 6pm March due to the Covid -19 pandemic, monitoring of the Phase 1 Traffic Management layout and security continued during the month of April.

Prior to covid-19 restrictions, phase 1 excavation work was in progress in the median.

SIAC Construction Ltd is in the progress of preparing standard operating procedures for works on site in advance of commencing works on site Monday May 18th.

N81 Knockroe Bend Realignment

Construction work stopped on Friday 27th March due to the government's Covid-19 restrictions and is currently expected to recommence on Monday 28th May.



In readiness for this the Contractor has updated their Health and Safety Plan with a revised Operating Procedure to mitigate the risk of infection from Covid-19 and is carrying out advance covid-19 enabling works commencing on 13th May.

Prior to covid-19 restrictions the works were progressing well with sub-base placed on offline sections of the N81 and L8314 and the first layer of base course commenced.

Works set to resume on base course, binder course and traffic management for tie-ins.

The roadworks speed limit order of 60Km/h is currently due to expire on 31st July 2020. Therefore an extension is now being sought to extend for the full 12 month period until Friday 11th December 2020 or such earlier date as may be determined by Wicklow County Council.

There were **92 incidents** attended during the month of April 2020. Individual Fire Stations were mobilised on a total of **101 occasions**.

Operational activity for the month April was **down 19% on the preceding month** (March 2020 – 125 mobilisations) due mainly to a decrease in RTC's, a reduction in alarm activations and river rescues. Activity for the month was **down 14%** on April 2019, due to a reduction in RTCs, and in ambulance assists.


