### Arklow Town & Environs Development Plan 2011-2017

In accordance with Section 12 (7) of the Planning & Development Act 2000 (as amended), notice is hereby given of **Proposed Amendments** to the Arklow Town and Environs Development Plan 2011-2017, which constitute material alterations to the draft plan.

In accordance with Section 12(7)(aa) of the Act, the Planning Authority has determined that the Proposed Amendments require to undergo Strategic Environmental Assessment but that they do not require an Appropriate Assessment under the Habitats Directive as potential impacts on the Natura 2000 network can be screened out.

The Proposed Amendments are accompanied by a report on the likely significant effects on the environment of implementing the Proposed Amendments, prepared in accordance with the Planning & Development (Strategic Environmental Assessment) Regulations 2004

A copy of the Proposed Amendments and the report on the likely significant effects on the environment / Natura 2000 network of implementing the proposed amendments will be on display at the following locations **from Monday the 18<sup>th</sup> of January 2011 to Tuesday 15<sup>th</sup> of February 2011 inclusive, Monday to Friday, excluding Bank Holidays:**

SUBMISSIONS NOT ADHERING TO THESE CRITERIA WILL BE CONSIDERED INVALID. LATE SUBMISSIONS WILL NOT BE ACCEPTED.
