

I am directed by the Minister for Housing and Urban Development to refer to your recent letter in relation to the above and set out hereunder observations on behalf of the Minister.

The Department of Housing, Planning and Local Government notes the circulated Proposed Material Alterations to the Draft Variation No.1 to the Wicklow County Development Plan 2016-2022 which are primarily concerned with the updating of certain elements of the core strategy of plan including in relation to recent local area plans.

As the Council will be aware, the National Planning Framework (NPF) was published Friday 16<sup>th</sup> Feb 2018, in tandem with the new ten-year National Development Plan, jointly named Project Ireland 2040: Building Ireland's Future. The publishing of the two documents together links strategic national planning and investment with regional-scale physical planning and the local economic and community development functions of Regional Assemblies and Local Authorities.

In addition, the formulation of the statutory Regional Spatial and Economic Strategy (RSES) for the Eastern and Midland Regional Assembly has commenced and will provide the strategic policy framework for the statutory development plan process of the constituent local authorities. The finalization of the RSES process in 2019 will necessarily be followed by a review of existing development plan policies to align them with the new regional planning strategy.

Pending the completion of the RSES process, the current Variation to the Development Plan is therefore considered to be interim in nature and appropriate.


