We wish to make the following submission on the review of the Wicklow County Development Plan 2016 - 2022 and the preparation of a new County Development Plan for the period 2021 - 2027.

### **DUNLAVIN**

The Dunlavin Town Plan states, under 5.4 Economic Development and Employment,: "Dunlavin is also the nearest town to the nationally renowned Rathsallagh Country House and Golf Club, and there is significant overspill benefits resulting from this proximity, including use of the local Church, public houses and restaurants, and guesthouses / B&Bs."

The Town Plan states the policy under Objective DUN3 "To facilitate and support the development of the tourism industry in Dunlavin and maximise the town's location as a gateway between the tourism assets within Co. Wicklow and Co. Kildare".

The Strategy for Tourism and Recreation in the Wicklow Development Plan states under 7.3 a General Objective (T20): "To support development at existing / proposed integrated tourism / leisure / recreational complexes at [six listed] locations, [including].....
• Rathsallagh House, Dunlavin (Map 07.06)".

Rathsallagh Country House and Golf Club is the only property zoned locally for Integrated Tourism/Leisure/Recreational Use.

Rathsallagh's continued use as a leisure facility is crucial to the success of this objective and that of the Dunlavin Town Plan. The golf course of its own is not viable, as has been proven by its closure for a period in 2015 and the recent closure of other golf clubs in the

vicinity (Killerig and Dunmurry Springs). A broader perspective is required.
