# **ITEM NO. 13**

### To note the County Wicklow Age Friendly Strategy 2023 – 2027.

Mr. M. Nicholson, Director of Services gave a short overview of County Wicklow Age Friendly Strategy 2023 – 2027 outlining the following:

- The programme has been operating since 2008
- It is affiliated to the World Health Organisation and every county has an agency friendly programme, an Age Friendly Strategy and an Age Friendly Co-Ordinator.
- The key to success is active involvement of all key stakeholders, including Age Friendly Programme Manager, Local Authority interdepartmental group, and local age friendly alliances.
- There are age friendly parking, libraries, housing specialists and benches.
- There are age friendly considerations, walkability surveys, talent initiatives, bus shelters, housing units, dementia garden etc.
- Senator Pat Casey is Wicklow Age Friendly Ambassador.
- The new plan has 72 actions over eight thematic groups.
- Recommendation that there should be an Elected Member on the Age Friendly Alliance.

A short discussion followed, the Elected Members congratulated the Age Friendly Alliance and the Administrative Team on their many achievements.

Mr. J. Lane, Director of Services, gave a short presentation outlining the following:

- Pathway 1 Pathways to supporting homeownerships and increasing affordability.
- Affordable Housing Options: Local Authority Build Turnkey Shared equity Part V – Cost Rental.
- Affordable Purchase.
- Affordable Housing Fund.
  - Available for Local Authority Affordable Purchase, Cost Rental and advance purchase (turnkey).
  - O Discount to market value minimum 15%.
  - Infrastructure/site works or as direct funding of Local Authority housing development cost.
  - o Increased maximum from €50,000 to €100,000. Subject to a number of conditions including density criteria.
- Local Authority purchase.
  - o Greenhill Road 365 units portal open 9<sup>th</sup> January.
  - Lott Lane 75 units Part 8 to be republished.
- Affordable Purchase (AHF assisted Advance purchase i.e. developer constructed)
  - o Approval for 2 schemes received in December 2022.
  - o Rathnew 44 units Affordable anticipated delivery late 2023/2024.
  - Baltinglass 25 affordable units part of a bigger scheme anticipated delivery late 2024.
  - Further applications being processed.
  - Seeking expressions of interest for affordable and social housing to be published January 2023.
- First Home Scheme (Shared Equity Scheme) launched July 2022.
- Part V changes.
- Cost Rental.

Mr. E. McGuane, Asset Management Lead and Mr. D. Hayden, Community Liaison Officer, Land Development Agency gave a 2<sup>nd</sup> presentation covering the following areas:

- Current site portfolio.
- Projects.
- Strategic Planning Projects.
- Affordable Homes Project Tosaigh.

- Cost Rental Overview.
- Cost Rental Eligibility.

There followed a broad discussion in which the Elected Members raised questions which were responded to by Mr. Hayden, Mr. McGuane and Mr. Lane.

The Elected Members welcomed the Affordable Pathways outlined by the Director of Service. The Cost Rental Development in Delgany was acknowledged as a positive addition, however, the Elected Members expressed surprise that they were not informed of the development at an earlier stage in the process.

Questions were raised about Cost Rental rents in the long term, sale of affordable houses, ownership of cost rental properties and exclusion of pet owners. A lengthy discussion took place on the eligibility criteria for affordable housing particularly in relation to the origin of the applicants.

It was proposed by the Cathaoirleach to move to Item No. 18 followed by Item 17.

Ms. A. Beaumont, Music Development Officer gave a presentation highlighting the following:

• Provide access to high quality affordable music performance education through a range of programmes.

- See music education as an essential tool in the artistic, social and intellectual development of children and young people.
- Its benefits include physical and emotional wellbeing; greater sense of belonging and community; improved concentration and behaviour; and creative thinking and problem solving.

- o Pilot project for Ukrainian Music Programme.

Ms. G. Whitty, HR Officer gave a presentation outlining the following:

- Action Plan adopted by EU Commission aimed at tackling the Gender Pay Gap.
- Directives already in place on pay discrimination/equal pay.
- Focus now on publication of data and reducing the pay, earnings and pension gap.
- Government approval for a range of measures, including legislation.
- Gender Pay Gap Information Act signed into law.
- Regulations published in May 2022.
- All organisations over 250 employees must report on their gender pay gap by end of 2022.
- National Public Sector Approach.
- Producing the report.
- Interpreting the figures.
- Benefit in kind.
- Women in Leadership.
- How we are supporting Gender Equality.

# **ITEM NO. 16**

To consider the Chief Executive's Monthly Management Report, December 2022.

Elected Members were circulated with the Chief Executive Monthly Management Report December 2022.

Elected Members raised questions but due to time constraint the Chief Executive and the relevant Director of Services agreed to respond directly to the Elected Members after the meeting.

### **Suspension of Standing Orders**

1. Cllr. P. O'Brien, seconded by Cllr. G. Dunne requested a suspension of standing orders to discuss the evolving situation in Direct Provision at the Grand Hotel which has been deemed necessary because of the failure of the Minister and his Department to engage with the Public Representatives in the Wicklow Municipal District and the dangerous living conditions the residents find themselves in.

Following a broad discussion on the matter it was agreed to write to the relevant Minister and to IPAS as a matter of urgency and request a meeting with relevant officials and a cross party delegation from Wicklow County Council to discuss the issue further.

2. Cllr. G. O'Neill, seconded by Cllr. J. Behan requested a suspension of standing orders to discuss the provision of modular housing in the Baltinglass Municipal area.

A short discussion took place in which the Elected Members expressed their concerns.

The Chief Executive advised the Elected Members that a list of possible sites were submitted to the Department for consideration in April. Sites selected were based on technical criteria as well as key requirements. The Government has appointed OPW as the contracting authority with responsibility for managing the construction and installation of modular units on a range of state-owned properties around the country. Two sites in County Wicklow remain under active consideration on the list, to date OPW has only requested access to carry out a survey for Baltinglass, some initial surveys were done in December, and it is expected a full site investigation will be carried out in January. A request to access the Dunlavin land, has not been received as yet. The site in Baltinglass is the only one surveyed at the moment. If the site is deemed suitable, the OPW will revert to the local authority in relation to proceeding with the developmental works. The Department of children will arrange for presentations to the relevant Elected Members in the district supported by the OPW technical team as part of our communications process. With regard to the emergency accommodation programme, the OPW will arrange a community information meeting and a leaflet drop in the relevant area.
