This land is currently for sale and is zoned for mixed use development, including residential, education, recreation and employment and has the capacity to provide thousands of affordable, social and private homes as well as many other essential facilities.

It is also the original location for an extension of the Green Luas line and has the capacity to provide a park and ride facility which would relieve some of the traffic delays on the N11 currently being experienced by thousands of commuters form Greystones, Wicklow and Arklow Municipal Districts.

This Council believes that this is a once in a lifetime opportunity for a publicly led initiative to design and develop the newest town in County Wicklow which has the capacity to make life better for countless thousands of residents from all over County Wicklow."

It was proposed by Cllr. P. Kennedy, seconded by Cllr. P. Fitzgerald and agreed by all to consider the disposal of 0.43 acres of land or thereabouts in the townland of Rathdrum, Co. Wicklow by way of 18 month lease for the period 9th July 2024 to 8th January 2026 and the right to pass and repass thereto, to Mr, Noel Jacob and Ms. Helen Jacob, Jacob's Well, Rathdrum, Co. Wicklow, as set out in statutory notice circulated.

Wicklow, the person entitled to the freehold interest in the property.

It was proposed by Cllr. P. Fitzgerald, seconded by Cllr. P. Kennedy and agreed by all to consider the disposal of 0.0139Ha or thereabouts in the townland of Knockanrahan Lower, Co. Wicklow comprised in Folio WW383L Co. Wicklow being the property known as 4 St. Kevin's Terrace, Arklow, Co. Wicklow by Transfer Order to Ms. Alice Breen (as Legal Personal Representative of John Breen, Deceased) of 4 St. Kevin's Terrace, Arklow, Co. Wicklow, the person entitled to the freehold interest in the property, as set out in statutory notice circulated.

ITEM NO. 4

To consider the disposal of 0.0412Ha or thereabouts in the townland of Ballinglen comprised within part of Folio WW4484 being the property known as Ballinglen, Tinahely, Co. Wicklow by Deed of Transfer and Rectification to Mr. Edward Walker as LPR of Charles Walker (deceased).

It was proposed by Cllr. J. Mulhall, seconded by Cllr. P. Stapleton and agreed by all to consider the disposal of 0.0412Ha or thereabouts in the townland of Ballinglen comprised within part of Folio WW4484 being the property known as Ballinglen, Tinahely, Co. Wicklow by Deed of Transfer and Rectification to Mr. Edward Walker as LPR of Charles Walker (deceased), as set out in statutory notice circulated.

ITEM NO. 5

To consider and adopt the following Resolution

"That the Chief Executive has the express authorisation of the elected council within the meaning of section 153(2) of the Local Government Act 2001 as amended, to act in any action and/or other proceeding, now in existence and/or in the future, relating to the exercise or performance by the local authority of a reserved function, including but not limited to the exercise of reserved functions in the context of a development plan. Such authorisation is given to do all such acts, matters, and things as the Chief Executive considers necessary and/or appropriate. The Chief Executive shall, inform the elected members of any future action or other proceeding, within the scope of this resolution at the first Monthly meeting of the elected members, after any such action or proceedings are served on the Council (where practicable or if not practicable, at the next appropriate meeting thereafter)".

A broad discussion followed. Some concerns raised by the Elected Members were:

- Handing over to the Chief Executive the authorisation to respond to any legal action in the future by a third party with regard to reserved functions.
- Key role of public representatives is to represent the public, have oversight and accountability which is not happening.
- Being asked to relinquish a power that a previous legislature in 2001 gave to Elected Members.
- Request to seek second legal opinion.
- Right as an Elected Member to be consulted in respect of legal action regarding a decision made as a public representative.
- County Development Plan Elected Members have the right to decide how the county is going to be developed.
- Request to raise the issue with AILG.
- Eradication of powers of the Elected Members.
- Chief Executive protecting the Elected Members by getting resolution put in place.
- Concern that decision is being made too quickly is there enough information to make an informed decision?
- The Act is enough for the Chief Executive to defend the Elected Members.
- List of live cases should be brought before the Council where express authorisation would be sought on a case-by-case basis.
- What is the number of cases that are live at present?
- Dissolution of powers meant to strengthen powers of the Elected Members.
- Request to be kept informed at all stages and have a veto on any particular direction the Chief Executive proposes.
- What are the implications for past cases?
- What are the risks factors if resolution is rejected?
- The Cairn Homes case before court at the moment which disputes the population targets set out in the County Development Plan.
- The wish that the Chief Executive defend the decision of the Elected Members in the County Development Plan.

The following motions were proposed:

- 1. Proposed by Cllr. J. Snell, seconded by Cllr. T. Fortune 'that a copy of legal opinion be circulated, second legal opinion to be sought by the Chief Executive, AILG representatives to seek AILG opinion and LAMA representatives to seek LAMA opinion'.
- **2.** Proposed by Cllr. S. Bourke, seconded by Cllr. L. Fenelon Gaskin to insert the wording "that such authorisation given to do acts, matters and things as the chief executive considers necessary and/or appropriate in consultation with the Members" before the wording 'the Chief Executive shall inform the Elected Members'.

- 3. Proposed by Cllr. M. Duddy, seconded by Cllr. T. Fortune 'that a list of existing live cases in which the Council are involved be brought before the Council to grant express authorisation to those proceedings rather than the adoption of a global-style resolution'.
- **4.** Proposed by Cllr. P. Glennon, seconded by Cllr. P. Stapleton to delete the words 'but not limited to'.
- **5.** Proposed by Cllr. T. Fortune, seconded by Cllr. O. Finn to defer this item to a later date.

Following further discussion, the Elected Members agreed to withdraw all five motions and it was agreed by all to move to Item No. 6 and return to this item later in the meeting, in order to allow the Chief Executive to revert with a re-worded resolution that deals specifically with the Cairn case.

- Could members of the public be on the SPC?
- Could Chairs of SPC's advise in advance when meetings will be held.
- SPC meetings scheduled so as not to clash with MD meetings.
- Reduce the numbers of Elected Members on SPC's.
- Request for information on what the SPC's are working on currently and what their wider remits are.

It was proposed by Cllr. J. Behan, seconded by Cllr. D. O'Brien to consider the Wicklow County Council Draft Strategic Policy Committee (SPC) Scheme 2024 – 2029.
