WICKLOW COUNTY DEVELOPMENT PLAN 2022-2028 PROPOSED MATERIAL AMENDMENTS TO THE DRAFT BLESSINGTON LOCAL AREA PLAN 2025-2031

Notice is hereby given pursuant to Section 20 of the Planning and Development Act 2000 (as amended) that Wicklow County Council, being the planning authority for the area, proposes to <u>amend</u> the draft Local Area Plan (LAP) for **Blessington**. The proposed amendments would, if made, constitute a material alteration of the draft LAP which was published on 30 October 2024.

The 'Blessington LAP 2025-2031' will consist of a written statement indicating the objectives in detail as may be required by the planning authority for the proper planning and sustainable development of the area, maps and appendices. This LAP will, when adopted, replace the existing Blessington Local Area Plan 2013-2019. The new LAP should be read in conjunction with the Wicklow County Development Plan 2022 – 2028.

- Addendum I to the Strategic Flood Risk Assessment, which provides a strategic flood risk assessment of the
 proposed amendments, carried out in accordance with 'Planning System and Flood Risk Management:
 Guidelines for Planning Authorities' (DoEHLG/OPW, 2009 pursuant to Section 28 of the Planning and
 Development Act 2000 (as amended).
