At the commencement of the meeting a roll call was taken. The Meetings Administrator advised of meetings etiquette for online meetings and that the press and some members of the public were also present.

Votes of Sympathy

Elected Members passed a vote of sympathy to the families of the late Mr. Jim Lavery, Mr. Eddie Hanlon, Ms. Mary O'Brien, Mr. Billy Kinsella and Mr. Larry Whelan. A minutes silence was observed for the deceased.

Request for Suspension of Standing Orders:- The Meetings Administrator advised that two requests for suspension of standing orders had been submitted in advance of the meeting. In accordance with the protocol adopted both requests were read to the meeting as proposed and seconded:-

1. Cllr. J. Mullen, seconded by Cllr. P. O'Brien requested a suspension of standing orders to discuss the following:

'That the Members of Wicklow County Council condemn the unprovoked invasion of the sovereign nation of Ukraine by Russia. We also demand that in response to the unjustified invasion of a fellow European nation that the Irish Government use the maximum diplomatic sanction which is the immediate expulsion of the Russian Ambassador from the Republic of Ireland'.

2. Cllr. J. Behan, seconded by Cllr. P. Fitzgerald requested a suspension of standing orders to discuss the following:

'That this Council agrees to request an urgent meeting with the Minister for Transport to discuss the suspension of funding for the N11/M11 Road Improvement Scheme as well as the need for noise mitigation measures in Kilmacanogue and the requirement for a footpath linking Kilmacanogue to Bray'.

It was agreed to discuss the two suspensions of standing orders at 4.30 p.m.

ITEM NO. 1

Section 140 motion, Local Government Act 2001, as amended, in the names of Cllr. G. O'Neill and Cllr. J. Behan seeking to withdraw the Blessington Greenway proposals from consideration by An Bord Pleanala.

To: Brian Gleeson, Chief Executive, Wicklow County Council

In accordance with Section 140 of the Local Government Act, 2001, as amended by the Local Government Reform Act 2014, we, the undersigned Members of Wicklow County Council, direct the Chief Executive of Wicklow County Council to withdraw the Blessington Greenway proposals from consideration by An Bord Pleanala.

This will allow for the removal of the elements of the Greenway Plan which will cause serious negative impacts on the lives of the people living in the areas surrounding the Blessington Lakes including the installation of traffic lights on Knockeiran, Baltyboys and Valleymount Bridges and the proposed new parking restrictions on Blessington Main Street which are widely opposed by the local community.

The reason for the motion is the lack of meaningful consultation with Elected Members of Wicklow County Council and the general public before the matter was referred to An Bord Pleanala.

We further direct that the matter be placed before the Members of Wicklow County Council at the forthcoming Council Meeting to be held at 2.00 p.m. on Monday 7th March 2022 in the Chamber of Wicklow County Council, County Buildings, Wicklow.

The Chief Executive referred to legal advice received and advised the Elected Members that the suggested resolution is one which if proceeded with, will be legally unsound, invalid and in breach of Section 140(2) and/or Section 140(10). Furthermore, no resolution under Section 140 of the 2001 Act can be brought to force the Chief Executive to withdraw a required application under Section 177AE of the Planning & Development Act because it would be an attempt to force the Chief Executive to do something that the Council is not lawfully able to do. Any such resolution would be void and legally ineffective.

Cllr. G. O'Neill raised the following points and concerns:

- That there was no consultation with the people, Elected Members and staff in West Wicklow.
- First learned at a Town Team meeting that the application had gone from the Council to An Bord Pleanála.
- An Garda Siochana and the Emergency Services were not informed.
- Risks involved dividing bridges in two, traffic on one side and pedestrians/cyclists on the other side.
- Public meetings held and submissions sent to An Bord Pleanála.
- Advised the Elected Members that the application could be withdrawn according to an An Bord Pleanála official.

• In favour of the Greenway, however, lack of consultation unacceptable.

Cllr. J. Behan paid tribute to Cllr. G. O'Neill for his persistence in raising the issue and in continuing to do so. He also raised the following concerns:

- That Wicklow County Council did not listen to genuine requests by Cllr. O'Neill and the local community for this Greenway Project to be withdrawn and made better.
- That he is not convinced by the legal advice.
- That no-one is against the Greenway but want a Greenway that will work.
- That this project will damage the quality of life of many people who live around the lakes of Blessington.
- The installation of traffic lights on 3 bridges will add from 5 to 10 minutes extra on journeys.
- Safety concerns in respect of ambulances or fire engines to get across the bridges in a hurry.

There followed further discussion by the Elected Members and response by the Chief Executive. Ms. L. Gallagher, Director of Service read Section 140(7) and (10) (e) of the Local Government Act 2001, as amended, to the Elected Members:

Section 140 (7) Without prejudice to any other relevant requirements, it is necessary for the passing of a resolution under this section that at least one-third of the total number of members of the local authority concerned vote in favour of the resolution.

(10) (e) to any act, matter or thing to be done or effected in the performance of the executive functions of a local authority in respect of its functions as a planning authority under the Planning & Development Act 2000.

It was proposed by the Cathaoirleach Cllr. S. Cullen, seconded by Cllr. P. Fitzgerald to defer the item for 2 weeks until 21st March 2022 in order to seek further clarification and legal opinion.
