Notices of Motion

Notice of motion in the name of Cllr. L. Scott (proposer), 1 seconded by Cllr. E. Doyle (1st September 2025)

"This council resolves that the Chief Executive write to the Department of Housing to request increased and multi-annual funding for the local authority Energy Efficiency Retrofitting Programme, in order to more effectively reach national climate targets and deliver much-needed regeneration to social housing in Co. Wicklow."

Notice of motion in the name of Cllr. L. Scott (proposer), 2 seconded by Cllr. L. Fenelon Gaskin and supported by Cllrs. S.

Stokes, M. Barry and T. Fortune (15th September 2025)

"In light of the amount of active open space, playgrounds, general community park and outdoor facilities in Co. Wicklow, we propose that the Chief Executive establishes a Parks Division as a priority. In addition the CE applies to the relevant Department for necessary funding and includes updates to this request as a standing item on the monthly CE report."

3 Notice of motion in the name of Cllr. C. Winstanley (proposer), seconded by Cllr. M. Barry (23rd September 2025)

That Wicklow County Council write, through the Chief Executive on behalf of the elected members, to the Minister for Children, Equality, Disability, Integration and Youth, and to the Minister for Enterprise, Trade and Employment, to:

- 1. Express support for the inclusion of socio-economic status as a protected ground in Ireland's equality legislation, specifically within the Employment Equality Acts and the Equal Status Acts.
- 2. This motion aligns with the Irish Human Rights and Equality Commission's recommendations and the national "Add the 10th" campaign, both of which call for socio-economic status to be formally recognised as a prohibited ground for discrimination.
- 3. Note that the Government has approved the General Scheme of the Equality (Miscellaneous Provisions) Bill 2024, published in early 2025, which proposes significant reforms to equality law and is expected to advance in the coming Dáil term.
- 4. Call on Government to ensure that socio-economic status is included in the forthcoming legislation, thereby strengthening protections for individuals and communities affected by poverty and social exclusion.
- 5. Affirm that Wicklow County Council is committed to promoting social inclusion, advancing equality, and protecting the rights of those experiencing poverty and disadvantage, and urges other local authorities across Ireland to adopt similar motions.

Rationale:

This motion recognises that adding socio-economic status as a protected ground is an essential step toward building an inclusive society where poverty or economic background does not determine a person's opportunities or rights. It will provide a legal basis to challenge discrimination, strengthen social justice, and support national efforts to reduce poverty and inequality.
