








Community Engagement Programme


Most frequent form of transport?




What would encourage more walking and cycling in the area?



Would a Greenway along the Swan River make you more likely to walk or cycle?




How do you feel about having a Greenway in your area?

Long Term Maintenance	"I would have concerns about ongoing maintenance of the completed greenway and whose responsibility this would be."
Safety & Risks of Anti-Social Behaviour	"Anti social behaviour. Increased noise level. Increased footfall. Feeling it would be too unsafe to let my child play in the area proposed."

Connection to Nature	"A beautiful, peaceful river walk with a clever design driven by recognition for nurturing biodiversity and native flora"
Functional Route	"A place to reconnect with nature, on the way to work."
	"Hopefully it would bring down the amount of air pollution as people wouldn't find the need to drive around Bray now that it is easier to get from A to B"
