Item 4: Consideration of Reports and Recommendations.

Presentation on water safety at the Cove Arklow.

Robert Kelly cited that with the new facilities in place in the Cove as a result of the Outdoor Recreation Scheme the Cove has become extra busy. The life guard hut has been moved to The Cove as a result and it is a safer place to swim. June July and August are the main bathing season and extra services are supplied for the duration. Extra signage will be positioned at South Beach to notify bathers of the dangers of the shelf in the water.

There has been some vandalism from the Bridge Hotel and down by the River walk, life buoys have been removed and damaged. A full refurbishment is due to start next Thursday; there is a lot of work and repair to be carried out as a result of this vandalism.

The following concerns were raised:

- Will the boy scouts use of the Cove be impacted with the life guard hut in place? There will be no impact.
- The new designated bathing area could not have happened without Roadstone.
- There will be weekly checks during bathing season of all safety equipment.
- The issue of toilets being placed at the Cove was rose however Robert said it was a matter for the Environment Department and he would pass the request over to them.

Housing - Tinahask Briefing.

Helena Fallon and Aideen Klauer delivered presentation on Tinahask.

The following concerns were raised:

 The team were thanked by the members for listening to them at the December meeting and in doing so increased the number of two bedroom units as requested. There has also been extra parking spaces allocated.

- Car parking is still seen as an issue however as the scheme is Government funded it is not
- There are now 6 disabled parking bays in this scheme.
- New relief road could take up to ten years to completion as it is quite complex with different

Pre-part 8 proposal Barndarrig.

Helena Fallon and Aideen Klauer delivered presentation on Pre-part 8 proposal for Barndarrig.

The following concerns were raised:

- What was the time frame between phase 1 and phase 2.
- One bedroom units are not adequate for people's needs.
- Plans for the one bedroom units should go back to SPC.
- All Elected Members agreed to move forward with Part 8 for ten units and after two years proceed with a second part 8 for the remaining ten units.
- The scheme will be advertised within the next two to three months.

- Roads in Kilcarra need attention, DE said this area is on the three year programme but is scheduled for maintenance, drainage and pot hole filling.
- Can plastic bollards throughout the town be replaced?
- No formal approval on the Pump track as yet as this is part of The Seaview Masterplan. Can DE look at the road out past Halpins.
- Can DE look at road at the leisure centre.
- Speeding an issue on Rory O'Connor place last survey had no speeding violations however
- Protocol with regards to speeding is available on County Council website.
- Footpaths in Heatherside. The estate has not been taken in charge. Pedestrian crossing outside of the estate on the Vale Road falls under the remit of the NTA.
- Ferrybank works were done with little disturbance to retail units and it is a huge
- Pathway at Clogga. This is outside AMD remit, erosion issues should be directed to the
- Traffic study is to start the end of May in Rathdrum.
- Road markings at Ballygannon Road, the tender is out at present once awarded it will be
- DE will investigate if it is possible to install a safety barrier at Wheelie gates.
- No decision as yet on Community Recognition funding.
- The Pride Crossing will not be re-freshed, as per previous discussions at County Level, these markings are not in accordance with signs regulations or directions of the Minister. The MD is exploring different options. DE will check gullies in Ballinaclash.
- DE will also look at the issue near the Old Valley Hotel.

Discretionary Fund 2025

There was a request for payment to fund self-close gates on two playgrounds in the area for security reasons. The gates are €4000.00 per gate.

Cllr. Leonard explained she felt discretionary funding decisions were rushed and she thinks it would be much fairer if each Elected Member had their own funding allowance. Cllr O'Toole expressed his support.
