MA 26 SLO9 Glebe	CE to RN1 New Residential	A watermain runs through this site and would need a diversion agreement.
MA 27 SLO10 Hawkstown Lower	New SLO, RN1 & AOS	This would require a network extension
MA 28 SLO11 Marlton (2 sites)	New SLO, Community & Employment	Our GIS shows no sewer in R751 to the west. There is one in Marlton Road

MA 40 Ballyguile More	RN2 to RN1	Network extensions would be required. These would be developer led.
MA 41 the Murrough	OS2 Natural Area to Employment	The site is not serviced with a sewer network. A pressurised main pumps sewage from the town to the Murrough / Knockrobin wastewater treatment plant. However, as it is a pumped main a connection would not be allowed. Therefore, any development on the site would have to include a substantial network extension @250m
