#### ITEM 1

#### ITEM 2

#### Presentation by Brian O'Sullivan

Brian O'Sullivan made a presentation on Speed Limit Reviews 2022. Items outlined included:

- Speed Management and Rational for speed limits
- Legalities as per *Guidelines for Setting and Managing Speed Limits in Ireland* (Section 9 (9) of 2004 Road Traffic Act)
- Setting special speed limits on National & Regional roads
- Summary County Councils must have regard to the 'Guidelines' when making and amending bye-laws for speed limits(Section 9 (9) of 2004 Road Traffic Act)

#### MEMBERS OBSERVATIONS

- Members thanked Brian O'Sullivan for making the presentation
- All housing estates (taken in-charge) will be 30 KPH speed limit
- Review of list for speed limit reduction from 80 to 50 at Nuns Cross
- Members discussed the Ashford Glenealy Road speed limit of 80 KPH to be reduced. Response from Assistant Engineer Brian O'Sullivan was that this is outside the Development Area of the town and cannot be reduced

#### ITEM 3

#### **District Engineers Report**

- Surface Dressing commenced with a view to completion within two weeks
- Lighthouse Road access reviewing situation with current talks with IPB and ongoing talks with the current landowner
- GSS and Outdoor staff all aware of the dates for the Blessing of the graves, a new Lawnmower has been purchased for grounds maintenance

#### MEMBERS OBSERVATIONS

- Lighthouse Road Access issues raised and dialogues currently aim to review and rectify the accessibility
- Ball Alley in Wicklow Town to be made available to the public
- Members discussed issues/timing of traffic lights and road markings at Tinakilly Park causing a backup of traffic and lengthy delays getting to Rathnew onwards.
- Blessing of the graves at Glenealy approaching and requires maintenance, a hand rail is required on approach to Rathnew graveyard
- The Round Ireland Yacht Race and Taste of Wicklow praised for raising a positive contribution to the area
- Issue raised over locking of park gates overnight as ongoing vandalism at the Little Park in Ashford

- Members raised the issue of unoccupied properties within the area, furthered that a vacant property list be generated and reasons for vacant properties be identified
