There followed a discussion about the prioritisation of goals and the subject of Windfarms in the Wicklow area and the possibility of employment coming to the County through these. DW pointed out that all goals are equally important. She also explained that it would be envisaged that they would have a draft of the plan in March which would go out to the Councillors and the MDs.

Brian Gleeson spoke about the Mid-East Enterprise Plan and the development of Marine Enterprise Hubs – the Wicklow and Arklow Action Plan – to cover all marine industries. Eileen Cullen spoke about the various possibilities for education and the KWETB would be providing the accredited side of this.

## Item 4 – Community Recognition Fund 2023

Prior to the meeting, the document explaining the Community Recognition Fund 2023 and also the Scheme Outline had been circulated to the members.

Michael Nicholson spoke about the launch of the €50 million Community Recognition Fund. This fund is a major initiative to support communities that have welcomed people from Ukraine and other countries. The funding will be for sports clubs, community organisations, transport infrastructure and

countries. The funding will be for sports clubs, community organisations, transport infrastructure and local groups. Every local authority in the country is to benefit.

MN went on to explain that Wicklow had been allotted €1.6 million. The funding will be divided among the five Municipal Districts and it is envisaged that rather than many smaller projects, one or two large projects in each MD would be funded. The department will have the final say in the decision on these projects. All projects have to be capital in nature and the funding will not cover ongoing running costs, and won't be allowed to cover projects already commenced. Whatever projects are put forward must be ones that will be benefit the community as a whole and be available to everybody.
