

- Roads engineering staff of Wicklow County Council have held a number of meetings with KLS and a rolling programme of work has been agreed in order to reduce the backlog of faults which the company have complied with. This is reviewed on a daily basis to account for the dynamic nature of the works i.e. existing faults and the daily submission of new faults.
- Additional WCC Admin / Engineering (SEE) staff have been transferred to PL to oversee & assist
 contractor prioritise & progress repairs through the districts. In order to reduce the numbers, the
 programme needs constant revision due to the dynamic nature of the works.
- These resources also ensure the reported faults are being entered on the 'Deadsure' app from which the repairs are planned.
- Unfortunately following recent weather relating incidents KLS were stood down by ESB from carrying out repairs on ESB owned infrastructure for a number of weeks in January (over 50% of logged faults are located on such infrastructure). The contractor has indicated that additional resources have now been added to their team to assist in clearing the back log of faults including incomplete works from previous contractor. This has been evident on the ground over that last few months.
- Following the lifting of the stand down at the end of January, the ESB are now being actively engaged
 with, to progress existing faults that are dependent on their presence or assistance.
- KLS are currently working in Arklow Town & Area on reactive and ordered civil works e.g. Aughrim
 Oaks. Upgrade & civil works are being planned for Templerainey Heights & Meadowvale. (approx. 16
 lamps)
- The faults on Heritage lights on Ferrybank & Main Street will require the removal of the current fitting to be replaced in the short term with new LED lamps. (approx. 13 lamps). These are examples where Traffic Management is required (TMR) to carry out works safely.
- Since the 27th January 2025 the percentage lights not working has been reduced from 4.7% to 2.67%. That is there were 148 active faults to the current 84 faults. 59 of the 84 faults are within the Arklow Town Area.
- KLS will also be visiting older fault reports that existed prior to their contract and will re –assess and schedule repairs as part of dealing with the backlog presented to them. This will include 'submitted' status which requires the fault to be categorised or attended to and closed when repaired.
- Where required Service Requests, Fault Reports & new unmetered connections are being submitted to the ESB ensuring ESB references recorded for follow up. (i.e. ESB required status)

Note on Faults in Older Developments

The following outlines the need for civil and upgrade works in many of the estates with existing faults and accounts for the need to upgrade adjacent assets in order to fix what appears like a single fault. E.g. Aughrim Oaks, Templerainiey height & Meadowvale Crescent

Under the ESB "Requirements for Work on Public Lighting on ESBs Network", our public lighting maintenance contractor is forbidden to carry out repairs to any public light that is fed directly from the ESB network without the presence of a public lighting customer service (micro) pillar or network cut-out installed in the column. This is to allow public lighting contractors to undertake works to the lights by completely isolating the public lighting power supply without impacting on the general electricity network, by means of an appropriate interface.

These requirements negatively impact both the timescale in which repairs can be completed; and the cost of said repairs with the now necessary installation of column cut-outs/micro-pillars.

Prior to 2000, a large number of developments would have installed public lighting with feeds directly from the ESB network, usually with a feed taken from the nearest supply point, i.e. the nearest ESB LV service pillar.

The columns that were installed in housing estates are predominantly five or six metre tubular columns, which are generally not of adequate size to allow a cut-out be installed within the columns themselves, so a new micro-pillar(s) may be required in the estates that were constructed in this fashion. The number of micro-pillars that would be necessary in each estate is entirely dependent on how the public lighting is connected, i.e. each development will have a unique solution. A typical example would be a direct fed housing estate with 20 public lighting columns — these 20 columns could be fed from just two ESB pillars (two circuits) or maybe eight pillars, depending on how it was wired originally. There is no definitive way of knowing this until the ESB attend site to open their pillars and assist the public lighting contractor with opening of their pillars/cable tracing/survey.

Public lighting contractors are forbidden from undertaking any works directly on the ESB networks and thus ESB attendance is essential to ascertain the extent of works required in each estate (ESB Service Request).

Where faults are found on Public Lighting in scenarios as described, The public lighting maintenance contractor will then need to measure, cost and programme the required civil works (digging, ducting, cabling, pillar install). Once these civil works are completed and the new micro-pillars have been installed, the ESB will again be required on site for the service alterations, whereby they will need to divert their original supply cable from the ESB LV service pillar to the newly installed public lighting micro-pillar. It is important to note that ESB co-operation on these projects is the critical path to the timely and smooth installation of these new micro-pillars as they are a key stakeholder, for the above mentioned reasons

- Additional parking in housing estates discussed. Advised that Council do not put in additional parking by using Green Spaces.
- Safety Barriers on rural roads very successful requested more in some areas e.g. Glenmalure. –
 District Engineer explained the locations are chosen by accident data from the Road Safety Authority and Locations of Interest are provided by the Department of Transport.
- Greenan road/ditch needs to be looked at dangerous
- Vale Road potholes need attention. Funding for 2026 & 2027 queried.
- Running Track funds queried for track to be ready for County Championships. District Administrator
 working with Department for funding & requested from members for Event Applications to be
 submitted for the Track to show demand for use.
- Requested that a letter be sent to all clubs informing them they need to submit Event Application forms.
- District Engineer explained that they need to be informed of any races or events planned to be held on or using public roads for various reasons.
- Sports Partnership to be requested to do a survey regarding events in the District.

Item 6: Notice of Motions (for decision)

(a) To consider the Notice of Motion in the names of Cllrs P Leonard and W O'Toole. received on 16th January 2025

"That Arklow MD fund and repair the two concrete access ramps on South Beach and investigate the possibility of constructing a public seating area by replacing the existing kerbing with a poured concrete seat with composite timber seat on top (similar to the style of the benches in the harbour) so that the area can be enjoyed by the local community"

District Engineer reports:

Access ramps would fall under the remit of the environment section of Wicklow County Council.

The car park and the access road are not in the ownership of Wicklow County Council.

If the members are happy to fund the benches with discretionary funds for 2025 then we can certainly locate some benches in the public space in our charge.

(b) To consider the Notice of Motion in the names of Cllrs P Leonard and W O'Toole. Received on 16th January 2025

"That Arklow MD fund a redesign of the existing entrance to Croghan Industrial Estate including an assessment of the public lighting which is inadequate together with investing in new signage at the entrance to support the many businesses which occupy this important local employment zone"

District Engineer reports:

The entrance was designed to the standards appropriate to the time and junction is appropriate for the sightlines and speeds of the roads.

All signage at the entrance is the responsibility of the individual businesses and they require a Section 254 licence for the signage to be in place. Ownership of land at location of signage is required. Businesses need to come together and apply for Section 254 Licence.

(c) To consider the Notice of Motion in the names of Cllrs P Leonard and W O'Toole. Received on 16th January 2025

"That Arklow MD support and contribute €2,500 towards a youth social inclusion project currently being supported by County Wicklow Partnership in conjunction with the charity Sail Training Ireland to bring the tall ship 'Maybe' to Arklow Harbour in August 2025 for a round trip to Aberystwyth in Wales"

No child should be excluded but issue is getting enough Irish Students to exchange. Secondary Schools will be written to for expressions of interests. €3,000 To be given to this event. When explained ClIr O'Toole supported this.
