I am writing to advocate for the inclusion and development of dedicated athletics facilities, including a running track, within the Local Area Plan. These facilities would be an invaluable resource for community games, local schools, adult athletes, and sports clubs, significantly enhancing the sporting culture and overall well-being of our region.

Blessington and its surrounding areas—encompassing Ballyknockan, Lacken, Hollywood, Valleymount, and Ballymore Eustace—are home to a growing population eager for improved sports infrastructure. At present, there are no dedicated athletics facilities, leaving our club, particularly as we expand our junior section, without a proper home. This is the largest area in the Wicklow region without proper running and athletics facilities. This gap in resources restricts opportunities for disciplines like shot put, long jump, hurdles, and more. Despite these challenges, our community has produced exceptional talent, and with the right facilities, we believe we could help these athletes achieve their full potential.

Promoting athletics and sport from a young age is especially vital, given that Ireland faces one of the highest obesity rates in the EU. Dedicated sports facilities would not only nurture emerging athletes but also provide a positive outlet for children and families, encouraging lifelong habits of health and fitness. This would have lasting benefits for physical and mental well-being, ultimately reducing the strain on our healthcare system.

The proposed facilities would bring immense benefits to the entire community by:

- Supporting local schools in delivering comprehensive physical education programs.

- Offering a dedicated space for community games and sports events.

- Providing a training ground for Lakeshore Striders, Community Games, and other local clubs.
- Encouraging participation in field sports and diverse athletic disciplines.
- Promoting social inclusion and fostering healthy lifestyles for all age groups.

- We respectfully urge the committee to prioritize this investment in community health and development. Such facilities would ensure that sport and fitness are accessible to everyone, laying a strong foundation for a healthier and more active future.
