This month:

82 New Homes officially opened in County Wicklow

Eighty-two new homes in three housing estates in Co Wicklow were opened today (Friday).

The houses, in Wicklow Town, Newtownnountkennedy and Kilmacanogue, were officially opened by Cllr Shay Cullen, Cathaoirleach of Wicklow County Council, along with Daragh O'Brien TD, Minister for Housing, Local Government and Heritage, and Simon Harris TD, Minister for Further and Higher Education, Research, Innovation and Science.

- Hawkstown Park, Wicklow, consists of eight one-bed, 16 two-bed and 16 three-bed homes, all of which were allocated in the recent weeks
- Mountain View, Newtownmountkennedy, consists of six one bed and 16 two bed homes and will be allocated in the coming weeks
- Jameson Heights, Kilmacanogue, has 20 homes and the residents moved in during the COVID pandemic

Grants for Local Waters & Biodiversity

A range of projects across County Wicklow are to benefit from grants to support the protection and enhancement of local waterbodies.

The Community Water Development Fund is providing a total of just over €23,500 for nine community groups around Wicklow.

Projects approved for grant funding in County Wicklow include:

- Hydrogeological assessment of Arklow Town Marsh to preserve the protected aquatic habitat (Arklow Tidy Towns)
- Glencree River Water Quality Project: Improvement and assessment (An Óige Knockree Conservation Group)
- Three separate Ecological Assessments of Cannistown River/Kilcoole Stream, Newcastle River and Swan River, Bray (Keep Kilcoole Tidy/Kilcoole Biodiversity Group, Newcastle Residents Association/ Biodiversity group, and Bray Tidy Towns/Swan River Conservation Group respectively)
- Enniskerry Tidy Towns Cookestown River Invasive Species survey and action plan
- Snapshot Europe 2022 Wildlife Survey across Wicklow Water Habitats (ReWild Wicklow)
- Refurbishment of Observation Hide at BirdWatch Ireland's East Coast Nature Reserve (BirdWatch Ireland) and
- The Park Stream, Shillelagh. Installation of solar powered water fountain (Shillelagh Peoples Property Ltd)



Wicklow Town achieves 7th place out of 40 Towns/Cities in Litter Survey

Wicklow Town has been assessed as the being 'Cleaner than European Norms' in the latest Irish Business Against Litter (IBAL) survey.

All approach roads got the top litter grade and it was also noted that there were less vacant/derelict sites along Abbey Street/Main Street, with the outdoor seating and substantial planting seen as a very welcome addition.

Wicklow Gaol and environs received a comment as being "exceptionally well presented and maintained" while the Glen Beach Cliff Walk was also noted as a wonderful addition to the town.

Potential units

Wicklow County Council currently has agreements in place for units in Delgany, Bray, Rathnew, Wicklow, Rathdrum, Kilcoole and Enniskerry with delivery ranging from 2022-2024. This includes the 59 units listed above. WCC is in negotiations in respect of over 100 further units with delivery dates yet to be confirmed.

Wicklow County Council is currently holding discussions with a number of developers at preplanning and planning stage. There are over 100 potential Part V units with planning permission but it's difficult to determine whether they will all proceed or even on what timescale.

Housing Maintenance - Heating Upgrade Programme

The adopted budget for 2022 is €236,000. Work has started on new Gas heating installations and will then move on to Oil as the same contractor is doing both. Gas & oil boiler maintenance contracts have been renewed and servicing has started. Arising from the procurement process there have been significant increases in the cost of boiler servicing – in the range 12 to 23%. Similar increases will apply to boiler repair and replacement costs.

Homeless HAP

The Homeless HAP Place finder provides assistance in:

- > seeking out potential properties suitable for households currently identified as homeless or at risk of homelessness:
- liaising with specific households to establish their specific needs;
- > establishing relationships with local property agents and landlords; and,
- > supporting those homeless households to (a) prevent the necessity to enter emergency accommodation or (b) to exit emergency accommodation and secure a tenancy.
- ➤ To date, 396 households (293 families & 103 singles) have been assisted under the Homeless HAP Scheme in Wicklow County Council from the inception on 1st October, 2018 to 30th June 2022. (171 homeless cases, 216 prevention cases to date and 9 direct provision). 118 properties were sourced by WCC.

Addressing Homelessness in partnership with Approved Housing Bodies

Homeless Supported Temporary Accommodation - Kilmantin Hill, Wicklow

There are 11 clients supported in the Kilmantin Hill facility, operated by Dublin Simon, with continuing transition by the clients to suitable, alternative accommodation.

Homeless Family Service - Fitzwilliam Road, Wicklow

Dublin Simon have been engaged by Wicklow County Council to operate and manage the facility at Fitzwilliam Road, Wicklow as a Family Homeless Service. The building comprises of 3 x 1 bed units 2 x 2 bed units and 2 x 3 bed units - Refurbishment works and snagging are now complete.

The first 5 families have now been accommodated and assessments are underway to fill the remaining 2 apartments in the hub.

It is envisaged that families will avail of the service for circa 6 month STA (Supported Temporary Accommodation) with key working support to enable family's transition from homelessness into Homeless HAP or alternative longer term accommodation.

Homeless Supported Temporary Accommodation - San Remo, Bray

San Remo opened to clients in October 2020. The facility, operated by Dublin Simon, incorporates a service model where there are a number of emergency/cold weather Beds and Supported Temporary Accommodation Beds (STA). There is on site key working support linking in with clients.



The Neighbourhood Liaison Committee is now operational and meets monthly.

Homeless Supported Accommodation - Carraig Eden, Greystones

The facility providing 35 ensuite bedrooms with associated kitchens and common areas is fully operational. Wicklow County Council have made arrangements to run an in-reach service with the clients to support them as they continue their journey into more permanent accommodation.

Other Homeless Supported Accommodation

Wicklow County Council owned properties in Wicklow, Bray and Arklow, leased to AHBs, provide 12 units of low to medium supported accommodation targeted to the particular support needs of the clients.

Housing First

Housing first recognises that a stable home provides the basis for recovery in other areas.

Peter McVerry Trust has been appointed as the Housing First Programme Implementer for the Mid East Region and Wicklow County Council is committed to working with them to achieve the targets identified in the programme. Properties will be provided by both Wicklow County Council and Peter McVerry Trust for the programme.

Wicklow County Council has, to date, successfully accommodated 9 clients under Housing First. Other clients proposed for Housing First have been assessed by the team and are availing of key support work pending finalisation of sourcing of accommodation – the main issue facing this programme is the availability of one bed units in suitable locations with easy access to services etc.

- WCC are currently assessing all Displaced Ukrainians persons in the County in order to identify
 their accommodation needs as well linking them in with all the relevant services and supports
 within the community.
- WCC are working through a list of pledged properties within the County and matching families accordingly. As of the 22nd June we will have housed 55 number displaced Ukrainian people. Larger buildings and vacant units are also being identified and explored as potential options for medium to long term accommodation. –
- Arklow Rest Centre closed at the end of May.
- The Community Response Forum continues to meet on a fortnightly basis



2. Community

Library

New Aughrim Library

De Blacam & Meagher Architects have presented their proposals re the new Aughrim library. Subject to approval, it will comprise a building of 200 sq mtrs, on the current site. The new entrance will be at street level. There will be a separate first floor mezzanine study area, overlooking the lending area, with glass frontage. It will be submitted for Part 8 approval over June/July. The proposed time line, allowing for construction tender, envisages the building commencing at the end of 2022, and opening in late 2023.



Baltinglass Story Trail

Wicklow's first ever Story Trail was launched as part of Cruinniú na nÓg on Saturday 11th of June. A Story Trail is a fun way to bring books and reading to families while they are out and about in the fresh air. Pages from a picture book are placed along a trail in a community space and children can enjoy them as the walk. The story is *The Lonely Beast* by Chris Judge and is placed in the Community Gardens in Baltinglass.

Bray Library School Literacy Group Visits

Bray Library commenced specialised visits for primary school literacy groups on Monday 13th of June, as part of their Helping Hand offer to schools. Each session is carefully prepared with staff and teachers liaising beforehand to take into account any learning differences, neurodivergence and accessibility requirements of participants while also taking note of what topics, genres and formats the children enjoy. Before the visits, membership cards are arranged, and staff promote our related services including digital supports to teachers, such as TTRS, Lexia and Borrowbox. A relevant selection of books is arranged by staff beforehand, so that the visit can be spent promoting the joy of reading for pleasure. A total of 6 groups from Scoil Uí Cheadaigh took part in this first round of sessions, which will be rolled out to all interested local schools in September.





Cruinniú na Nóg at Wicklow Library Branches

Wicklow's Creative Ireland team organised an exciting and diverse range of shows and workshops for Cruinniú na nÓg 2022, many of these events events took place in libraries around the county. Activities included traditional singing workshops, filming and editing workshops, Dinosaur Fun, puppet Shows, cardboard crafts, Meet the Instruments at Arklow Library, Story Telling and more.

Creative Schools Programme Arklow Library

Approximately 150 primary school students in Arklow were involved in creating a collection of short videos on the Avoca River with a visual artist, funded by Wicklow Heritage Office. This project will be launched in Arklow Library with all students in attendance to collectively view the completed videos and to enjoy a little celebratory party - a hearty congratulations to all involved from Wicklow County Council!

Yoga at Arklow Library

On Tuesday 21st June Arklow Library celebrates International Day of Yoga with Well Soul Yoga by offering a free introduction to yoga for adults. This will be followed by a Mother & Baby yoga session on Monday 4th July.



Family Fun Day Arklow Library

Every Saturday Arklow Library kicks off Family Fun Day with a storytime at 11am followed by arts & crafts and free play with our Magformers, jigsaws and colouring activities in the library. On May 28th we celebrated Elmer Day with some themed stories and activities.





KPMG Children's Books Ireland Reading Heroes Award

Arklow Library was delighted that their nominee, local reader extraordinaire Lily O'Brien was shortlisted for the KPMG Children's Books Ireland Reading Heroes Award! Lily adds hugely not only to the life of the Arklow Library but also her school reading community, and library staff were thrilled to see her accomplishments recognised at the ceremony in Merrion Square. In addition to celebrating with Children's Books Ireland and KPMG, Lily had the pleasure of congratulating author C. G. SDG Children's Book Club, Greystones Library

Reading Goals is a children's book club, where children read and discuss book related to the UN Sustainable Development Goals. Reading Goals will meet on Wednesday 22nd June and weather permitted; we will walk to the beach to discuss *Illegal* by Eoin Colfer. Here, we will also set out our Summer events, including a massive art project and a beach survey helped by Jim Callery, Environmental officer with Wicklow County Council.

Pride Celebrations in all libraries

Wicklow County Council Library service celebrated Pride throughout the month of June. Book recommendations and colourful displays featuring books with LGBTQIA interest were evident in all branches and the rainbow flag was flown or displayed in all branches. LGBT+ Bookclubs took place in Arklow and Bray libraries and Rainbow storytime sessions to celebrate diversity took place in many of our libraries. Rosamund Taylor and Mark ward facilitated a poetry event in Bray library on 23rd of June and Paul Murphy of Bray LGBTQ + led a workshop entitled "Supporting Your LGBTQ+ Child" for parents.

Community Awards:

As part of its commitment to supporting local community development, Wicklow County Council operates an annual Community Award Scheme. A total of 227 community groups and local organsiations received awards in 2022 to assist them in undertaking community projects in their area.

We are currently on week 4 of our Couch to 2K programme. There are 93 participants taking part. The programme is being delivered through an app called 'Movespring'.

Bike Week 2022

Bike Week took place 14th – 22nd May this year. Our aims for Bike Week were to provide people of all ages and abilities with a variety of cycling events throughout the week. We try to encourage greater participation in cycling, promote the benefits of cycling and enhance the provision of cycling within the community. Wicklow Sports & Recreation Partnership ran a wide variety of programmes and events during Bike Week.



Maintenance Workshops

Beginner & Advanced Bike Maintenance Workshops took place in The Sports Room Wicklow Town, Cycle Plus Greystones and The Avon Blessington. The workshops were aimed at helping cyclists learn how to manage and fix small repairs on the bikes such as puncture repairs, how to change tubes, take wheels on and off quickly as well as tips on how to keep a bike running smoothly. Spaces were limited to 12 for each workshop. Workshops were fully booked throughout the week targeting 70+ people. Workshops were delivered by head bike mechanics and all participants received a Wicklow Sports &



Recreation Partnership drawstring bag, Wicklow Sport & Recreation Partnership bike week buff, a puncture repair kit and tyre lever.

25K 'Pedal for your Medal'

25K Pedal for your Medal was an ongoing event throughout Bike Week, held countywide. Over 90+ completed the cycle receiving a Bike Week medal and a Wicklow Sport & Recreation Partnership bike week buff.



5Cycle to Zen

Seven morning and evening Cycle to Zen's took place during Bike Week. Three in The Avon Blessington, taking in the specular views of the greenway. Two took place in Bray on the promenade and two Burnaby Park in Greystones where was asked people to cycle to our outdoor yoga class. All Cycle to Zen classes were fully booked with over 70+ people taking part.



Social Cycle

Wicklow Sports & Recreation Partnership in conjunction with The Sports Room Wicklow Town held two Social Cycle's during Bike Week. Both cycles took place Saturday 14th and 21st May. The cycle started at The Sports Room in Wicklow Town, along The Murrough to Killoughter, while taking in the scenic views of Wicklow Town. On completion, refreshments were given by The Firehouse Bakery. 22 people took part in the social cycles.



FATBIKE Adventure Rentals

Wicklow Sport & Recitation Partnership in partnership with FATBIKES Adventure ran three, two hour FATBIKE rentals. These took place Wednesday, Thursday and Friday of Bike Week. The three evenings were fully booked with 48 people taking part.





Learn to Cycle Taster Sessions

Wicklow Sport & Recreation Partnership created the opportunity for 12 children to participate in a Learn to Cycle Taster Session in Baltinglass & Tinahely on Saturday 14th May. The parents were delighted with the progress of the their children learning the life skill of cycling.

Inclusive Trike to Track



Wicklow Sports & Recreation Partnership in collaboration with St Catherine's Special School and Rehab Care Bray delivered a Trike to Track session at the track at Shoreline Greystones Sports Park on Monday 16th May. 13 students from St Catherines and 3 clients from Rehab Care participated in 2 separate sessions delivered by Cycling Ireland tutors.



School Grant Applications

There were 71 grant applications for running bike related activities or events in Schools and clubs throughout County Wicklow during Bike Week. The breakdown included 2 secondary schools, 27 primary schools, 36 preschools and 6 sports clubs. The bike events were simple, diverse and engaging to get people of all ages and abilities on their bikes. These activities incorporated cycle races, bike safety talks with community Gardaí, learn to cycle, bling your bike, cycle to training, cycle to social tennis and bike maintenance workshops.

Social Inclusion Community Activation Programme (SICAP):

Aside from delivering on existing programme commitments, the SICAP programme implementers also continue to work extensively supporting the Ukranian refugees.

Bray Area Partnership are chairing and co-ordinating the Bray and North Wicklow Response Forum which brings together statutory agencies, local community organisations, NGOs and volunteers to provide a collaborative and partnership response to the needs on the ground. The Forum meets fortnightly and has between 20-30 attendees.

Co. Wicklow Partnership have recruited three new part-time Support Workers under the SICAP programme to work closely with the Ukranian refugees in the Wicklow, Arklow and Baltinglass MD



areas. They are Irish-Ukranian and are fluent in English, Ukranian and Russian. CWP also provided assistance under the SICAP programme to kit out the Wicklow Hub Centre.

Public Participation Network (PPN):

A successful funding application was made by Co. Wicklow PPN/WCC/LCDC to DRCD and Pobal to run a pilot project that will facilitate marginalised groups engage with the upcoming Local Economic & Community Plan (LECP) planning process. This work will also review Co. Wicklow's PPN Visions for Community Wellbeing. The five consultation workshops will take place in May.

Consultations: PPN Vision for Community Wellbeing/LECP Online Survey; Food Waste Prevention Roadmap; 21 Actions to Tackle Racism Survey; Proposed Amendments to the Co. Development Plan; Impact of Covid 19 on Persons with Disabilities; Unveiling Inequality- A peer support project exploring the experiences of LGBT Travellers and Roma.

Funding Opportunities/Competitions: Social Entrepreneurs Ireland Ideas Academy; Communities Integration Fund; European Year of Youth Micro Grants Scheme; International Charity Bazaar-Funding applications; Clár Funding; Outdoor Recreation Infrastructure Fund; Lets Fund it Organisation- providing support to local charities; Ireland Increasing Digital Reach Initiative Fund; Arklow Municipal District Festivals Funding; AXA Parks Fund.

Training sessions were held recently for member groups on the topics of: Funding; Risk Management; Insurance. All sessions well attended.

Sláintecare Healthy Communities

Launch: The programme launch took place on 3rd June in Ballywaltrim Community Centre. Ministers Feighan officially launched the programme in Bray, and the additional keynote speakers included Cllr Aoife Flynn Kennedy, Cathaoirleach of Bray Municipal District, Brain Gleeson CE Wicklow County Council, Aisling Heffernan HSE Health and Wellbeing Head of Service, and Jennifer D'Arcy, Social Inclusion Programmes Coordinator, Bray Area Partnership. In addition there was prerecorded piece by Minister Stephen Donnelly and a local service user. The launch went very well, and was attended by a wide variety of statutory and community service providers for the Bray area.

Enhancement Fund Update: Designs and budgets are in place to begin the installation of kitchens in both Ballywaltrim Community Centre and the Little Bray Family Resource Development Project. The other projects including the calisthenics equipment, basketball courts and outdoor gym equipment are being put out to tender. The climbing boulder has been extensively researched and is likely to cost more than the original budget, however there is an option to facilitate this additional cost through the Sláintecare Healthy Communities fund.

Co-operation Ireland All-Island Pride of Place Awards

The Awards ceremony for the Co-operation Ireland Pride of Place competition 2021 was held in The Gleneagles INEC Arena, Killarney, Co. Kerry on 16th May 2022. The following groups were nominated under these two categories -



- Kiltegan under Population under Population Category 1- 300
- Neighbourhood Network Time Machine under Community Wellbeing Initiative Category.

Kiltegan Village won a prestigious Pride of Place community award on the night.

Economic Development, Planning and Infrastructure

1. Local Economic and Community Plan (LECP) (Economic)

The Economic Development Unit of the Enterprise and Corporate Services Directorate is charged with implementing the economic actions in the Local Economic and Community Plan (LECP). LECPs detail how Local Authorities will support economic and community development in their areas.

New guidelines have been launched for the preparation of LECPs which will require the Council to consider housing needs when formulating both the economic and community elements of the LECPs. The guidelines are timely as the current LECP finishes in 2022.

The next Wicklow Local Economic and Community Plan (LECP) 2023 – 2029 will set out, for a six-year period, the objectives and actions needed to promote and support the economic development and the local and community development of County Wicklow, both directly and in partnership with other economic and community development stakeholders.

The new plan will take account of lessons learned and the changing needs of communities, climate action and sustainability among other things. The Economic Development unit is seeking to engage with the business, tourism and wider community to help identify priorities for the County over the lifetime of the plan.

Consultation has begun in consideration of the high level goals to inform the LECP, with a workshop held at the Economic Development and Enterprise Support Strategic Policy Committee.

Retail

Bray Central

Practical Completion Cert (PCC) was issued by the Architects for the Scheme on the 15th of February to Wicklow County Council. In accordance with the development agreement an inspection has taken place between the Council's Monitor, Conor Carty, the District Engineer Liam Bourke and the design team for the developer. Once PCC has been agreed the process of transfer of title will begin. The Legal Team for the developer and the Council's Law Agent are in communication with regard to legals.

Oakmount continue to engage with prospective anchor tenants on the two main units in the centre. It is hoped that agreements to let will be settled in the coming weeks. Oakmount has advised that there are



leases in place on all of the leisure spaces and heads of terms are agreed with several new retail units. Fit out of the restaurants continues and Press Up Group has advertised for staff for these units.

Bray Outdoor Performance Space

The letter of Contract Award for design Consultants issued to the successful tenderer on the 30th March. The successful tenderer is Vincent Hannon Architects. An initial meeting with officials from the Council was held on 21st April.

Meetings have taken place with Strand Road residents, Royal Marine Terrace and Martello Terrace. A site meeting took place on the 9th May with the Design Team, Council officials and representatives from the Mermaid Theatre where the different canopy options were discussed. Initial drawings are expected from the Architect within the next week.

When the final design is agreed drawings will be prepared and presented to the Members prior to commencing the Part 8 process.

Bray Harbour Improvements

The requirement for additional environmental assessments was identified in the draft Feasibility Report. During a meeting with RPS in March, RPS undertook to carry out an EIA Scoping Exercise as an add-on to their current engagement. It was also agreed that they should provide ecological services to undertake a Stage 1 Appropriate Assessment Screening. A fee proposal was submitted for additional public consultation on the scheme and the production of a 3D model for the improved visualization of the scheme. The fee falls within the value of the original tender for which RPS were appointed in 2019 to carry out the feasibility study. RPS has been instructed to proceed with this work. A follow up meeting is proposed to clarify the extent of the terrestrial elements of the scheme to be included in the EIA scoping report which shall be referred to until a design is available and may be subject to a Part 8 planning process.

When scoping reports are completed and agreed, a new tender will be required to procure engineering services for the preparation of detailed designs and EIAR to submit to An Bord Pleanala for planning approval. It is also proposed that the council investigate the feasibility of acquiring a portion of the foreshore by CPO for the marine element of the scheme. This can be decided in parallel by An Bord



Pleanala and may avoid the need for a foreshore licence application for the scheme. At a meeting with BHJDC on the 5th May, stakeholders were updated on the status of the scheme.

Town Teams

Under the Government policy, Town Centres First, the establishment of Town Teams is encouraged and we are likely to see more Town Teams in situ over the coming years.

Most Town Teams in Wicklow have been operating since 2018. It is considered timely to carry out a review of the town teams and with this in mind Wicklow County Council has appointed Mr Allen McAdam of MCA Consulting to conduct the review. It is proposed to present the results of the review at a plenary meeting of all the Town Teams to be held in early 2022.

Masterplans for Town Centres under 10,000 population

Blessington has been awarded funding of €100,000 to develop a Master Plan for the town. This will also allow plans for projects identified as part of the drive to become e-greenway ready to be advanced.

This initiative is a key part of Our Rural Future – the Government's ambitious five-year strategy designed to reimagine and revitalise rural Ireland. It is also linked to the Government's 'Housing for All' strategy and the forthcoming 'Town Centre First Policy' which will be announced in the coming weeks.

Wicklow County Council will now work closely with local community groups, retailers and members of the Town Team in devising and delivering on the objectives of the Masterplan building on the very comprehensive Health Check carried out by Future Analytics.

Arklow Town Team

Arklow Town Team is collaborating with Wicklow County Council to aid Main Street traders by spreading the word that Arklow is 'Open for Business'. Arklow is currently in a phase of great transformation with large infrastructural schemes underway which will enhance the town for residents and visitors alike. It is important that businesses are supported for the duration of the works.

Arklow Town Team held a second 'Trip Down Memory Lane' event in the Arklow Library, where more stories were recorded from past employees of Arklow Pottery and members of the community who had a connection to Arklow Pottery which will be included in our Arklow Pottery Online project. An archive is



also being created of the Arklow Pottery stamps over the years. The Web designer has been briefed and is working on the new website. The content is being written which will include a new Pottery Heritage Trail.

The Arklow Main Street is in bloom as the 125 Flower Baskets have been erected. The baskets have brought colour and vibrancy to our town centre.

The Interactive Tourism Kiosk project is progressing well. The contractors have coordinated with our Visit Arklow website developers, In Good Company, and they are now able to display and enhance the articles from our website. The design process has now started. An EXPLORE ARKLOW section will be created exclusively for the screen with the onus placed on brand new maps of the town, its points of interest, amenities, and selected walks.

Bray Town Team / Bray Town Recovery Team

Terms of reference were issued to the Bray MD Members in 2021. The Cathaoirleach is reviewing these and will be examining the best way forward.

Greystones Town Team

Greystones Train Station project being led by Greystones Town Team and with the support of CIE, Irish Rail, Greystones Tidy Towns and the Whale Theatre is progressing the project with the mural due to start soon.

Wicklow Town Team

The Team Structure is currently being reviewed as some members plan on stepping down as their projects have now been completed. The focus going forward will be to attract younger members from the age group of 25 to 35 onto the Team.

The Heritage Walks are proving very successful and there are now 8 volunteers to lead the walks. These have already been guided on the Trail by John Finlay.



The team are still working hard to advance the Greenway and other projects being considered are a Ballyguile walk and a pilgrim walk from Glendalough to Wicklow Town as well as a pump track on the Murrough.

It was agreed at the April Meeting that the Town Team would attend at least 3 WMD meetings during the year to keep the elected members updated on projects etc. It was also agreed to send all elected members of WMD the minutes of the Town Team meetings.

Blessington Town Team

In conjunction with the Town Teams the following Festivals/Events took place during May; The Blessington area Rose of Tralee fund raiser, Darkness into Light walk, Glimpses of Blessington and District before the lake talk presented by Seamus Matthiu, World premier of 'Blessington' by Adam Walker & Fiachra Garvey in Russborough House, The West Wicklow Festival in Russborough House, Ninette De Valois, Baltyboys House history tour, and Ninette De Valois festival programme in the Tramway Theatre.

A presentation was made to the Town Team by Kaleidoscope for their upcoming festival at Russborough House, to be held from 24th -26th June 2022. The festival last took place in 2019 and is due to increase in capacity from 15,000 to 25,000. It will take place across eight stages of music, talks, debates, panel discussions, Q&A's, food tastings, comedy and more. Advertising for the festival will target the Irish Diaspora in the UK and USA

The National Tidy Towns Competition will be held in June, July and August 2022, and Blessington will once again be entered. The team are pushing to achieve a bronze medal in 2022. But the key to this success has been the hard work of the Blessington Tidy Towns committee and volunteers; they encourage everyone to work together for a better of Blessington. The tidy towns group work with Wicklow County Council and the community to deliver results for Blessington. In the last 10 years Blessington has moved from bottom of the results to the top 25% in 2021 and the group are sure further success is possible.

There is ongoing engagement from Businesses in Blessington, with staff from Wicklow County Council regarding getting business's Greenway ready.



Streetscapes

Wicklow County Council has been allocated €320,000 in Streetscape funding under the Department of Rural and Community Development Town and Village Streetscape Scheme.

The Streetscape Enhancement Initiative is a key part of the Government's 'Our Rural Future' and is designed to make our rural towns and villages more attractive colourful and vibrant places to live, work and visit.

108 applications were received and approved under this measure with 56 businesses submitting required documents to receive payment. €210,171.56 has been paid out to date.

It is expected that there will be new strategic funding announced in 2022.

Tourism

Tourism Strategy and Marketing Plan 2018-2022

The strategy sets out a number of challenging but achievable priorities along with a series of detailed actions to be implemented over the next 5 years

The Key Priorities are:

- 1. Develop New Accommodation
- 2. Develop Key Towns as Visitor Hubs
- 3. Develop a Masterplan for Glendalough
- 4. Grow Thematic Experiences
- 5. Market our County by Developing A Common Narrative

Wicklow Passport Display Units:

The Wicklow Passport remains a key tool to help bring visitors to lesser known areas in Wicklow. We are growing our network of stamping locations with new members in the Greystones and Bray area. Online sales are ongoing, and feedback from participating businesses remains very good.



Wicklow Tourism Map

The Wicklow Tourism map was printed early May, and extensive distribution has been carried out around the County. The production of the map was made possible thanks to the support of the various members advertising on the map. The map is available for collection at Wicklow Town Hall in Wicklow Town.

Wicklow Influencer's Itineraries:

In May, we ran two more itineraries. Firstly, we welcomed Deric Hartigan (TV3 Weather Presenter) to an outdoor activities weekend that included mountain biking, great food and drinks and climbing Lugnaquilla. Deric heavily promoted his trip through extremely popular social media channels. We also created a new blog featuring his itinerary: https://visitwicklow.ie/mountain-bike-climb-lugnaquilla-great-local-beer-food-two-days-of-outdoor-fun-in-wicklow/

We then welcomed Siobhán O'Connor from the Irish Mirror for a family weekend in South Wicklow. We packed a lot in over the two days with many activities and visits including Mount Usher Gardens, Avoca Handweavers, Tinahely Farm, the Chocolate Gardens of Ireland, and Rathwood. Siobhan shared her experience on social media, and we are finalising our blog to be shared on the visitwicklow's social media platforms.

Trip Wicklow Rose

Wicklow Tourism helped organised a get together for the 20+ ladies participating at this year's selection of the Wicklow Rose. The event was held at River Valley Holiday Park where the participants enjoyed a variety of outdoor activities including electric kart racing, archery and more. Wicklow County Council is the main sponsor for the Wicklow Rose, and the objective is to maximise exposure through the Rose or Tralee event and various media opportunities. Wicklow will be hosting a group of national and international Roses in August before the main event in Tralee. We are currently working on a route that will showcase Wicklow's stunning landscap.

Accessibility Trip:

Wicklow Tourism is keen to showcase accessible experiences. In partnership with Bray Rehab Care and Bray Area Partnership, we invited Ciaran and Billy to Bray Bowl. Billy and Ciaran are wheelchair users, and they showed us how to use the accessible lanes at Bray Bowl. We created a short video that was



then promoted online. The video enjoyed extensive reach and engagement and can be viewed at https://fb.watch/dyUziwwGx5/

It is our ambition to regularly share new accessible experiences and showcase Wicklow from different perspectives in a more inclusive way.

EcoTrail Wicklow:

EcoTrail Wicklow was successful in securing funding from Failte Ireland for the 2022 edition of the race in September. This support is fabulous and guarantees extensive exposure for the event both at home and abroad. We are currently working on a plan to make EcoTrail Wicklow a three day experience and keep participants for a few days in and around Bray and Wicklow. The main objective of EcoTrail from a Wicklow Tourism perspective is to showcase Wicklow as a fantastic outdoors destination. The extra resources offered guarantee that EcoTrail and Wicklow will reach new and untapped markets.

Celtic Routes Meeting

After two years of online meetings, the Celtic Routes team met in person in Waterford. Along with our Welsh partners, we discuss ongoing promotional activities. Extensive marketing is happening in the UK through various media including online promotions, print media features and press trip. Wicklow hosted a press trip in September of 2021, and the article was printed in the May edition of the Country Walking magazine in the UK. See itinerary and article at link https://visitwicklow.ie/from-rathdrum-to-bray-four-days-walking-the-wicklow-mountains.

The Celtic Routs project was obviously disrupted through the Covid 19 pandemic, but is now in full swing. The project has been extended into 2023 and will continue to market heavily our various destinations.

Laragh and Glendalough Traffic Management

Weekend traffic management arrangements have been introduced in Laragh to deal with the problems caused by heavy volumes of cars entering the village on Saturday, Sundays and public holidays to visit Glendalough and the surrounding area with effect from 4th June

This pilot scheme involves:



- Provision of a free (weekend / public holiday) bus service to connect the Laragh carpark on the R755 and the Glendalough Visitor Centre.
- Signs to warn drivers when the Upper car park and the Glendalough Visitor Centre car park are full and drivers will be directed to the Laragh car park. This can be accessed by following directional signs provided.

Glendalough Masterplan and Wicklow Visitor Orientation Study

This is a Fáilte Ireland funded project led by FI with strategic partners NPWS, OPW, Coillte and WCC. The Plan covers visitor attractions and activities available in the area and the first stage of stakeholder engagement has been completed.

The consultant team is now engaging with some of the key landowners to assess the feasibility of developing additional off road trails between Laragh and Glendalough and provision of additional parking. The process has identified a number of issues: congestion at key sites, concerns over security, capacity and quality of car parking and visitor services, issues with local access, and erosion and degradation of the environment.

Visitor Experience Hubs have been identified around the county where there is a particular focus of visitor attractions. Development of these hubs will build capacity, help disperse visitors across the county, encouraging longer stays and greater investment in the area. The team is developing detailed plans for walking, mountain biking, off road family cycling.

Measures have been taken this year to introduce additional temporary parking and to use traffic counters to improve parking management and signage. Toilet facilities have been upgraded.

The consultants have prepared the draft masterplan and this was presented to members of the Laragh/Glendalough Community on the 27th October 2021 and to the members of at the Ordinary Meeting of Wicklow County Council on the 6th December 2021.

Next Steps: Further Consultation, Strategic Environmental Assessment and Economic Appraisal. A number of multi-agency sub-groups have been formed to address Environmental, Financial and Management issues; these are data gathering at present.



Outdoor Dining

All Local Authorities were invited to apply to Fáilte Ireland for funding under Part Two - Local Authority Weatherproofing & Outdoor Dining Enhancement Scheme - to develop streets and public spaces to facilitate outdoor dining in urban tourism centres, enabling access to outdoor seating for extended periods throughout the year.

Wicklow County Council applied for and was awarded funding for Outdoor Dining and Weatherproofing for Market Square in Wicklow Town (€119,000) and Abbey Lane in Arklow (€81,000). Works are almost complete on the Wicklow project, the windbreaker flower boxes with MARKET SQUARE etched on them have been installed.

Rural and Urban Regeneration Development Fund Grant Applications

Blessington has been awarded just over €1m funding under the Rural Regeneration Development Fund (RRDF). This will be used for a major regeneration of Blessington Town Centre and related projects. It will be utilised for the regeneration of Blessington Town Centre, the development of plans for public realm works, the redevelopment of a derelict property to create an eHub and a Visitor Centre for the forthcoming Blessington Lakes eGreenway. This strategic funding along with the planned completion of the Blessington Inner Relief Road and the funding for the Blessington Lakes eGreenway will help achieve Wicklow County Council's long-term vision for Blessington and enhance Blessington as a place to visit. Combined with the proposals for developing a Masterplan for Blessington, this project will add to the quality of life of the entire community by optimising digital connectivity, supporting employment and skills and enhancing the public realm in line with the objectives that underpin "Our Rural Future" Ireland's Rural Development policy.

A call was announced for RRDF category 1 proposals with a closing date for applications on the 29th April 2022.

URDF: Urban Regeneration Development Fund

Part 1 of the Arklow URDF Project involves the refurbishment of the Courthouse and the development of an Enterprise Space in the former Town Council offices. Part 2 of the project the public realm works are currently underway.



Funding of €7.14m has been announced for the Bray Harbour Area Integrated Regeneration Project from the Urban Regeneration and Development Fund (URDF) and this funding has the capacity to unlock the great potential of Bray Harbour and surrounding area.

Following a presentation to the Bray members on the 11th January, RPS recently completed a draft feasibility report covering the marine and terrestrial elements of the Bray Harbour Improvements Scheme. A meeting of the Bray Harbour Joint Development Committee took place on the 24th February at which the preferred options described in the report were presented along with some further matters that have been requested for attention.

It is recognised that space for existing and proposed recreational facility providers around the harbour remains an issue and was discussed at the meeting. RPS will be asked to further examine the regeneration opportunities on the north side of the harbour that may also facilitate the provision of improved recreational infrastructure. RPS has also been requested to address future sea level rise in the terrestrial works proposals and to outline the stakeholder engagements that took place in preparing the report.

The preferred option for the marine works provides for extending south pier northwards and extending a breakwater spur northwards from the north pier to create a smaller outer harbor. Along with another spur on the inside of the south pier this will serve to greatly reduce the wave action from the north easterly winds that are responsible for the wave damage that occurs in the harbor. This will also provide a berth for small passenger ferries and also provide a holding area for boats while waiting on the tide before entering the main harbor. Dredging is also proposed to facilitate mooring but access in and out of the current harbor will be still dependent on the tides.

An estimate of about €8.5m plus VAT has been provided for the preferred option for the marine works. A cost for the terrestrial works was not provided and this has been requested for inclusion in the report. A steering group meeting is planned for the 9th March, at which additions and amendments to the report will be discussed. Additional works, in relation to environmental assessments will also be examined with RPS to determine if they can be progressed within the current contract. The draft feasibility report has found that there are significant potential environmental impacts and that the planning decision will most likely be determined by An Bord Pleanala.

The Bray Sustainable Bridge Project is on hold until An Bord Pleanála make a determination on the need for an Environmental Impact Assessment Report (EIAR).



The requirement for additional environmental assessments was identified in the draft Feasibility Report. During a meeting with RPS in March, RPS undertook to carry out an EIA Scoping Exercise as an add-on to their current engagement. It was also agreed that they should provide ecological services to undertake a Stage 1 Appropriate Assessment Screening. A fee proposal was submitted and included for additional public consultation on the scheme and the production of a 3D model for the improved visualization of the scheme. The fee falls within the value of the original tender for which RPS were appointed in 2019 to carry out the feasibility study. Accordingly the RPS has been instructed to proceed with this work.

When scoping reports are completed and agreed, a new tender will be required to procure engineering services for the preparation of detailed designs and EIAR to submit to An Bord Pleanala for planning approval. It is also proposed that the council investigate the feasibility of acquiring a portion of the foreshore by CPO for the marine element of the scheme. This can be decided in parallel by An Bord Pleanala and may avoid the need for a foreshore licence application for the scheme. At a meeting with BHJDC on the 5th May, stakeholders were updated on the status of the scheme.

Maritime

The area of offshore renewable energy is rapidly evolving. Due to the number of projects proposed off the coast of Wicklow it is important that the County engages with the process to enable the community of Wicklow to benefit from the opportunities arising while mitigating against any likely impacts that any offshore renewable project will have.

Key milestones have been:

The Offshore Renewable Energy Support Scheme Consultation. Wicklow County Council made a submission strongly supporting the case for the funds created as a result of the offshore renewable energy projects to be managed and distributed locally rather than centrally.

The adoption of the Maritime Area Planning (MAP) Act 2021 aimed at harnessing Ireland's offshore wind potential while protecting our marine environment.

One of the elements of the MAP is the creation of a new maritime consent process (MAP) Under the special transition provisions in the MAP Act, the Minister for the Environment, Climate and Communications will have the responsibility for assessing and granting MACs for a first phase (Phase One) of offshore projects, which satisfy the definition of "relevant maritime usage" under the Act (the Relevant Projects).



The relevant projects of interest to Wicklow include the Codling Wind Park and the Dublin Array A consultation process on the Offshore Renewable Energy Maritime Area Consent (MAC) Assessment for Phase One has taken place.

The purpose of the consultation is to:

- Set out the proposed approach to MAC assessment for Relevant Projects
- Provide important information on various aspects of the new MAC regime for Relevant Projects
- Invite feedback from interested stakeholders on the proposed approach to the assessment of Phase
 One MAC applications

Following completion of the consultation process, the Minister for the Environment, Climate and Communications has announced the opening of the application process for Marine Area Consents to relevant projects, it should be noted that the Arklow Bank Wind Farm, which is Ireland's first offshore wind farm, is at an advanced stage of planning and has been operating under an earlier consent regime. SSE has recently announced its intention to apply for a larger more ambitious project under the new MAC scheme.

An Bord Pleanála granted planning permission to SSE Renewables to develop the onshore grid infrastructure necessary to connect the 800MW Phase 2 of Arklow Bank Wind Park. This decision is a critical milestone in the development of Arklow Bank Wind Park and the location of its Operations and Maintenance base in Arklow.

Food and Beverage Strategy

Funding of €175,000 has been secured via the LEADER Food Programme for a Food and Beverage Coordinator role for Wicklow Naturally CLG and for the supply of event costs for the period 2021 - 2023 in support of Wicklow Naturally's Promotional Activities Plan. Wicklow Naturally will contribute 5% from subscriptions and it is proposed that Wicklow County Council will contribute €35,000 over the two year life of the project.

Wicklow Naturally, supported by Wicklow County Council was successful in securing funding from the Department of Agriculture, Food and the Marine in respect of the development of Food Trails as part of Wicklow's tourism offering. Wicklow Naturally will be working with Wicklow Tourism to develop this product. A number of trails have been identified, with photography, videography and a pilot tour to take place in June.



Wicklow Naturally continues to increase its network of members in 2022 to add to the array of County Wicklow produce. Wicklow Naturally members will be represented at a range of events throughout the year including Taste of Wicklow, the Tinahely show, Ploughing Championships, OctoberFeast and Gifted; all aimed at raising the profile of Wicklow produce.

2. Planning and Development

County Development Plan Review

Following consideration of the Draft Wicklow County Development Plan 2022-2028 and the Chief Executive's Report in respect of submissions received, the Members of Wicklow County Council, resolved in accordance with Sections 12(6) and 12(7) of the Planning and Development Act 2000 (as amended), that the Draft Development Plan be amended. The proposed amendments constitute material alterations to the Draft Wicklow County Development Plan 2022-2028.

Submissions or observations regarding the Proposed Material Amendments to the Draft Plan were invited and 76 submissions were received by the closing date of Wednesday 25th May 2022.

A report on the submissions is being prepared for further presentation to the Members for their consideration.

Wicklow Heritage & Biodiversity Office

County Heritage Plan (CHP) allocations from The Heritage Council - The following projects and activities are underway in 2022 - Wicklow Barn Owl Survey; Wicklow Swift Champion Project; Heritage Communications; Glendalough Community Archaeology project and a County Wicklow Community Archaeology initiative.

Wicklow Barn Owl project is underway, survey work has commenced, social media Facebook page created, over 100 reports of sightings (including historic) and expressions of interest in hosting a nest box received. Barn Owl Nest boxes (internal and external) erected by NPWS in 12 + locations to date including the grounds of Clermont House.

Swift project underway - promoted via social media, dedicated point of contact, nest boxes provided to tidy towns groups and schools.

Allocation received through CHP for appointment of a part time community archaeologist. Request for quotations (RFQ) issued for the provision of **Community Archaeology Services** for Wicklow County Council to work with Heritage Office to support landowners and council in their role as custodians of archaeological heritage.

Community Monument Fund (CMF) 2022- Seven CMF projects currently underway, overseen by Heritage Officer, allocations as follows: Arklow Castle repairs, €84,621; Mullinacuffe Historic Church ruins repairs €14,954; Castlekevin, Roundwood conservation plan €18,682; Baltinglass Hills – Lidar Survey €29,362; West Wicklow Medieval church and graveyards –geophysical survey and access improvements €30,000; Castlekevin podcast production €7,748; Abbey Lane, Arklow – research & interpretation €7,072..



Local Biodiversity Action Plan Fund: Funding allocations of €48.000 confirmed to Heritage Office under the LBAPF for a continuation and expansion of the Brittas Bay Conservation Project and the initiation of a county hedgerow survey.

Heritage Communications: Ongoing distribution of 'managed for wildlife' and other pollinator resources among public and local authority staff. 20+ events held in County Wicklow for National Biodiversity Week 15th-22nd May. Meeting of Wicklow ICAN groups hosted on 9th May in Wicklow Library.

Protected Structures Grants: Projects under the Built Heritage Investment Scheme (BHIS) and the Historic Structure Fund (HSF) grant schemes from the Department of Housing, Local Government and Heritage underway. BHIS includes 11 projects under a county allocation of €96,000. HSF includes 3 projects; €25,000 towards Russborough Weir Wall repairs; €40,000 for St Matthews Church, Newtownmountkennedy, and €10,000 to vernacular house at Greenan More. All projects, reporting and recoupment to be overseen by heritage officer on behalf of planning section.

Whitestown Remediation Project

Wicklow County Council has employed Fehily Timoney & Company to advise on the remediation of the site at Whitestown, in accordance with the judgments of Mr. Justice Humphreys



The first draft remediation plan was lodged with Brownfield restoration Ireland Limited (BRIL) on 27th November 2020. Following submissions from a number of parties a revised remediation plan, which incorporated requests contained in the submissions, was circulated on the 28th April 2022.

The revised draft remediation plan also contains a Natura Impact Statement as requested by the NPWS in their submission.

Recycling Centres

Contract documents have been issued to a civil Engineering consultancy to commence work on the design of a new roof and refurbishment of Bray Recycling Centre.

Climate Action

Climate Action Plan 2021 - Securing Our Future

The Climate Action Plan, which was launched on 4th November 2021, is an ambitious plan to put Ireland on a more sustainable path, cutting emissions and creating a cleaner, greener economy and society

The Climate Action Plan follows the Climate Act 2021, which commits Ireland to a legally binding target of net-zero greenhouse gas emissions no later than 2050, and a reduction of 51% by 2030. These targets are a key pillar of the Programme for Government.

The plan sets out 475 separate actions to halve Ireland's greenhouse emissions by 2030, including extensive offshore wind power, retrofitting 500,000 homes and putting a million electric vehicles on the roads.

The public sector will lead by example and halve emissions by 2030. Green Teams will be established in every public sector body. No new fossil fuel heating systems will be installed in public buildings after 2023, except in very limited exceptional circumstances. All new fleet purchases will be electric from 2023, where such vehicles are available.

A new National Retrofit Plan will drive demand and make retrofitting more affordable whilst there are increased targets for district heating and the public sector, and strengthening building standards for all buildings.

Just transition principles are embedded in the plan, including the principles that people need to be equipped with the skills to benefit from changes and that costs need to be shared. A Just Transition Commission will be established.

All increases in carbon tax receipts are earmarked for targeted social protection measures, an expansion of retrofitting, particularly for social and low-income homes, and agri-environmental projects.

Wicklow County Council will commence the Advance Planning Stage of the development of the plan in Q2. This will include a review of the Climate Adaptation Strategy adopted in September 2019 and a Countywide Baseline Emissions Inventory (BEI).



Wicklow Climate Action

The Tree Management Policy was adopted by the Council on 10th January 2022. Work is ongoing to implement the protocols in the policy. This includes the development of an app to capture all information about existing trees on council owned land. The Climate Action budget will cover the cost of a tree survey in one town in each MD in 2022. The MDs will need to provide the budget for this survey work and any resulting recommendations in the future.

A draft Glyphosate Policy is on the agenda of the June Plenary Meeting. Work is ongoing to bring an awareness to staff, community groups and the public on the environmental impacts of applying glyphosate. As with the Tree Policy, an App is being developed to record and map usage throughout the County by WCC Staff. Helen Purcell has raised the use of these apps by WCC staff with SIPTU.

Arklow Decarbonisation Project: RPS Consulting Engineers has delivered the Baseline Emissions Inventory, the Register of Opportunities and Placemaking and Active Travel Reports. We await the delivery of the Implementation Plan. CARO have been reporting on progress of the Arklow DZ Project to DECC as they are treating it as an unofficial pilot for the Country.

A National EV Strategy was launched by the Department of Transport in March. This strategy places an onus on the Public Sector to increase EV penetration in the public sector fleet, to coordinate the delivery of infrastructure across all levels of government and to facilitate the development of a comprehensive mixed-type EV charge point network serving the needs of all citizens. The Climate Action Officer is coordinating an input from a number of departments to develop a strategy for the Council on the rollout of EV Chargers in the public domain and TWES are working on transitioning fleet to EVs.

The Green Team, a cross departmental team with 16 members, is working on a policy to rollout the use of recycled paper throughout the organisation. Alternative green cleaning products are being trialled. The members of the Green Team will be tasked with forwarding projects, services etc. that meet the theme of Climate Action for circulating via social media on the 1st July #yourcouncilday

A tender for a consultant to develop a Conservation Management Plan for Bray Head and Wicklow Head closed on Friday 27th May 2022 – no responses were received. Negotiated procedures with a suitable consultant have commenced.

Environmental Awareness

Wicklow County Council is one of three local authorities involved in an EPA funded pilot on separate collection of textiles which will test different approaches for improving the collection of textiles. The project was launched in May with two collections held, one in St Mary's College and one at the recycling centre. The textiles are being graded to see what quality of clothing is donated and how much potential there is for reuse of the material.



A new sustainability module for the GAA Future leaders programme developed by Wicklow, Kildare, and Meath local authorities with CARO was launched at Croke Park.

Seventeen schools were awarded a Green Flag in May.

The Relove Fashion competition for secondary schools for the next school year was launched to allow schools to plan for it in curriculum development.

A composter and two worm composting systems were installed to test composting options for food waste in the staff canteen and provide a demonstration of composting to staff. All systems are now being used to take food waste from the canteen and offices.

An LAPN project will link to the Bikes for Africa project and involve delivery of workshops on bicycle repair in the three larger recycling centres and a video animation to promote extending the life of bicycles through good maintenance. Workshops will target both adult and youth participation.

An LAPN project to provide training on composting has now been completed and a case study is being prepared. The project was extended to provide training for Loreto College in Bray and Newcastle Tidy Towns will receive training in the coming months.

The annual National Spring Clean Campaign has finished with 118 groups registering to undertake a clean up event.

Wicklow County Council is working with eight other local authorities to develop a series of short videos on dog fouling for use on social media. The videos are currently in production.

Sustainable Energy Committees

Greystones/Delgany and Wicklow Town SECs both completed their energy master plans.

Work continues on the Energy Map Plans, EMPs for Enniskerry, High Park and Blessington.

Newtownmountkennedy, Glenmalure and Laragh have also completed Energy Master Plans.

Consultants have now started work on the Arklow SEC energy master plan.

Glenmalure, Laragh and Wicklow Town are planning Energy Awareness Days for June.

Control of Dogs



Dog Licences

294 licences were purchased for dogs in the month of May 2022, of which 139, or 47%, were purchased online. Reminders during May, for renewals late May/early June totalled 260.

Beaches

Bathing Water Season

Wicklow County Council commenced its Beach Lifeguard Service on June 1st. The service provides fully qualified beach Lifeguards at seven locations along the Wicklow Coast Line namely, Bray North & South, Greystones South, Wicklow Harbour, Brittas Bay North & South and Arklow South Beach. Each of these locations will be patrolled from 11am to 7pm daily until the end of August, with weekend cover provided on our Blue Flag Beaches in Greystones and both Brittas Bay beaches.

Water Safety - Stay Safe this Summer

Wicklow County Council strongly advise the public to use Lifeguard Patrolled beaches. The lifeguards focus is on the avoidance of incidents by providing advice and intervening when hazards are identified. Additionally, they provide first aid for those using the beach and they are in contact with the Irish Coast Guard should they be required.

In general, never swim alone, make sure you can be seen – wear bright swim cap etc, never swim following alcohol intake and warm up fast upon getting out of the water. Your body can continue to cool for up to 30 minutes following a swim – get dressed quickly with many layers and have a warm non-alcoholic drink.

Blue Flag

Wicklow County Council retained its Blue Flags for Greystones South, Brittas Bay North and Brittas Bay South beaches, awarded by An Taisce in recognition of the excellent water quality and facilities available at these bathing areas.

The An Taisce Blue Flags programme demands consistently excellent water quality over a four-year period.

Two other bathing locations in Co. Wicklow have achieved excellent status. This brings the number of bathing locations in Co. Wicklow with the status Excellent to five:

- Brittas Bay South
- Brittas Bay North
- Arklow South
- Clogga
- Greystones South

Caravan Parks

There are a total of 28 caravan parks currently operating in County Wicklow. 21 parks have renewed their licences and the remainder are in the process of applying for their licence. This licence is issued under the Local Government (Sanitary Services) Act 1948.

Public Participation: Identification of Bathing Waters



Local authorities must identify official bathing areas in their area every year so that they can be monitored for safety, water quality and their level of use. There are six bathing waters identified under the Bathing Water Regulations 2008. These are Bray South Promenade, Greystones South Beach, Silver Strand Beach, Brittas Bay North Beach, Brittas Bay South Beach and Clogga Beach.

The Council also monitors nine other waters used in the County namely; South of Bray Harbour, The Cove Greystones, Kilcoole Beach, The Murrough Wicklow, Wicklow Harbour Bathing Area, Wicklow Harbour Lifeboat/Sailing Club Area, Arklow South Beach and The Cove Arklow.

Wicklow County Council is asking people who swim at beaches, lakes and rivers to tell them if they think they should maintain existing designated bathing waters designations or give a new official bathing area designation to areas that are commonly used for swimming, but not identified at the moment. Closing date for submissions has been extended to 30th June 2022.

M11N11 Junction 4 to 14 Improvement Scheme

The Option Selection report was published along with Bulletin #11 on the project website www.n11m11.ie on 14 December 2021. The publication followed the review of submissions received during public display in 2021. Phase 3 Design and Environmental Evaluation was due to commence in Q1 2022. The scheme is currently suspended as no funding has been provided to continue during 2022.

The Wicklow County Council project team are continuing to meet virtually with the public and any interested parties.

M11N11 Bus Priority Interim Scheme

The BPIS web site is now available on www.n11m11bpis.ie. This website will provide up to date information on the progress of the scheme.

N11 Parallel Service Road at Kilmacanogue

A noise assessment of the 7 no residential properties that are adjacent to the new Parallel Service Road Scheme was carried out during April and May 2022. The draft report concluded that the change in junction layout does not change the noise levels at nearby properties when compared to the previous layout. However when road traffic speeds are increased to 100kph along the N11, noise levels were elevated at the nearest noise sensitive locations by up to 4.5 dB Lden. This would cause a potentially significant impact to the receptors along the N11. Following on from this report, feasible noise mitigation measures are now being investigated.

N81 Knockroe Bend Realignment

The tenders for the Per Cent Art Feature will be published by the Arts Officer shortly.

N81 Irishtown West, Whitestown Lower, Hangman's Bend and Tuckmill Lower "N81 Four Studies"

Following completion of Transport Infrastructure Ireland (TII) Phase 1 feasibility studies (N81 Four Studies – Feasibility Report), Wicklow County Council will now look to progress the following two projects:

- N81 Whitestown Lower Project; and
- N81 Hangman's Bend and Tuckmill Project.

Wicklow County Council will commence procurement for Technical Advisors to undertake TII Project Management Guideline Phases 2 to 4 (inclusive) for the above projects, with the aim to procure an advisor and commence Phase 2 in 2022.

N81 Pavement Capital Works

Resurfacing works of 1km of the N81 between Tuckmill and Saundersgrove will be tendered for in 2022. Ground Investigation was carried out in May with pavement design to follow.

N81 Capital Maintenance

Resurfacing work at Monaspick and Annalecky was completed in May.

Redford Junction – Part VIII submissions for the Redford Park Junction improvement scheme closed on the 10th June 2022. This is to upgrade the existing signal-controlled Redford Park Junction consisting of improvements for pedestrians and cyclist with the upgrade of footpaths and the inclusion of protected cycle track facilities, as well as an improvement through the upgrade of two existing bus stops in the immediate vicinity of the junction.

Cunningham's Corner - As part of Specific Road Improvement Funding, realignment of a bend is required on the R755 Roundwood to Killmacanogue Road (near Djouce golf club) where there have been a number of incidents over the years.

Drainage works substantially complete on off-line section. Landscaping and planting have been completed with fencing to follow on at end of May. Tender complete for overlay and surfacing works, with contractor to start on site by end of May. Final drainage works to be commenced when traffic has moved to new section of road.

Sally's Bridge - Construction commenced at Sally's Bridge to widen the existing junction to improve sight lines and turning movements in late August 2021. Fencing to be completed by end of May 2022.

Speed Limit Review

A county wide review of speed limits has commenced. Elected members, the Garda and a range of stakeholders are being contacted in advance of the preparation of a draft review document. There were **115 incidents** attended during the month of May 2022. Individual Fire Stations were mobilised on a total of **141 occasions** including 5 incidents in other counties.

Operational activity for the month of May **increased by 28% on the preceding month** (April 2022 – 111 mobilisations). This is accounted for by the following: mobilisations to domestic fires increased from 12 to 22, gorse fires increased from 7 to 14, ambulance assists increased from 7 to 22, there was an increase in small malicious fires close to urban areas, up from 15 to 22.

Operational activity for the month of May 2022 was up 41% on the equivalent month in 2021 (May 2021 – 100 mobilisations). When compared year on year increases occurred in alarm activations (up from 13 to 25), gorse fires (up from 10 to 15), vehicle fires (up from 1 to 8 mobilisations) plus small increases in a range of other incident types.



General Municipal Allocation and Discretionary Fund 2022

The decision taken by Members at the LPT meeting on July 27th 2021 to raise the LPT basic rate by 6% resulted in an additional €1,043,460 in the Revenue Budget for 2022.
