#### **Footpath Renewal**

Work continuing on cleaning Main Street. Areas for repair have been identified. Tender awarded, scheduling of works ongoing to fit around traffic management requirements and resources available **Other works** 

Topographical Survey completed on Rathdrum Main Street. Information to go to consultant Masterplan of Seaview Avenue – Request for Tenders sent to Design Teams, awaiting responses.

#### The following requests/matters were raised by Elected Members.

Cllr. Murphy requested a review of maintenance at the duck pond. Damien Byrne (DB) said this was part of the overall plan regarding reed beds and sustainability and we also have to work with nature.

Cllr. O'Toole stated it is important to be conscious when planting at duck pond, DB explained we are working within Environmental restrictions and engaging with an arborist.

Cllr. Murphy requested to view the plans for Seaview. DB said the plan is being prepared for the tender process and once this is complete an update will be provided to Members.

Cllr. Bourke asked if the road from Ballinaclash to Aughrim could be looked at as there are a lot of sharp stones and tyres are getting cut. DB said he will investigate this.

Cllr. Leonard made time to thank Damien, Avril and all AMD staff on works carried out on footpaths at Curran's Corner. She also enquired who owns the site.

Cllr. Leonard requested a dog bin be installed on South Quay. She stated there is raw sewage in the harbour due to the WWTP not fully connected. DB said the foul network is under the remit of Uisce Eireann and it is up to them to remedy any issues or install new connections.

LE explained that Uisce Eireann is aware of the issues. The concerns of the Elected Members should be brought up at the LRSD. LE feels this is the quickest route to get results as Wicklow Co. Col have no remit in this area.

Cllr. O'Toole said the pipe on the Emoclew road is constantly leaking and UE are extremely slow in responding to any queries. Once again Leonora stated that the LRSD is the quickest route to state complaints.

Cllr. Leonard enquired about the flood relief and Harbour road stating water is ponding when valves are closed it is a recurring issue. DB is working in conjunction with Flood Relief and UE, inspection works will be carried out but this has to be done at low tide.

Cllr. Bourke enquired when will the WWTP be de-commissioned; LE stated that this was a matter for UE.

Cllr. O'Toole praised the works carried out in the cemetery but there is regular vandalism and a dumping ground, can CCTV be installed. LE said Graveyards are under the remit of The Environment Section. Cllr. Fitzgerald thinks there may be a GDPR issue with CCTV in graveyards, LE will enquire and bring her findings to the September meeting.

Cllr. Kennedy enquired regarding safety improvement works at Merrigans Corner and also Briars overgrown on Riverwalk. DB will have a look at both issues.

DB also stated there are scheduled works to be carried out on the Road through Aughrim Village. There are currently maintenance works being carried out at the Meetings of the waters.

To consider draft guidance document on Discretionary funding allocation to individual/groups.

Cllr. O'Toole suggested increasing the €3000 and not to have to put it back into a contingency fund. LE suggested that the document re-issue with the amendments and the Members can make a decision at the September meeting and at September meeting.

AB stated that the funding needed to be awarded within the year and to try distributing funds as evenly as possible. As this funding is Discretionary groups need to know it is coming from the Elected Members.

AB stated groups apply for Festival funding and then also apply to the Discretionary funding so this document is necessary. This may be considered duplicate funding from the district.

Cllr. Leonard stated if groups get funding they should disclose this on their community funding application as we should not be double funding groups.

#### 10. Any Other Business.

Cllr. Bourke asked for an update on the location of the playground in Meadowvale. LE will look into this. Cllr. Leonard said residents do not want it up there as it is not suitable for the area. A new site is needed for the playground however the builder is obliged to comply with his planning permission.

Cllr. Leonard was enthusiastic with how well the tall ship project is progressing and requested notifying the twinning committee of the project as the project will raise awareness for Aberystwyth.

AB said the twinning committee had made a request for funding; they did not apply for funding in 2024.

Cllr. Fitzgerald proposed this and Cllr. Bourke seconded it.

LE said the Maritime Museum have been granted permission to put carriages into the Memorial garden.

Cllr. Kennedy requested a presentation on the Arklow to Shillelagh greenway. LE said Joe Lane had ensured a meeting will happen with the Elected Members.

Cllr. Kennedy asked for an update on access to North Beach. LE stated there is no court date at present.

Cllr. Kennedy enquired if Wicklow County Council had been in touch with the IDA to encourage new business into the town with the WWTP in place. LE had a meeting with the IDA and they are extremely active in pursuing new business for the town.

Cllr. Kennedy congratulated the rowers on their fantastic achievement and suggests a letter be sent to them.

Cllr. O'Toole asked for a piece of land at the running track as the athletics team need storage space. AB had reached out to the Athletic club and asked for a meeting. Insurance and lease agreement will both have to be looked into. LE said we could try to bring them in through the CCSD and discuss insurance, lease etc. as we didn't realise it was a building the original plan was a container, which had already been refused.

Cllr. Murphy stated Groups regularly have events without going through the proper channels and that event forms had to be filled out in advance. Cllr. Leonard suggested encouraging people to use safe public spaces for events. AB said road closures are time sensitive and very necessary for any event; this is a huge health and safety issue. We have used social media to educate people regarding holding events.

AB said the last set of works at the running track has been completed, the track itself needs to be rolled, which is depended on favourable weather. Signage in line with the funding allocation requirements had been ordered. A lot of work has been carried out underground in order to future proof the track for the years ahead. There has been some anti-social behaviour at the track with scramblers and scooters, signage has been ordered so hopefully this might deter this behaviour. However it was difficult to enforce.

Cllr. Leonard asked for bollards at Lamberton to be replaced, DB said the NTA had been contacted for the specifications so we can order the same again.

Cllr. Leonard said the bricks used for Kynocks yard are in the depot. They are from the base of chimney and she will send on the information, it is hoped to use these bricks as part of the Kynocks project.

Cllr. Murphy thanked all present and said to enjoy the August break.

Cllr. Leonard took the time to thank Eoin Mac Raghnaill for all the work he has done to date and welcomed Hugh O'Farrell Walsh.
