1 Notice of motion in the name of Cllr. M. Crean (proposer) and supported by Cllrs. P. Leonard, J. Behan, T. Fortune, M. Kavanagh and R. O 'Connor (18th February 2021)

'That Wicklow County Council establishes an internal working group committed to advancing community wealth building beginning with an increased priority on the inclusion of green and social clauses in procurement criteria for services and goods'.
