**Proposed : To construct 20 No. Social Housing Units and all associated works at  
Barndarrig (Townland of Ballinacor East), Co. Wicklow. The accommodation shall  
consist of the following: 4 No. 3 bed 2 storey houses, 10 No. 2 bed 2 storey houses, 3  
No. Age-Friendly 1 storey houses and Group Housing consisting of 1 No. 2 bed and 2  
No. 3 bed detached houses**

**Environmental Impact Assessment (EIA) Screening Determination**

Pursuant to the requirements of the above, Wicklow County Council is proposing to construct a housing development consisting of the construction of 20 No. Social Housing Units consisting of 4 No. two bedroom two storey housing units, 10 No. three bedroom two storey housing units and 3 No. age friendly 1 storey houses and Group housing consisting of 1 No. 2 bed and 2 NO. 3 bed detached houses.

It is intended to place the plans and particulars for the proposed development on public display in accordance with the requirements of the Part XI of the Planning and Development Act 2000 (as amended) and Part 8 of the Planning and Development Regulations, 2001 (as amended).

Having regard to EIA Directive 2011/92/EU as amended by Directive 2014/52/EU (the EIA Directive), and ( inter alia) the European Commission's *Environmental Impact Assessment of Projects, Guidance on Screening (Directive 2011/92/EU as amended by 2014/52/EU)*, screening of the developments for EIA was carried out in July 2025 by JBA Consultants, 2<sup>nd</sup> Floor, Lincoln House Lane, Arran Quay, Dublin, D07 Y75P.

The screening has been carried out to determine whether the Project is a class set out in Annex I or II of the EIA Directive (transposed into Schedule 5( ( Part 1 and 2) of the Planning and Development Regulations 2001, as amended) and, if the project is not subject to a mandatory EIA, the likelihood of having significant effects on the environment under the criteria included in Annex III of the EIA Directive (transposed into Irish Law Schedule 7 of the Planning and Development Regulations 2001 as amended) in order determine whether a sub-threshold development should be subject be subject of EIA.

The EIA Screening Report has identified that EIA is not mandatory, and the proposal has been assessed in accordance with the criteria for sub-threshold development. The EIA Screening concludes that the nature of the proposed development is not to have likely significant effects on the environment (direct or indirect) and there is no requirement for an EIA.


