## Notice under Section 179 of the Planning and Development Act 2000 (as amended) and Part 8, Article 81 of the Planning and Development Regulations 2001 (as amended)

In accordance with the requirements of Part XI, Section 179 of the Planning & Development Act 2000, as amended, and Part 8 of the Planning and Development Regulations 2001, as amended, notice is hereby given that Wicklow County Council proposes to undertake the following development:

The decommissioning of an existing temporary WWTP and installation of a new wastewater pumping station and foul sewer at Rath Luain, Dunlavin, Co. Wicklow.

In accordance with Articles 81 and 120 of the Planning & Development Regulations 2001 (as amended), Wicklow County Council has concluded from a preliminary examination that no significant effects on the environment are likely as a result of the proposed development and that an Environmental Impact Assessment is not required. Any person may, within 4 weeks from the date of this notice, apply in accordance with the provisions of the Planning and Development Regulations 2001 (as amended) to An Bord Pleanála for a screening determination as to whether the development would be likely to have significant effects on the environment.

In accordance with the provisions of Article 250 of the Planning and Development Regulations 2001, as amended, Wicklow County Council has carried out a screening of the proposed development to assess, in view of best scientific knowledge, if the development, individually or in combination with other plans or projects, would be likely to have a significant effect on a European site. Accordingly, Wicklow County Council has determined that the proposed development would not be likely to have a significant effect on a European site.
