1 Notice of motion in the name of Cllr. E. Doyle, seconded by Cllr. M. Murphy (6th September 2022)

'That this Council ensures that any future playgrounds constructed on public land be accessible by the inclusion of play items that are accessible for children with disabilities or movement impairment. That accessibility be included at design stage.

That where possible, in the case of existing playgrounds being refurbished, an accessible item be included at that stage'.
